

# **Basement Flooding Study Areas 42, 44, 62 - Downtown**

## Municipal Class Environmental Assessment Notice of Study Completion

The City of Toronto has completed a Municipal Class Environmental Assessment (EA) study that examines surface and basement flooding within Study Areas 42, 44 and 62, and identifies improvements that can be made to City infrastructure to reduce the risk of future flooding. The study area is located downtown from St. Clair Avenue West to Lake Ontario and Jane Street to the Don Valley Parkway and has experienced basement and surface flooding during severe rainstorms in the past.



The study followed the Master Planning Approach #2 of the Municipal Class Environmental Assessment and satisfies the requirements for the Schedule B projects that include two new relief sewers – Garrison and Cabbagetown to provide additional capacity to relieve the existing overburdened sewers.

The study also recommends two new outfalls for the Garrison and Cabbagetown relief sewers, which will require completion of further phases in the Class EA process and are not subject to this notice.

Additional measures that are recommended are pre-approved and the City can move forward with implementation. They include:

Sewer Inflow Reduction to Eliminate Sewer Overloading

- Catchbasin inlet controls to reduce the rate at which surface water enters the sewer system
- Watertight manhole lids on sewers to reduce leakage of rainwater into sewer pipes

More Conveyance Capacity

- New storm sewers and catchbasins on local roads
- Replacing existing sewers with larger pipes that have more capacity, including the Sunnyside relief sewer

#### Storage Facilities

 Underground tanks or in-line storage pipes to store excess storm water during extreme rainfall events
