## 15543240 Canada Inc. (Report No. 7950) o/a Pizza Pizza Sameer Ghulam Jilani, Director Applicant for an Eating or Drinking Establishment Licence (Application No. C441966)

## **DECISION:**

The Tribunal approved the joint Proposed Resolution signed on January 9, 2025, as follows:

"Eating or Drinking Establishment Licence will be issued, subject to the following conditions:

(1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence application may be cancelled;

- (2) Immediately upon being issued, the Eating or Drinking Establishment Licence will be placed on probation for a period of one (1) year. 15543240 Canada Inc. is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against 15543240 Canada Inc., and Sameer Ghulam Jilani and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to the next one (1) renewal of the licence, 15543240 Canada Inc. must provide to Municipal Licensing and Standards, at its own expense, an original up-to-date Criminal Record and Judicial Matters Check for Sameer Ghulam Jilani;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 15543240 Canada Inc., Sameer Ghulam Jilani or any other concerns with respect to the conduct of the licensee, those matters and report no. 7950 and any updating material, may be brought back before the Tribunal for a full hearing."
