Re: Sponsored travel provided by the World Association of the Major Metropolises for your Trip to São Paulo Urban Summit June 16 to 21, 2024 in São Paulo, Brazil

Thank you for providing me with a Travel Declaration Form for the above-noted trip. In my view, the travel related benefits you have disclosed are in compliance with section (f) of Article 4 (Gifts and Benefits) of the *Code of Conduct for Members of Council* as travel was sponsored by the World Association of the Major Metropolises for an event that you attended in your official capacity as the Mayor's designate and at which you were a speaker on a panel discussion.

I form this view based on my review of:

The Code of Conduct for Members of Council, Part IV, Gifts and Benefits, states that no Member shall accept a fee, advance, gift or personal benefit that is connected directly or indirectly with the performance of his or her duties of office, unless permitted by the exceptions listed. The following is listed as an exception:

(f) food, lodging, transportation and entertainment provided by provincial, regional and local governments or political subdivisions of them, by the Federal government or by a foreign government within a foreign country, or by a conference, seminar or event organizer where the Member is either speaking or attending in an official capacity;

This form will serve as a disclosure statement required by the Code.

Upon receiving the Travel Declaration from the Council Member, the Integrity Commissioner shall review the form to determine whether the gift is permissible. In the event that the Integrity Commissioner makes that preliminary determination, he or she shall call upon the Member for clarification. Should the Integrity Commissioner determine that the gift was not permitted, he or she may direct the Member to reimburse the sponsor for the value.

Hi Michal,

Confirming that Councillor Bravo has agreed to go to Sao Paolo as the Mayor's designate.

While she is there she will:

- Attend the **Urban 20 preparatory sessions on June 17 and 18** which aims to bring together cities from G20 countries to inform and influence the discussions between national leaders at the upcoming G20 in Sao Paulo emphasizing the importance of implementing local policies to meet SDGs and Paris Agreement objectives.
- Participate on a panel discussion at *ICLEI World Congress from June 18 to 21,* and additionally join the session on Megacities co-organized by ICLEI and Metropolis.
- Attend the *Metropolis Board of Directors meeting on June 19 and 20 as an observer as well as* participate on a panel for Metropolis during the "Metropolis Policy Debate". She will also participate on the margins of the meeting in policy discussions, and technical visits arranged by the City of São Paulo.
