Temporary Road Closure Burnham Road


Contract: 22ECS-LU-01FP Expected Start Date: Tuesday, February 18, 2025 Expected End Date: Friday, March 21, 2025

Timeline is subject to change.

This project is part of the Council-approved 2022 Basement Flooding Protection Program to improve the water distribution system; renew our aging infrastructure and reduce the risk of sewer collapse or blockages that cause sewer backups and flooding. This work also involves replacing the city-owned portion of substandard water services and sanitary sewer laterals.

Due to the nature of the construction work and to avoid safety concerns, **Burnham Road will be closed to all vehicular and pedestrian through traffic.** This closure will affect vehicle and pedestrian access to Burnham Road at the intersections of Lumley Avenue, and Brendan Road. This road closure is effective from 7:00 a.m. on February 18, 2025, to 7:00 p.m. on Friday, March 21, 2025. Residents living on Burnham Road will have access to the roadway and their driveway. We apologize for any inconvenience that this closure will cause, and we thank you for your continued patience as we complete the construction.

WHAT TO EXPECT DURING CONSTRUCTION

- The community will experience dust, noise, and traffic delays.
- The city will make efforts to reduce impacts.



Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.



Pedestrians: Pedestrian access to Burnham Road will be restricted at the intersections of Brendan Road, and Lumley Avenue.



Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday.



Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
