

# Don Valley Parkway Concrete Crib Wall Rehabilitation at Chester Hill Road

Contract: 24ECS-BE-18AM
Start Date: Late March 2025 End Date: October 2025
\*Timeline is subject to change.

The City of Toronto is planning to rehabilitate the existing concrete crib wall adjacent to the Don Valley Parkway at Chester Hill Road. This work will ensure that the crib wall meets today's standards and remains safe for vehicles into the future. The project is part of the Council-approved 2025 Capital Works Program.

## **WORK DETAILS**

The City's contractor will:

- Rehabilitate the crib wall east of the Don Valley Parkway and west of Chester Hill Road to ensure long term structural integrity.
- Clear and grub the work area, including the removal and pruning of trees on city property.
- Replace concrete crib wall foundations and install helical piles to prevent local wall settlement.
- Install soil nails to stabilize the slope and prevent further degradation.
- Install new concrete facing on existing concrete crib wall.
- Install new inspection guard rails on top of concrete refacing.
- Replace the steel beam guide rails between the roadway and the work zone.

### WHAT TO EXPECT DURING CONSTRUCTION

 You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.



**Work Hours**: Work will take place from 7 a.m.to 7 p.m. Monday to Friday, and 9 a.m. to 7 p.m. Saturday, excluding holidays.



## **Construction Notice**



**Traffic Management:** During construction, all lanes of the Don Valley Parkway (DVP) will remain open. Road users should be mindful of the narrow shoulders on the DVP near the working area. Road users should expect delays and increased traffic on the DVP.



**On-Site Communication:** There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing. If you need to speak with staff on the construction site, please ask for the Site Inspector. If the site inspector is unavailable, contact the person listed at the end of this notice.



**Restoration:** The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
