Comments	<p>Hellenic Home for the Aged Inc. is the owner of the Subject Property and the Adjoining Property municipally known as 2411 Lawrence Avenue East (the "Adjoining Property").</p> <p>A Site Plan Agreement between Hellenic Home for the Aged Inc. and the City of Toronto is registered on title to the Adjoining Property for the construction of the existing building, which was registered as Instrument No. AT75484 on January 9, 2003 (the "Original SPA").</p> <p>The Amended SPA was registered on both the Subject Property and Adjoining Property. The Amended SPA relates to the construction and the addition of a chapel on the Adjoining Property only. Therefore, as the Original SPA is not registered on the Subject Property, and the Amended SPA does not apply to the Subject Property, it is appropriate to release the Amended SPA from the Subject Property.</p> <p>The Amended SPA will remain registered on Adjoining Property.</p>
