Section 1. Proponent Information

Proponent Information identifies the individual or organization having ownership of the proposed works/facilities at the time of construction. Should the Proponent not be the sole owner of the land where the facilities are being installed, the written consent of all land owners shall be provided.

Acceptable identification of the Proponent includes:

- i) for an individual or sole proprietor, a copy of a birth certificate, passport, or driver's license;
- ii) for a general partnership, document containing legal names of all general partners (such as a Business Names Report for the partnership from the Ontario Ministry of Public and Business Service Delivery);
- iii) for a Limited Partnership, Declaration under the Limited Partnerships Act as obtained from the Ontario Ministry of Public and Business Service Delivery;
- iv) for an Ontario corporation, a Certificate of Status, Master Business Licence, or most recently updated Corporate Profile Report obtained from the Ontario Ministry of Public and Business Service Delivery; and,
- v) for a Canadian corporation; Articles of Incorporation, Articles of Continuance, or Articles of Amendment, under the Canada Business Corporations Act as obtained from Innovation, Science and Economic Development Canada.

For development applications, the Proponent will be the developer. The contact person named shall be a representative of the developer with the authority to act on behalf of the developer.

For Toronto Water capital works; the Proponent will be the City of Toronto. The contact person named shall be a representative of the City who has authority to sign the section "Verification by Owner" on MECP Form 1 /CS1 /SS1 /SS2 /SW1 /SW2 /SW3 pursuant to item PW28.11 adopted by City Council at its meeting held on November 30 and December 1, 2009 for Municipal Drinking Water Licensing Program and /or item IE24.8 adopted by City Council at its meeting held on October 1 and 4, 2021 and /or item IE21.1 adopted by City Council at its meeting held on May 7, 2025 for MECP Consolidate Linear Infrastructure (CLI) ECA.

Section 2. Landowner Information

Landowner Information identifies the individual or organization having ownership of the land for which the proposed works/facilities will be installed by a Proponent other than the Landowner at the time of construction. Should the project facilities be constructed on several parcels of the land, the written consent of all land owners shall be provided on separate supplementary consent forms.

Acceptable identification of the Landowner includes:

- i) for an individual or sole proprietor, a copy of a birth certificate, passport, or driver's license;
- ii) for a general partnership, document containing legal names of all general partners (such as a Business Names Report for the partnership from the Ontario Ministry of Public and Business Service Delivery);
- iii) for a Limited Partnership, Declaration under the Limited Partnerships Act as obtained from the Ontario Ministry of Public and Business Service Delivery;
- iv) for an Ontario corporation, a Certificate of Status, Master Business Licence, or most recently updated Corporate Profile Report obtained from the Ontario Ministry of Public and Business Service Delivery; and,
- v) for a Canadian corporation, a Articles of Incorporation, Articles of Continuance, or Articles of Amendment, under the Canada Business Corporations Act as obtained from Innovation, Science and Economic Development Canada.

The contact person named shall be a representative of the landowner with the authority to act on behalf of the landowner.

Section 3. Statement of Landowner

Statement of Landowner is the Landowner's affirmation that to the best of his/her knowledge, the information provided in the form is accurate and complete, and that the proponent identified in the form is authorized to obtaining acceptance for the proposed works on the land under the Landowner's ownership.
