Scarborough Bluffs West Revitalization Study

Notice of Commencement of Terms of Reference

The City of Toronto, in partnership with Toronto and Region Conservation Authority (TRCA) is initiating an Individual Environmental Assessment to explore the **renewal of and improvements to approximately 4.5 km of Lake Ontario shoreline**, from Balmy Beach at Silver Birch Avenue to Bluffer's Park. The project will engage the public, Indigenous communities and technical experts to inform a plan to enhance the landscape and provide safe access to the waterfront while protecting sensitive shoreline and natural areas.

Public consultation is an important element of the study. The public will have opportunities for input at key stages throughout the project. Consultation opportunities will be advertised on the project website, by email, in local newspapers, on social media pages, and through mail to households and businesses in the area.

Process

This study will be carried out in accordance with the requirements of the *Environmental Assessment Act*. The first step of the process is the preparation of a terms of reference. The terms of reference will set out the proponent's framework and work plan for addressing the *Environmental Assessment Act* requirements when preparing the environmental assessment, including such things as the alternatives that will be considered and the public consultation activities that will be carried out. If approved by the Minister, the terms of reference will provide the framework and requirements for the preparation of the environmental assessment.

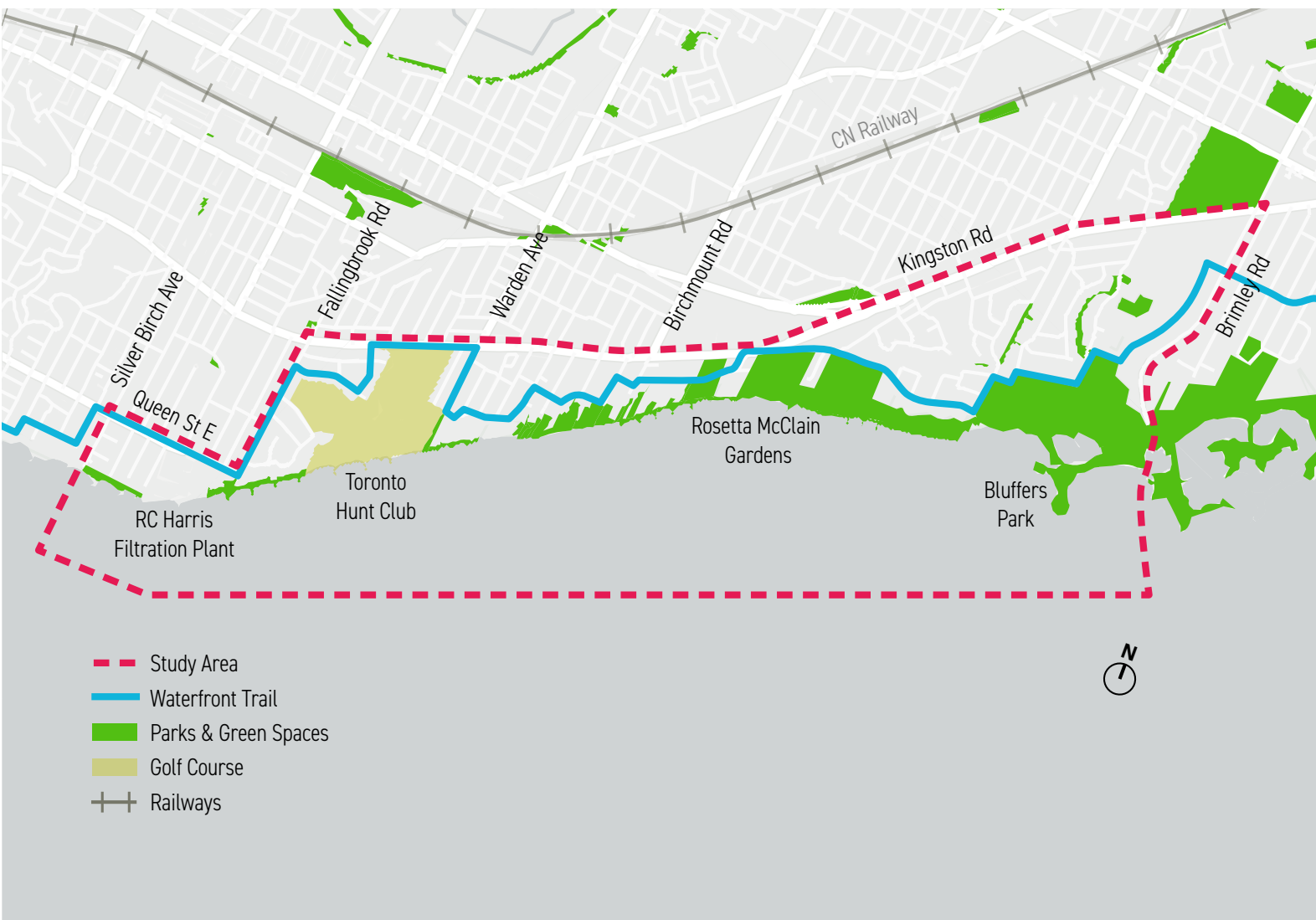


Scarborough Bluffs West Revitalization Study

About the Project

The project was launched as an Individual Environmental Assessment in November 2023 by Toronto and Region Conservation Authority, in partnership with the City of Toronto.

The project will consider opportunities to:

- Improve how people access, move through and experience the waterfront
- Provide a connected trail between Bluffer's Park and the eastern edge of the Beaches, exploring the feasibility of a connected trail system along the shoreline
- Preserve and enhance natural features and minimize hazards
- Create connected naturalized systems along the Lake Ontario shoreline which respects and protects the significant natural and cultural features of the Bluffs
- Enhance wildlife habitats on land and in the water

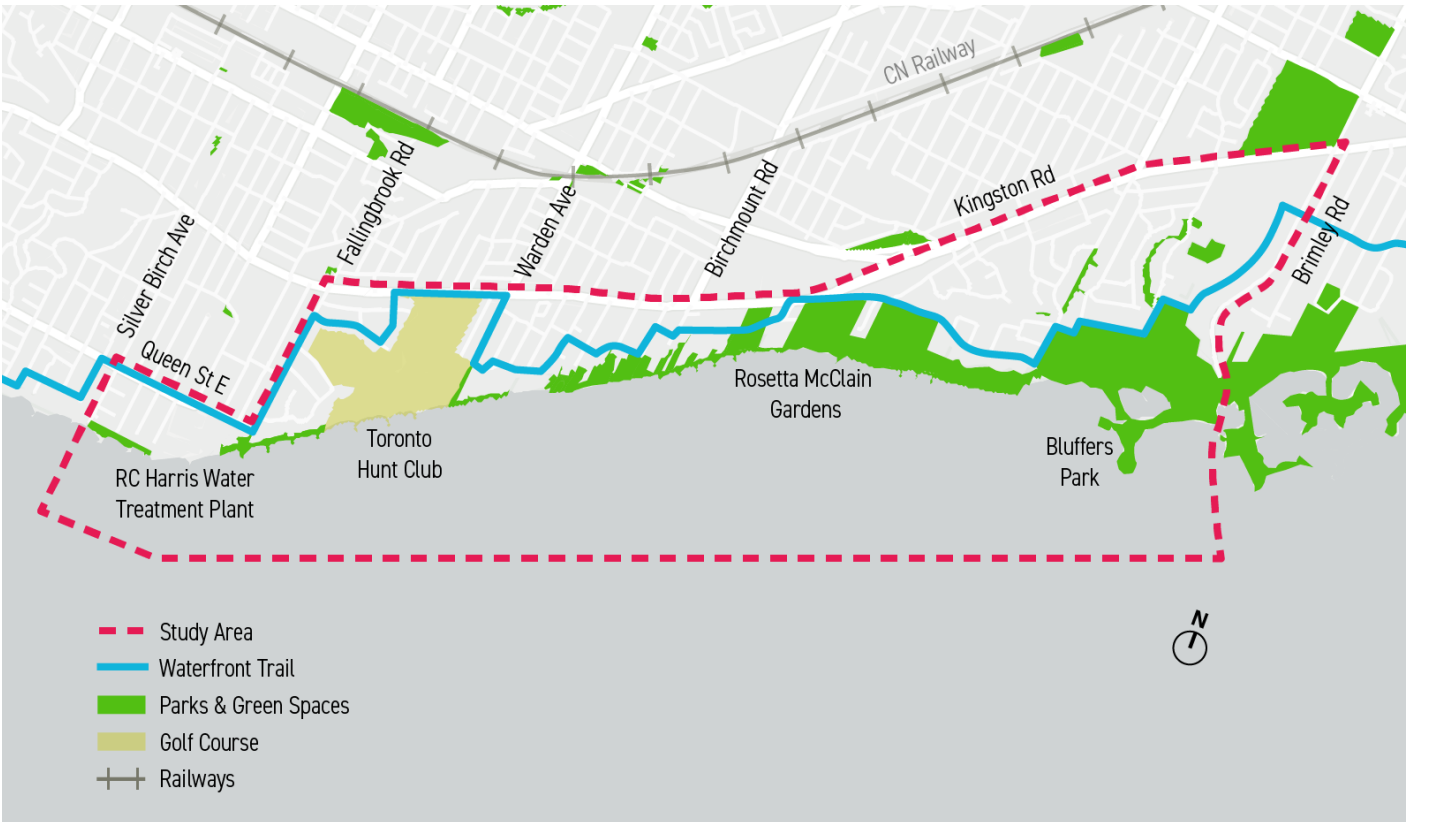

Scarborough Bluffs West Revitalization Study

The Scarborough Bluffs West Revitalization Study will explore opportunities for improved waterfront access between the Eastern Beaches (Silver Birch Avenue) and Bluffers Park along Lake Ontario, while enhancing the protection of sensitive shoreline and natural areas.

Toronto and Region Conservation Authority and the City of Toronto are seeking public input on the proposed process and criteria to develop and assess alternatives during the Environmental Assessment, which will begin next year.



Study Overview

The project will consider opportunities to:

- Improve how people access, move through, and experience the waterfront.
- Provide a connected trail system while exploring the feasibility of a shoreline trail.
- Preserve and enhance the natural environment, including the cultural significance of the Bluffs.
- Minimize natural hazards and risks to public safety caused by erosion.

Process

This Study follows the Individual Environmental Assessment (EA) process which promotes good environmental planning by determining and managing the potential effects of a project prior to implementation. There are two phases to an Individual Environmental Assessment:

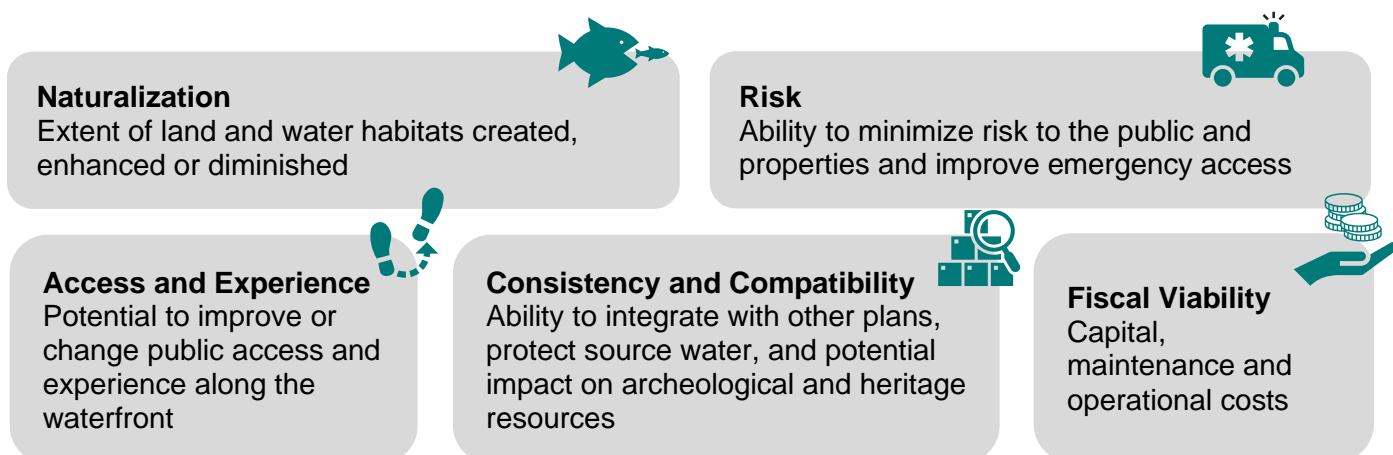
- **Phase 1: Terms of Reference**, which provides a roadmap for environmental effects to be examined, problems and opportunities to be addressed, and how the Environmental assessment will be prepared. It also outlines how consultation will be conducted during the Environmental Assessment.
- **Phase 2: Environmental Assessment**, in which alternatives are generated that address the problems and opportunities. The alternatives are then evaluated against the environmental effects identified in the Terms of Reference. Public consultation is conducted throughout the process.

Both the Terms of Reference and Environmental Assessment must be reviewed and approved by the Ministry of Environment, Conservation and Parks before the project can proceed.



Draft Criteria

Evaluation criteria will be used in the Environmental Assessment to measure the ability of each alternative to meet the project objectives. Proposed criteria include:
