DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on June 24, 2025 (by Rahul Raina) and on June 25, 2025 (by Municipal Licensing and Standards), as follows:

"The Eating or Drinking Establishment Licence No. B71-5145194 shall be cancelled and an Expanded Activity Eating or Drinking Establishment Licence (the "**New Licence**") shall be issued subject to the following conditions:

- (1) The Licensee shall ensure that all fees, documents and/or any outstanding requirements, to the extent that they have been communicated to the Licensee by MLS, must be submitted to the satisfaction of MLS within 30 days of the Tribunal hearing, failing which the New Licensee may be cancelled;
- (2) The Licensee shall adhere to the terms of the Minor Variance Decision issued by the Committee of Adjustment in file number A0032/14TEY and affirmed by the Ontario Municipal board in file number PL 140252 (attached as Schedule A to this Proposed Resolution) and all other applicable zoning requirements, except to the extent that any portion of the Minor Variance Decision or applicable zoning is amended or overturned;
- (3) The Licensee shall comply with Chapter 743 of the City of Toronto's Municipal Code and shall not encumber the City of Toronto public right of way by any means and shall take reasonable steps to prevent and/or address any loitering or encumbrance of the public right of way by clients or patrons, including complying with the Patron Management Measures submitted in Application No C505666;

- (4) The New Licence shall be suspended for 31 consecutive days. The suspension shall start at 12:00 a.m. on Tuesday July 1, 2025, and shall end at 12:00 a.m. on Friday August 1, 2025;
- (5) Immediately upon being issued, the New Licence shall be placed on probation for a period of 4 years. During the probationary period:
 - a. MLS may make additional checks of criminal and by-law charges and convictions against the Licensee and its Director(s), and conduct other investigations, as appropriate, to assess the Licensee's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
 - b. The Licensee shall notify MLS in writing within 5 business days of any new caution, charge, or notice of violation or any other form of warning or sanction the Licensee receives from the Alcohol and Gaming Commission of Ontario (AGCO), Toronto Fire Services, or other regulatory body after the date of this Proposed Resolution.
- (6) If MLS has any concerns with any new charges or convictions against the Licensee or its Director(s) or any other concerns with respect to the conduct of the Licensee, those matters and any prior reports and any updating material, may be brought back before the Tribunal for a full hearing. However, MLS shall not use any admission of guilt, conviction, sentence, monetary penalties, or other resolution with respect to charges that are currently pending as the basis to return this matter to the Tribunal, which for greater certainty the parties understand to be the following charges:"
