(3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against ISMAIL AHMED WARSAME or any other concerns with respect to the conduct of the licensee, those matters and report no. 7944 and any updating material, may be brought back before the Tribunal for a full hearing."
