TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: July 24, 2025 (1:00 PM) Summary of Decisions J. Lau

1. 14757653 Canada Inc. (Report No. 7983)

o/a Nutmento Caribbean Grill Mohit Hemant Shah, Director Applicant for an Eating or Drinking Establishment Licence (Application No. C486662)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on July 24, 2025, as follows:

"Eating or Drinking Establishment Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled:
- (2) Immediately upon being issued, the Eating or Drinking Establishment Licence will be placed on probation for a period of One (1) year. MOHIT HEMANT SHAH advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against MOHIT HEMANT SHAH and conduct other investigations, as appropriate, to assess MOHIT HEMANT SHAH's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against MOHIT HEMANT SHAH or any other concerns with respect to the conduct of the licensee, those matters and report no. 7983 and any updating material, may be brought back before the Tribunal for a full hearing."

2. Unlimited Taxi and Limo Group Ltd. (Report No. 7968)

o/a Unlimited Taxi and Limo Group Manisha J Trivedi, President Applicant for the Renewal of Taxicab Broker Licence No. B03-5353589

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"The Taxicab Broker Licence shall be renewed, subject to the following conditions:

- (1) All fees, documents, an updated List of Licensed Vehicle Owners and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being issued, the Taxicab Broker Licence will be placed on probation for a period of two (2) years. Unlimited Taxi and Limo Group Ltd. and Manisha J Trivedi are advised that during the probationary period, Municipal Licensing and Standards may make additional checks of any criminal, and by-law charges and convictions against Unlimited Taxi and Limo Group Ltd. and Manisha J Trivedi and conduct other investigations, as appropriate, to assess Unlimited Taxi and Limo Group Ltd.'s compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Unlimited Taxi and Limo Group Ltd. or Manisha J Trivedi or any other concerns with respect to the conduct of the licensee, those matters and report no. 7968 and any updating material, may be brought back before the Tribunal for a full hearing;
- (4) While licensed as a Taxicab Broker, Unlimited Taxi and Limo Group Ltd. must submit to Municipal Licensing and Standards an updated List of Licensed Vehicle Owners. The List of Licensed Vehicle Owners must be submitted to Municipal Licensing and Standards at the time of renewal;
- (5) Unlimited Taxi and Limo Group Ltd. must advise Municipal Licensing and Standards in writing of any change to the List of Licensed Vehicle Owners, including whenever any taxi owners are added or removed, within 48 hours pursuant to section 27(a) of Chapter 546 of the Toronto Municipal Code."
