Warden Ave Culvert Replacement over West Highland Creek

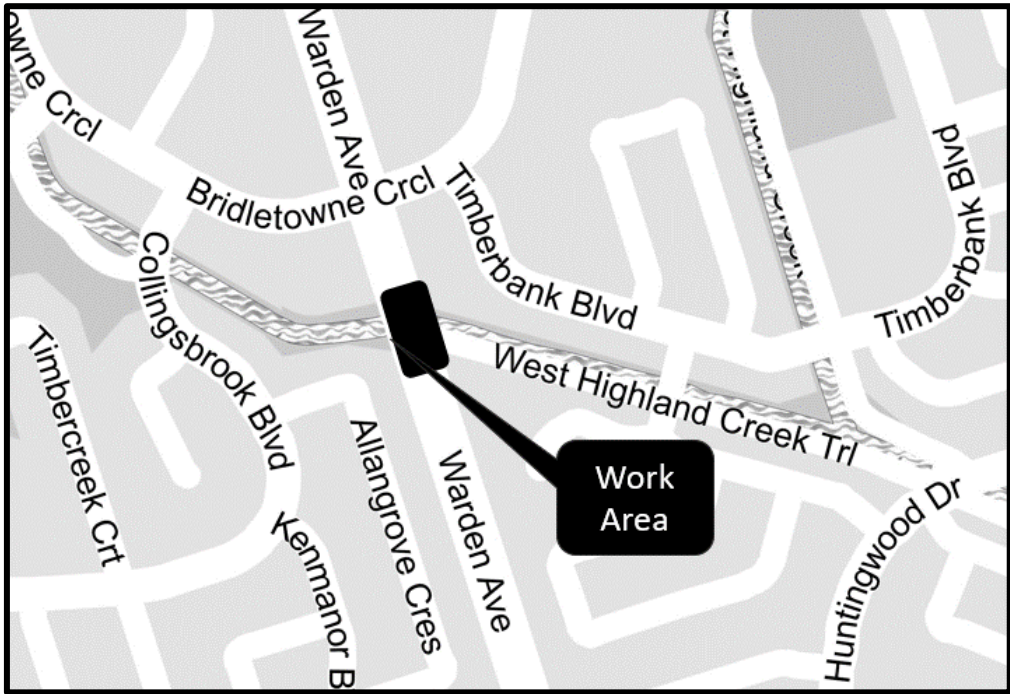

The City of Toronto is planning for the replacement of the Warden Ave Culvert over West Highland Creek. This work will ensure that the culvert meets today’s standards and remains safe for vehicles and pedestrians into the future.

To safely complete this work, northbound and southbound traffic within the project area will be reduced to one lane in each direction.

The project is part of the Council-approved 2025 Capital Works Program.

- WORK DETAILS:**
- Earth excavation and backfill.
 - Remove and replace the existing elliptical culvert with a new culvert and waterproofing.
 - Reconstruct culvert inlet and outlet.
 - Reconstruct retaining walls.
 - Reconstruct steel beam guide rails.
 - Reconstruct the sidewalk, boulevard, and asphalt pavement within the proposed work area.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.

	Work Hours: Work will take place from 7:00 a.m. to 7:00 p.m., Monday through Friday, and 9:00 a.m. to 7:00 p.m. Saturday, with work outside of these hours and on weekends as required.
	Traffic Management: Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. To safely complete this work, northbound and southbound traffic within the project area will be reduced to one lane in each direction.
	Access to Your Home: The City-hired contractor may need access to the interior and exterior of your home to complete a pre-construction condition survey. Affected properties will receive a letter about scheduling a time to complete the pre-construction condition survey. Although participation is voluntary, the pre-construction survey results may be useful to confirm claims for potential damage caused by City construction.



Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the **Field Ambassador** listed below.
