## Installation of On-Street Shared Lane Markings and Crosswalk Markings on Laughton Avenue

### ON STREET PARKING RESTRICTIONS

Contract: 25ECS-RD-04LR

Date: November 3, 2025, to November 5, 2025 (Weather permitting)

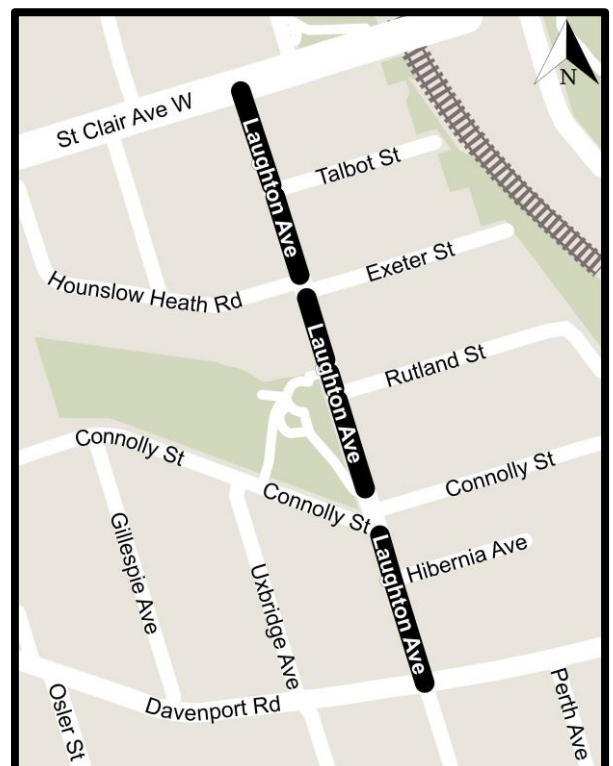
Starting on November 3<sup>rd</sup>, the City of Toronto will be adding new pavement markings on Laughton Avenue, from St. Clair Avenue West to Davenport Road. New pavement markings include shared lane markings, zebra marked crosswalks, stop bars and centrelines, and a curb extension using flexible bollards at the southeast corner of Connolly Street and Laughton Avenue. On-street shared lane markings are painted onto the road to improve road user awareness and help people cycling navigate the street. There are no impacts to motor vehicle lanes.

To complete this work, **NO ON-STREET PARKING** will be permitted on Laughton Avenue between St. Clair Avenue West and Davenport Road from **7:00 a.m. on Monday, November 3, 2025, to Tuesday November 4, at 7:00 a.m.** Please note that this schedule is weather dependent and subject to change.

Road safety improvements will be implemented with the road resurfacing work as part of the Council approved Silverthorn Cycling Connections project. These changes are being implemented to create a safer neighbourhood street for all road users. #### What To Expect

- Starting at 7:00 am on Monday November 3, 2025, the City's contractor will begin to install new pavement markings.
- Depending on work progress during the day installation work may extend into overnight hours.
- City services such as Fire, Emergency Medical Services and garbage pick-up will continue as usual.
- There may be short periods of noise during installation from leaf blowing equipment to clear the roads of debris before painting and during pavement marking removal.



## On Street Parking Restrictions

- **Please do not park on Laughton Avenue between St. Clair Avenue West to Davenport Road after 7:00 AM on Monday November 3, 2025 in order to provide a clear working area for our contractor. The alternate date for this work is Tuesday November 4, 2025 if there is inclement weather on Monday.**
- Laughton residents who receive this notice will also receive a temporary parking permit that will allow them to park on adjacent side streets during installation.
- Parking in the active work zone is not permitted due to space requirements for construction equipment and materials.
- If your parked vehicle affects installation, it will be relocated with no charge to the owner. If your vehicle is moved, please contact parking control for its location at 416-808-2222.

## PARKING VIOLATION NOTICES

**Parking Violation Notice:** Please ensure you park in a legal parking spot at all times. If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:

1. Pay the parking violation (follow instructions on the back of the notice) **or**
2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.

If you do not have a copy of the Construction Notice, please contact 311 to request a copy.

**Please note:** Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (e.g. in front of a fire hydrant or in No Parking zones).

In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.
