## **Basement Flooding Protection Program Fairbank-Silverthorn Storm Sewer System - Phase 2 Construction on Failsworth Avenue and Aileen Avenue**

**Contract #: 23ECS-MI-02FS**

**Start Date: November 2025**

**Expected End Date: May 2026**

*\*Timeline is subject to change.*

The City of Toronto is advancing construction of a new storm sewer system that will collect, store and move stormwater (rain and melted snow) from the Fairbank-Silverthorn area to Black Creek. This work is part of the City's Basement Flooding Protection Program to help reduce the risk of future basement flooding. Once complete, the new storm sewer system will help to reduce the impact of heavy rainfall and sewer back-ups for more than 4,600 homes in your area.

The City's contractor will be installing new storm sewers on Failsworth Avenue and Aileen Avenue from November 2025 to May 2026. Road resurfacing and restoration will take place once sewer-related works are completed.

The works will be done in the following sequence:

- Phase 1: #3 – 55 Failsworth Avenue
- Phase 2: #7 – 56 Aileen Avenue
- Phase 3: Road resurfacing and restoration works

The following traffic restrictions will apply during construction. Please refer to the map on Page 2 for further details:

- Failsworth Avenue and Aileen Avenue, including the intersection, will be limited to local traffic only during construction. One lane will be maintained for emergency access.
- Driveways may be affected for short durations between 3 – 55 Failsworth Avenue and between 7 – 56 Aileen Ave. If your driveway is affected, a separate driveway notice will be submitted at least 48 hours before works take place.
- Sidewalks on both sides will remain open for the duration of construction. Pedestrian access to properties will be maintained at all times.

### **WORK DETAILS**

For this project, the contractor will:

- Excavate the road and dig a trench
- Install new storm sewers.
- Resurface the road upon completion

|   | <p><b>Road Closure:</b> During construction, Failsworth Ave from Kenora Cres to Aileen Ave and Aileen Ave from Failsworth Ave to Blackthorn Ave will be closed and limited to local traffic only. Beginning November 2025, vehicular parking on Failsworth Ave and Aileen Ave will be prohibited during the working hours of 7a.m. to 7p.m. Vehicles left unattended will be subject to “friendly towing.” Access for emergency vehicles will be maintained at all times.</p> <p><b>Sidewalk Access:</b> Sidewalks on both sides will remain open for the duration of construction. Pedestrian access to properties will be maintained at all times.</p> <p><b>Driveway Access:</b> Your driveway may be affected during construction. Please note that you will be notified with a separate notice that specified the duration of the driveway impact if applicable.</p> <p><b>Street Parking:</b> Street parking will not be available during construction. Arrangements for alternate street parking should be considered.</p> |
