
Road Resurfacing on Oriole Parkway from Eglinton Avenue West to Chaplin Crescent

Contract: 25ECS-LU-06SU
Start Date: October 14, 2025 | End Date: December 19, 2025
*Timeline is subject to change.

The City of Toronto is planning to resurface Oriole Parkway from Eglinton Avenue West to Chaplin Crescent. Our inspection of the road shows that it needs repaving, and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair. In addition, multiple neighbourhood improvements will be made, including replacing the existing median with new landscaping, new pavement markings, and new signage.

This project is part of the Council-approved 2025 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

WORK DETAILS

The contractor will:

- · Dig up the road surface and medians
- · Adjust maintenance holes and stormwater catch basins
- Repair curbs and gutters and sidewalk
- · Add curb bump-outs
- Repair concrete road base
- Pave the road surface
- Install improved signage and pavement markings
- Restore driveways and other areas impacted by construction



Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.



Construction Notice



Pre-Construction Inspection: OZA Inspections Ltd., under contract to the City of Toronto, will survey all properties within 30 metres of the construction area before construction starts. The inspection will look at the interior and exterior of all properties to verify existing conditions. Although participation is voluntary, the City encourages all homeowners to participate. Without the survey, it will be difficult to confirm any claims of damage caused by construction.

Affected properties will receive a separate notice to set up an appointment. All inspection staff will wear photo I.D. and carry photo equipment for this work.



On-Site Communication: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing.

If you need to speak with staff about the construction site, please contact the Field Ambassador listed below or ask for the Site Inspector.



Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage. The City will not be responsible for damage to any privately owned items on City property.

This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the **Field Ambassador** listed below.

The City will not be responsible for any damage to any privately owned items on City property.





Telephone and Internet Services: This work may affect phone and internet cables for individual properties that aren't buried deep below the sidewalk. Residents who find their service has been disrupted should contact the **Field Ambassador** and notify their phone or internet service provider.



Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.

Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.



Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.

Traffic on Oriole Parkway will be reduced to one lane in each direction.



Parking: There will be no on street parking for the duration of the project. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.

Local residents with parking permits are encouraged to park on Braemar Avenue from Eglinton Avenue West to Chaplin Crescent; and on Anderson Avenue from Oriole Parkway to Colin Avenue. Permit holders must park between the poles of those streets that state it is permitted parking. The City has issued Temporary Parking Permits which will be distributed to Permit Holders in the coming days.



Construction Notice



Parking Violation Notices: Please ensure you park in a legal parking spot at all times. If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date in order to avoid additional fines or records being kept of non-payment:

- 1. Pay the parking violation (follow instructions on the back of the notice) or
- 2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.

If you do not have a copy of the Construction Notice, please contact 311 to request a copy.

Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in No Parking zones).

In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.



Garbage and Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. *Please ensure that you label your bins with your address.*



Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
