DECISION:

The Tribunal approved the joint Proposed Resolution signed on October 30, 2025, as follows:

"The Motorized Refreshment Vehicle licences shall be renewed, subject to the following conditions:

(1) All overdue by-law fines that have been incurred by Fresh N Cool Inc. in relation to the charges or convictions listed at pages 22-24 of Report No. 7976 must be paid prior to the licence being renewed within 60 days of the Tribunal hearing, failing which the licences may be cancelled;

- (2) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licences may be cancelled;
- (3) Immediately upon being renewed, the Motorized Refreshment Vehicle licences will be placed on probation for a period of **two (2) years**. Fresh N Cool Inc., Kamel Ouettar and Sadok Mohamed Harrabi are advised that during the probationary period, Municipal Licensing and Standards may make additional checks of any criminal, and by-law charges and convictions against Fresh N Cool Inc., Kamel Ouettar and Sadok Mohamed Harrabi and conduct other investigations, as appropriate, to assess Fresh N Cool Inc. compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Fresh N Cool Inc., Kamel Ouettar or Sadok Mohamed Harrabi or any other concerns with respect to the conduct of the licensee, those matters and report no. 7976 and any updating material, may be brought back before the Tribunal for a full hearing."
