# 1. Review of Net Zero Strategy Action Plan Consultation and TCAN Community Discussion

**Description:** Update from City and CAG Co-Chair.

## Discussion/Notes

- Update on the recent public consultation process for the net zero strategy, which had over 2,800 participants. Key findings include:
  - o 60% of respondents already feeling climate change impacts
  - 63% of homeowner respondents having completed or planning energy audits/ retrofits
  - o 60% of vehicle owners having no plans to replace gas-powered vehicles.
- Financial barriers and lack of incentives were cited as major challenges for both home energy improvements and electric vehicle adoption.
- This is a sample of people who are interested and who engage with us in many ways. As such, residents who are interested in climate action are likely over-represented in this sample.
- The consultation materials were sent to all Councillor's offices at launch along with sample social media posts. The materials did find their way into some Councillor newsletters, but the message was competing with other newsletter items.
- The number of responses was similar to the EV survey of the previous year which was approx. 2,500 responses.

# **Outcomes/Next Steps**

- A climate survey with a more representative sample may go out this year through a polling firm after which we can compare this data.
- Question: Why aren't Councillors more apt to take up this messaging and report the survey results (for example) in newsletters? Further conversation on sharing information, engaging CAG with council members is requested.
- The survey results and TCAN results were shared with the CAG in the invitation to the Q1 meeting and are available on the resources page of the CAG website.

# 2. CAG Working Groups

**Description:** Reports and discussion from CAG Working Groups

#### Discussion/Notes

- 5 Working Groups have been established and had at least one meeting as of this quarterly CAG meeting, including:
  - o Communications and Engagement
  - Buildings
  - o Energy Transition
  - o Resilience
  - Working With Other Levels of Government



- Future meetings will be coordinated by the CAG consultant. A meeting format for future meetings will be used by the consultant.
- The Transportation Working Group has submitted their application and, pending approval, will be meeting in April.
- The Waste and Circular Economy Working Group is yet to have an assigned staff representative and will not meet again until one is assigned and the group is approved.

# **Outcomes/Next Steps**

- Continue to get clarity on the Waste working group.
- Co-chairs/lead for each group are recommended.
- Consultant to coordinate next meeting
- Future CAG meetings will have dedicated agenda item reserved for Working Group Reports.

# 3. CAG Terms of Reference Review and CAG Annual Report

**Description:** After a brief update on CAG related business, a discussion was held on the role of the CAG as Community Champions as outlined in the CAG mandate in the Terms of Reference.

## Discussion/Notes

- The CAG annual report 2024 was completed by Groundswell and reviewed and approved by staff, pending any final revisions or noted omissions from CAG members. The report will be circulated for review after the meeting.
- There are currently no plans to make changes to the CAG's structure, reporting lines, or Terms of Reference. Requests for changes can be submitted for discussion at future meetings.
- 2026 is the end of the first 3-year term of the CAG. Members have joined at different times in that term. You will be invited to a next term. Members are encouraged to consider their ongoing membership prior to the June 2025 CAG meeting. Recruitment for new members will begin in September. The City will communicate with all current members on this topic before the next meeting.

## **Outcomes/Next Steps**

- 2024 CAG report is ready to distribute. Any notice of errors or omissions can be submitted to staff by April 30.
- Terms of Reference are included in the resources page on the CAG website.
- A brief summary of the discussion on Community Champions was added to the Resources page of the CAG website and will be distributed with summary notes.
- The discussion identified that informing and engaging councilors is very important to sharing the work of the city to residents and inspiring them. Finding ways to keep councilors updated and involved under our current mandate is important for the CAG to be community champions.
