## 1. Vinod Randy Kangal (Report No. 8019)

Applicant for Renewal of Motorized Refreshment Vehicle Licence No. V15-5022490; Plate 01606

Vinod Randy Kangal o/a Randy's Roti & Double's Applicant for an Eating or Drinking Establishment Licence (Application No. C590994)

## 2. Canadian Gold & Diamond Company Ltd. (Report No. 8030)

Mushtaba Qaryzada, Director Applicant for a Second Hand Shop Licence (Application No. C577821)

### **DECISION:**

The Tribunal approved the joint Proposed Resolution signed on November 27, 2025, as follows:

"The Second Hand Shop Licence shall be issued subject to the following conditions:

(1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;

- (2) The licence will be placed on probation for a period of three (3) years or until the criminal charges laid in 2021 against Mr. Qaryzada are resolved, whichever is longer. The corporation and Mr. Qaryzada are advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the corporation and its directors and officers, and conduct other investigations as appropriate, to assess the licensee's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each renewal of the licence during the probationary period, Mushtaba Qaryzada must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) At all times during the probationary period, Mr. Qaryzada shall be in the presence of another individual, other than a customer of the business, at all times while on the business premises at Unit 22-23 at 1921 Eglinton Avenue East in Toronto;
- (5) During the probationary period, if MLS has concerns with any new charges or convictions against the corporation or any other concerns with respect to its conduct or the conduct of its directors and officers, those matters and Report No. 8030 and any updating material may be returned to the Tribunal for a hearing."
