1. Industry Snack Bar Inc. (Report No. 8005)

o/a Industry Snack Bar Michelle Pablos, Officer Anh Tuan M Tran, Officer Applicant for an Eating or Drinking Establishment Licence (Application No. C531347)

DECISION:

The Tribunal approved the request for adjournment to January 8, 2026 at 9:30 a.m., on consent.

Municipal Licensing and Standards and Anh Tuan M Tran requested an adjournment of this matter.

2. Oos Creations Inc. (Report No. 7997)

o/a Oos Barbershop Soudabeh Hamzehi, Director Applicant for the Personal Services Settings Licence (Application No. C524757)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on November 4, 2025 (by Municipal Licensing and Standards) and November 5, 2025 (by Soudabeh Hamzehi), as follows:

"The Personal Services Settings Licence will be issued, subject to the following conditions:

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;

- (2) The licence shall be placed on probation for a period of three (3) years. Oos Creations Inc. is advised that during the probationary period, MLS may make additional checks of any driving, criminal and by-law charges and convictions against Oos Creations Inc., Soudabeh Hamzehi, and Iman Esbati and conduct other investigations, as appropriate, to assess the licensee's and directors' compliance with the requirements of Chapter 545 of the Toronto Municipal Code and other applicable laws;
- (3) During the probationary period, Soudabeh Hamzehi or another employee of the licensee shall at all times accompany and supervise Iman Esbati while he is offering services to a client. This condition shall cease to apply if Oos Creations Inc. provides proof, to the satisfaction of the Municipal Licensing and Standards Division, that the criminal charge against Iman Esbati of "Assault with a Weapon" laid on February 16, 2024 has been withdrawn or he has been otherwise acquitted of the charge;
- (4) Prior to the next three (3) renewals of the licence, Oos Creations Inc. must provide to Municipal Licensing and Standards, at its own expense, an original up-to-date abstract of Iman Esbati's Criminal Record and Judicial Matters Check;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Oos Creations Inc., Soudabeh Hamzehi, Iman Esbati or any of the company's directors, or any other concerns with respect to the conduct of the licensee, those matters and report no. 7997 and any updating material, may be brought back before the Tribunal for a full hearing."
