Land Acknowledgement



Background Why are shelters opening?

- Toronto's shelter system is full. There is an urgent need to address the issue of homelessness
- Demand for shelter space is expected to remain high or continue to rise
- Housing is the ultimate solution to homelessness. Shelters are necessary to fill gaps while housing solutions are being developed
- Homelessness is the result of failures across multiple systems. This includes housing supports, health care, income supports, mental health, and the justice system

The Street Needs Assessment, a point-in-time count, estimated more than 15,000 people were experiencing homelessness in October 2024



Homelessness Services Capital Infrastructure Strategy (HSCIS)

- In November 2023, Toronto City Council unanimously approved the Homelessness Services Capital Infrastructure Strategy
- The HSCIS is focused on the recovery and stability of the system
- Solutions include both purchased and long-term leased sites produce substantial cost-savings
- By 2033, up to 20 new shelters with approximately 1,600 spaces will be developed
- This includes 2 Buttonwood Ave which was announced as a new shelter location in October 2025

In 2024, over 4,300 people were moved from the shelter system into permanent housing







2 Buttonwood Ave

The City is developing a new shelter at 2 Buttonwood Ave

- This site will provide shelter to women with children experiencing homelessness
 - Demographic was determined using shelter system data
- The program will open gradually
 - Starting with 24 families initially
 - Expanding to 96 families over time
- The shelter will be operated by the City of Toronto
- Estimated opening date for the site is Late 2026



> Shelter Siting Process

- City Council delegated authority to City of Toronto staff to approve and develop new shelter locations across Toronto
- CREM, TSSS, and CreateTO undertake a comprehensive real estate review to identify potential sites for new shelters
- The site search includes looking at hundreds of potential sites across Toronto through listings, brokerages, and networks
- Sites must meet the key shelter site criteria to move forward as a potential shelter location

Limited availability of sites that meet shelter site criteria




Key Shelter Site Criteria

- 1. Site Availability, Fair Market Value
- 2. Permitted for Shelter Use
- 3. Site Size
- 4. Proximity from Existing Shelters
- 5. Access to Amenities
- 6. Proximity to Public Transit



Shelter Siting Process How are shelter locations selected?

- Currently, shelters across Toronto are successfully located in residential areas, often close to libraries, schools, daycares, and community centres
 - Shelters must be located on properties zoned to allow for municipal shelter use
 - Shelters cannot be located on lands that are zoned for employment or industrial use
- 2 Buttonwood Ave was secured by the City for shelter use based on key shelter site criteria

All shelters have trained staff on-site for 24/7 operations

Shelter Operations Crisis Intervention Coordinated Services Intake and Assessment Healthcare **Public Education & Outreach Mental Health Collaboration with Partners** Employment **Education** Access to shelters is streamlined through Central Intake as a point of entry







Role of the Shelter Operator

Shelter staff work one on one (1:1) with all clients and families.
All families will be assigned to a Counsellor who is responsible for:

Case Management

Housing Search Assistance

Support with Housing Stability

Tenant Rights Education

Connecting to Financial Counselling Supports

Connections to Healthcare (Primary, Mental Health)

Referrals for Income Assistance (OW, ODSP)

Resident meetings are held so shelter residents can provide feedback on operations







2 Buttonwood Programming Focused on Stability

Programming for women includes:

- Life Skills (Cooking, Financial, and Social)
- Community Integration and Relationship Building
- Housing Search & Support Workshops
- Mental Health and Wellness Workshops
- Employment Readiness Workshops

Programming for children and youth includes:

- After School Programs: Movie Nights, Swimming, Homework Club
- Education Field Trips: ROM, Science Centre
- Recreational Programs: Indoor and Outdoor Games, Arts & Crafts
- Child Minding: Babysitting Program


