# ROAD CLOSURE Garratt Boulevard Between Wilson Avenue and Regent Road

Contract: 21ECS-LU-04FP

Expected Start Date: September 30, 2025 Expected End Date: November 30, 2025 \*Content/dates subject to change

The City of Toronto is modifying and upgrading the storm and sanitary system in your area to reduce surface and basement flooding. Due to the depth and nature of the construction on Garratt Boulevard, the construction end date for this work has been extended until November 30, 2025. The road will be **closed** between Wilson Avenue and Regent Road effective from 7:00 a.m. on Monday, September 29, 2025, to 7:00 p.m. on Sunday, November 30, 2025, for construction.


This project is part of the Council-approved 2023 Basement Flooding Protection Program to improve the water distribution system, renew our aging infrastructure and reduce the risk of sewer collapse or blockages that cause sewer backups and flooding.

#### **WORK DETAILS**

For this project, the contractor will:

- Excavate on Wilson Avenue to install the sanitary sewer, followed by restoration of the area, and allocate space on Garratt Blvd for material storage during construction.
- This work will require the temporary closure on Garratt Boulevard to all traffic.

## **Construction Impact**

#### WHAT TO EXPECT DURING CONSTRUCTION

- The community will experience dust, noise, and traffic delays.
- The City will make efforts to reduce impacts. Your patience is appreciated.



**Traffic Management**: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users, and residents.



**Pedestrians:** The work may require temporary sidewalk restrictions; however, any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.



**Work Hours:** Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.



**Accessible Accommodation:** The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
