

# **Fire Route Designation**

A fire route designation is required under City of Toronto Municipal Code Chapter 880 for any property owner seeking to designate a private road as a fire route. This designation prohibits parking along the route and ensures unobstructed access for emergency vehicles. Completed forms, with required accompanying information / attachments, may be submitted by mail to the appropriate Command Office, or by email to <a href="mailto:tresinspections@toronto.ca">tresinspections@toronto.ca</a>.

  - The location, number and proximity to the building of all fire hydrants and Fire Department connections on the site;
  - The location and design of the proposed fire route; and
  - Proof of compliance with the requirements in the Building Code as required in <u>Chapter 880, Fire Routes</u>, Section 880-3A(2).
- ✓ Proof of ownership of the private road and building
- ☑ A fee of \$623.86 (includes HST) payable to the Treasurer, City of Toronto as per Appendix B Schedule 1, Fire Services, of Chapter 441, Fees and Charges (April 1, 2025). Exemption of fee applies if there is an active building permit. Payment can be made by credit card or cheque.
- ☑ Copy of Toronto Fire Services Notice of Violation, if applicable.

## **Fire Route Designation**

The Fire Chief may obtain the assistance of any other official of the City, including the local Councillor, as the Fire Chief considers advisable. The Fire Chief may call a public meeting to seek input on the details of the proposed fire route if they so require, prior to final approval.

Once processed, the signed application will be returned to the Applicant and a site inspection may be scheduled if required.
