EXTENDED ROAD CLOSURE Garratt Boulevard Between Wilson Avenue and Regent Road

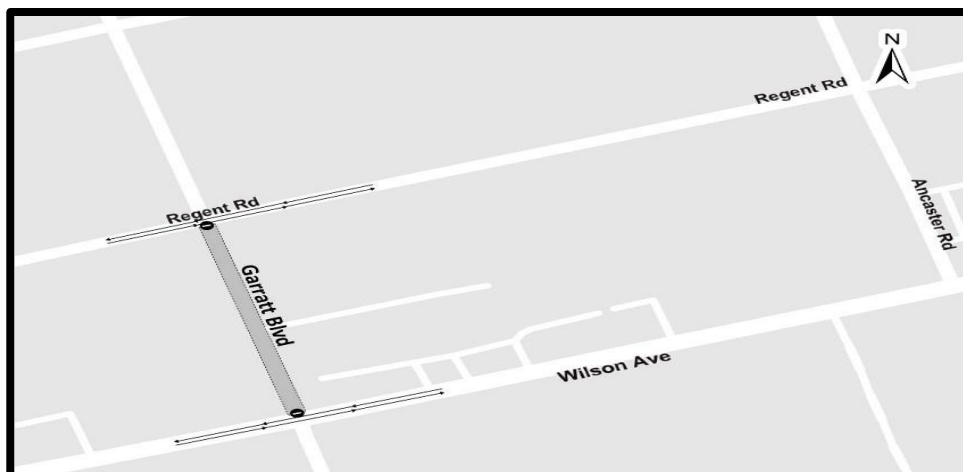
The City of Toronto is modifying and upgrading the storm and sanitary system in your area to reduce surface and basement flooding. The construction end date has been extended until January 30, 2026. The road will be closed between Wilson Avenue and Regent Road effective from 7:00 a.m. on Monday, September 29, 2025, to 7:00 p.m. on Friday, January 30, 2026.

WORK DETAILS

For this project, the contractor will:





- Excavate on Wilson Avenue to install the watermain, followed by restoration of the area, and allocate space on Garratt Blvd for material storage during construction.
- This work will require a temporary closure of Garratt Boulevard to through traffic; however, local access will be maintained.
- Four (4) City of Toronto signs will be placed on Wilson Avenue indicating **Businesses Are Open during Construction**.
- Parking areas on Wilson Avenue have multiple entrances and one entrance in each location is always accessible.

WHAT TO EXPECT DURING CONSTRUCTION

- The community will experience dust, noise, and traffic delays.
- The City will make efforts to reduce impacts. Your patience is appreciated.

	Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users, and residents.
	Pedestrians: The work may require temporary sidewalk restrictions; however, any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.
	Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.
	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
