Gardiner Expressway Rehabilitation: Section 3 Early Works on Five Bridges

This notice provides an update on the Gardiner Expressway Rehabilitation: Section 3 Early Works on Five Bridges project. Work on this project is progressing and transitioning into Stage 2, which will involve demolition activities.

STAGE 2 WORK

This stage of the work will involve demolition work on the Park Lawn Road Overpass and the Mimico Creek Overpass. This phase requires the use of demolition equipment and some work will occur overnight.

Park Lawn Road Overpass

As previously communicated, demolition activities on the Park Lawn Road overpass will be taking place overnight from 11 p.m. on Saturday, December 13 until 11 a.m. Sunday, December 14.

To safely complete this work, a full overnight closure of Park Lawn Road will be required from the Park Lawn Road on-ramp to the Gardiner Expressway westbound (north limit) to the Gardiner Expressway eastbound off-ramp to Park Lawn Road (south limit). This work is being completed overnight when traffic volumes are lower to help ensure the safety of crews and the travelling public.

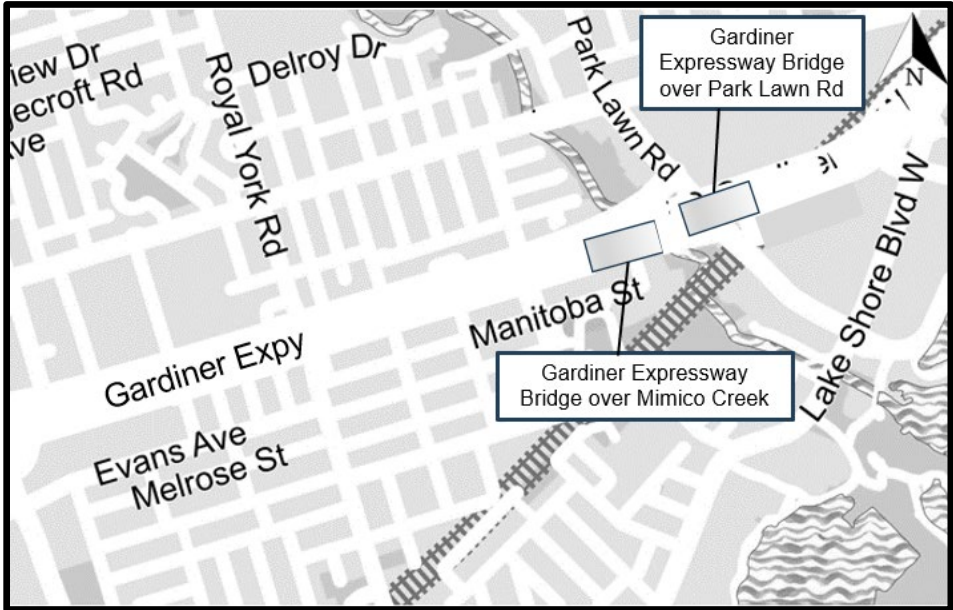
Mimico Creek Overpass Demolition

Demolition at Mimico Creek is expected to take approximately one month due to the environmentally sensitive creek area and confined work space in this area. While efforts will be made to complete the majority of demolition work during the day, overnight work will be required on some nights to safely complete activities.

STAGE 2 NOISY DEMOLITION WORK




Stage 2 work will involve the use of saw cutting, hydraulic hammers and other demolition equipment, and higher levels of noise during these activities can be expected. Construction activities, including demolition, are permitted 24 hours a day, 7 days a week and may take place throughout the day and night. 	<p>Work Hours: Work is permitted 24 hours a day, Monday to Sunday, including holidays.</p> <p>Overnight Work: Some tasks will require overnight work. Timelines for overnight work will be communicated on the project website listed below and through subscriber email updates. Visit the project web page listed below to subscribe to receive email updates. During overnight work, construction impacts and noise levels are expected to be similar to daytime construction activities. You may expect that there will be some noise from reversing trucks, saw-cutting, jackhammering, and/or loading of materials into trucks for disposal.</p>
	<p>Traffic Management:</p> <p>During Park Lawn Road Overpass Demolition:</p> <ul style="list-style-type: none">• The Park Lawn Road on-ramp towards Gardiner Expressway westbound will remain open for the duration of the work.• The Gardiner Expressway eastbound off-ramp to Park Lawn Road will only have access to southbound Park Lawn Road for the duration of the work.• Northbound traffic on Park Lawn Road from the off-ramp will be closed for the duration of the full closure noted above.• Signage will be posted. <p>During Mimico Creek Overpass Demolition:</p> <ul style="list-style-type: none">• Nightly lane closures on the Gardiner Expressway should be expected• Signage will be posted.
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>
