**4. Amanuel Berhe Mesgina (Report No. 8060)**

Holder of Toronto Taxicab Owner's Licence No. V02-5105710; Taxicab Plate No. 03055

**DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

Toronto Taxicab Owner's Licence No. V02-5105710 shall be immediately suspended on the following conditions:

- (1) Amanuel Berhe Mesgina is to register a new vehicle with Municipal Licensing and Standards that complies with the conditions of Chapter 546-51 of the Toronto Municipal Code;
- (2) Amanuel Berhe Mesgina is to return Taxicab Plate No. 03055 to the Municipal Licensing and Standards office at 850 Coxwell Avenue, Toronto, Ontario, M4C 5R1;
- (3) The temporary suspension of Toronto Taxicab Owner's Licence No. V02-5105710 will be lifted after one of the two above conditions are satisfied.
