

The City of Toronto is modifying and upgrading the storm sewer system in your area to reduce surface and basement flooding. Due to the depth and nature of the construction work, a section of Westview Boulevard will be closed, from approximately Yardley Avenue to Galbraith Avenue.

This closure will be in effect **from 7:00 a.m. on Monday, December 15, 2025, to 7:00 p.m. on Friday, January 16, 2026.**

WORK DETAILS

- The intersection at Yardley Avenue and Westview Boulevard will be fully closed except for the **winter shutdown** noted below. During the intersection closure, the contractor will assist residents who live in the work zone with access to their driveways.
- Installation of storm sewer from 188 Westview Boulevard to 220 Westview Boulevard.
- Full road closure to all through traffic on Westview Boulevard. Access to Local Traffic only.
- Westview Boulevard residents will have access to their driveways except when construction occurs in the vicinity of their home.
- Driveway Impact Notices will be delivered to homes when construction is impacting them directly.

	<p>Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users, and residents.</p> <p>Traffic detour plan: Westview Boulevard can be accessed through Tiago Avenue and Galbraith Avenue.</p> <p>Drivers travelling on O'Connor Drive and Yardley Avenue can either use Amsterdam Avenue to get onto Westview Boulevard, then use Gailbraith Avenue, or use Dohme Avenue to Westview Boulevard, then use Tiago Avenue.</p>
	<p>Pedestrians: The work will require temporary sidewalk restrictions. However, pedestrian detour access will always be available during construction.</p>
	<p>Work Hours: Work will take place from 7:00 a.m. to 7:00 p.m., from Monday, December 15, 2025, to Friday, January 16, 2026.</p> <p>Note - The crew(s) will be off site for a winter shutdown from December 24th to January 2nd. Clearway Construction is planning to temporarily restore the roadway so that this section can be opened during the shutdown.</p>

	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>
	<p>Parking Violation Notices: <u>Please ensure you always park in a legal parking spot.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:</p> <p>Pay the parking violation (follow instructions on the back of the notice) or File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.</p> <p>If you do not have a copy of the Construction Notice, please contact 311 to request a copy.</p> <p>Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e., in front of a fire hydrant or in No Parking zones).</p> <p>To reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.</p>
