over Centennial Creek

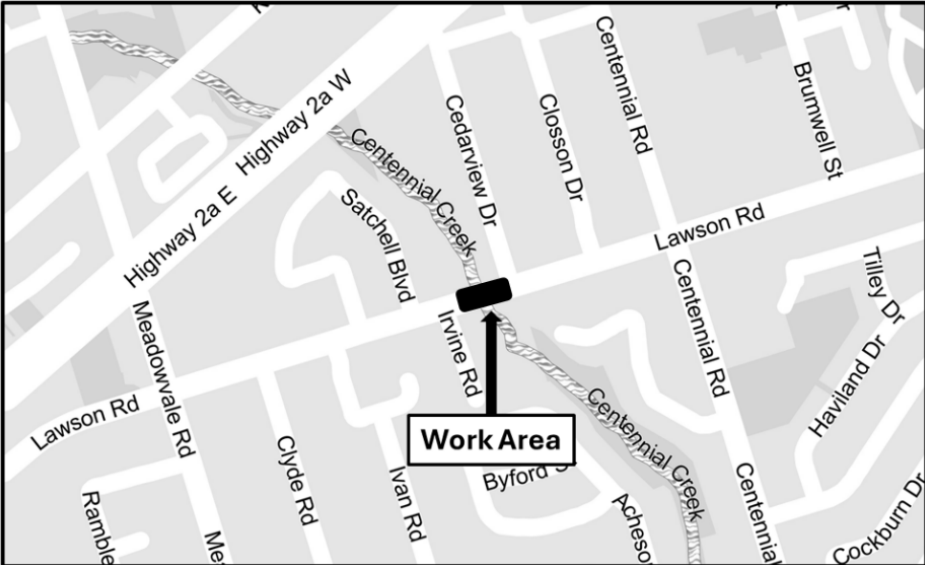

The City of Toronto will rehabilitate the Lawson Road Culvert over East Highland Creek. This work will ensure that the culvert meets today’s standards and remains safe for vehicles and pedestrians into the future. The project is part of the Council-approved 2025 Capital Works Program.




MAP OF WORK AREA & WORK DETAILS






- The City’s contractor will:
- Repair and renovate the existing Lawson Road Culvert over Centennial Creek.
 - Complete concrete repairs to the existing culvert structure
 - Remove sediment and vegetation build up through the culvert barrel and built-up debris at inlet and outlet
 - Localized repair to chain link fence
 - Extend existing soffit drain outlets

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.

	Work Hours: Work will take place from 7 a.m.to 7 p.m., Monday to Friday, with work after hours and on weekends as required.
	Pre-Construction Inspection: Alliance Verdi Civil Inc., under contract to the City of Toronto, is conducting inspections of properties in the vicinity of the construction area before construction starts. Affected properties will receive a separate notice to set up an appointment for the inspection. The inspection will look at the exterior and interior of properties to verify existing conditions. Although participation is voluntary, the City encourages all property owners to participate. Without the survey, it will be difficult to confirm any claims of damage caused by construction. All inspection staff will wear photo I.D. and carry photo equipment for this work.
	Traffic Management and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times. Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. <ul style="list-style-type: none">• Vehicular traffic on Lawson Road will be maintained with one lane in each direction. However, the road width will be narrowed.

	<ul style="list-style-type: none">• Sidewalk on the north side of Lawson Road will remain open throughout construction.• Sidewalk on the south side of Lawson Road will be closed during the entire construction.
	On-Site Communication: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing. If you need to speak with staff on the construction site, please ask for the Site Inspector.
	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Field Ambassador listed below.
	Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
