Milner Avenue Culvert Rehabilitation
over East Highland Creek

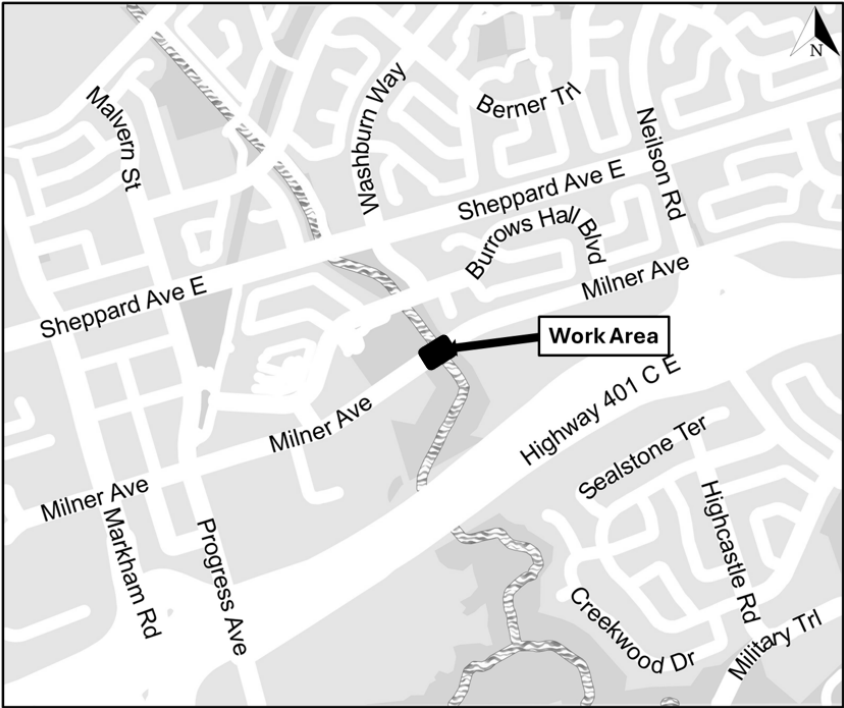

The City of Toronto will rehabilitate the Milner Avenue Culvert over East Highland Creek. This work will ensure that the culvert meets today’s standards and remains safe for vehicles and pedestrians into the future. The project is part of the Council-approved 2025 Capital Works Program.




MAP OF WORK AREA & WORK DETAILS







- The City’s contractor will:
- Reconstruct armour stone outfall at the culvert outlet including replacement of any cracked or weathered stone and all stones that do not meet size requirements
 - Grout gaps in armour stone outfall structure
 - Install new rock channel aprons in streambed upstream and downstream
 - Install new armour stone along upstream edge of inlet apron

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.

	Work Hours: Work will take place from 7 a.m.to 7 p.m., Monday to Friday, with work after hours and on weekends as required.
	Pre-Construction Inspection: Alliance Verdi Civil Inc., under contract to the City of Toronto, is conducting inspections of properties in the vicinity of the construction area before construction starts. Affected properties will receive a separate notice to set up an appointment for the inspection. The inspection will look at the exterior and interior of properties to verify existing conditions. Although participation is voluntary, the City encourages all property owners to participate. Without the survey, it will be difficult to confirm any claims of damage caused by construction. All inspection staff will wear photo I.D. and carry photo equipment for this work.
	Traffic Management And Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times. Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.

	<ul style="list-style-type: none">• Vehicular traffic on Milner Avenue will be maintained. Temporary short-duration lane closures may be required to facilitate construction equipment access and material delivery.• Sidewalks on both sides of Milner Avenue will remain open throughout construction. At times, sections of the sidewalk may need to be temporarily closed, however, construction personnel will be on site to direct pedestrians and ensure safe movement around construction equipment and materials.
	On-Site Communication: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing. If you need to speak with staff on the construction site, please ask for the Site Inspector.
	Parking: This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.
	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Field Ambassador listed below.
	Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
