- (3) The temporary suspension of Toronto Taxicab Owner's Licence No. V02-4948118 will be lifted after one of the two above conditions are satisfied.

The Tribunal proceeded with a hearing on this matter ex parte, at the request of Municipal Licensing and Standards. The Tribunal is satisfied that Girma Hailu was properly served notice of today's hearing.
