ROAD CLOSURE Summer Drive and Cleata Drive

Expected Start Date: January 7, 2026

The City of Toronto is upgrading the Storm and Sanitary sewers, as well as replacing the water main, in your area to reduce surface and basement flooding. Due to the depth and nature of the construction work, the intersection will be closed from 7 a.m. on Wednesday, January 7, 2026, to 7 p.m. on Friday, January 16, 2026, for construction purposes.

WORK DETAILS

The contractor will:

- Excavate at the intersection of Summer Drive and Cleta Drive for the storm sewer system upgrade and sanitary sewer upgrade. Work will also include the storm and sanitary tie into the existing sewer network on Summer Drive.
- Intersection at Cleta Drive and Summer Drive will be fully closed to all through traffic.
- During the road closures, residents will have access to their driveways except when construction is occurring in front of their property. Driveway Impact Notices will be distributed on an ongoing basis as necessary.
- When driveway access is not available, please park in a legal spot on a local side street and display the Driveway Impact Notice in your windshield.

	<p>Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users, and residents.</p> <p>Traffic Detour:</p> <ul style="list-style-type: none"> • Traffic on Summer Drive east of blocked intersection to travel east on Summer Drive to Hart Avenue; North on Hart Avenue to Corvette Avenue; West on Corvette Avenue to Kennedy Road. • Traffic on Summer Drive west of blocked intersection to travel west on Summer Drive to Kennedy Road. • Traffic on Cleta Drive north of blocked intersection to travel north on Cleta Drive to Corvette Avenue; West on Corvette Avenue to Kennedy Road. • Traffic on Cleta Drive south of blocked intersection to travel south on Cleta Drive to Brenda Crescent; West on Brenda Crescent to Kennedy Road.
	<p>Pedestrians: The work will require temporary sidewalk restrictions. However, pedestrian detour access will always be available during construction.</p>
	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Wednesday, January 7, 2026, to Friday, January 16, 2026.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>



Parking Violation Notices: Please ensure you always park in a legal parking spot. If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:

1. Pay the parking violation (follow instructions on the back of the notice) **or**
2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.

If you do not have a copy of the Construction Notice, please contact Field Ambassador to request a copy.

Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e., in front of a fire hydrant or in No Parking zones).

To reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.
