

This notice provides an update on resurfacing works Oriole Parkway from Eglinton Avenue West to Chaplin Crescent.

The contractor has almost completed sidewalk and concrete median removals and installations. Once this phase is finished, reconstruction of the catch basins will begin and will be completed by **December 19, 2025**.

Due to the onset of colder temperatures, the remaining restoration activities are scheduled for Spring 2026. Another update will be provided early April 2026.

WORK STATUS TO DATE

The City's contractor is currently working on:

- Completing majority of sidewalk removal and installation
- Completing majority of median island removal and installation
- Removal and installation of catch basins

Please note, that road conditions adjacent to the sidewalk and medians will remain temporary until permanent restoration is completed in Spring 2026. This includes placing temporary asphalt where the current cuts are, including at the end of impacted driveways. Should there be any issues over the winter period, please contact the Field Ambassador.

REMAINING WORK (SPRING 2026)

The City's contractor will complete:

- Road milling and reconstruction
- Top paving and line painting
- Planting and landscaping
- Small section of sidewalk and median replacement

	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.</p> <p>Traffic on Oriole Parkway will be reduced to one lane in each direction while work takes place. During the winter shutdown, all regular traffic patterns will resume to minimize disruption.</p>
	<p>Road and Sidewalk Access: To complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Pedestrians: The work may require temporary sidewalk restrictions, however any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.</p>
	<p>People Cycling: Travel will be reduced to one shared lane in each direction for people cycling and driving through the work zone.</p>
	<p>Parking: This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.</p> <p>Local residents with parking permits are encouraged to park on Braemar Avenue from Eglinton Avenue West to Chaplin Crescent, and on Anderson Avenue from Oriole Parkway to Colin Avenue. Permit holders must park between the poles of these streets that state it is permitted parking. The City has issued Temporary Parking Permits.</p>
	<p>Parking Violation Notice: <u>Please ensure you park in a legal parking spot at all times.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:</p> <ol style="list-style-type: none"> 1. Pay the parking violation (follow instructions on the back of the notice) or 2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction. <p>If you do not have a copy of the Construction Notice, please contact 311 to request a copy.</p> <p>Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (e.g. in front of a fire hydrant or in No Parking zones).</p> <p>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.</p>
