

The City of Toronto is upgrading the storm and sanitary sewer system, and Watermain in your area to reduce surface and basement flooding. Due to the depth and nature of the construction work, Westview Boulevard will be fully closed North of St Clair Avenue East and South of Gardens Crescent. A section of Joanith Drive east of Westview Boulevard is included in the closure. This road closure is in effect from 7 a.m. on Thursday, November 20, 2025, to 7 p.m. on Friday, January 23, 2026, for construction purposes.

WORK DETAILS

The contractor will:

- Excavate on Westview Boulevard north of St Clair Avenue East and South of Gardens Crescent to upgrade the storm, sanitary sewer system, and watermain. The boundaries of the Westview Boulevard work zone extend from **2 Westview Boulevard to 44 Westview Boulevard**.
- Excavate a portion of Joanith Drive east of Westview Boulevard to upgrade storm and sanitary sewer system and watermain. The boundaries of the Joanith Drive work zone extend from **Westview Boulevard to 12 Joanith Drive**.
- Westview Boulevard and Joanith Drive will be fully closed to all through traffic.
- During the road closure, residents will have access to their driveways except when construction is occurring directly in front of their property. Driveway Impact Notices will be distributed as necessary.
- When driveway access is not available, please park in a legal spot on a local side street and display the Driveway Impact Notice in your windshield.

	<p>Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users, and residents.</p> <p>Traffic Detour – Through Selwyn Avenue to access Westview Boulevard.</p>
	<p>Pedestrians: The work will require temporary sidewalk restrictions. However, pedestrian detour access will always be available during construction.</p>
	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Thursday, November 20, 2025, to Friday, January 23, 2026.</p> <p>Clearway, Construction crew will not be on site from December 24th to January 4th. Driveway access will be temporarily restored during this time.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>

	<p>Parking Violation Notices: <u>Please ensure you always park in a legal parking spot.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:</p> <ol style="list-style-type: none"> 1. Pay the parking violation (follow instructions on the back of the notice) or 2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction. <p>If you do not have a copy of the Construction Notice, please contact 311 to request a copy.</p> <p>Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e., in front of a fire hydrant or in No Parking zones).</p> <p>To reduce ticketing due to construction, please exercise patience with neighbours</p>
