

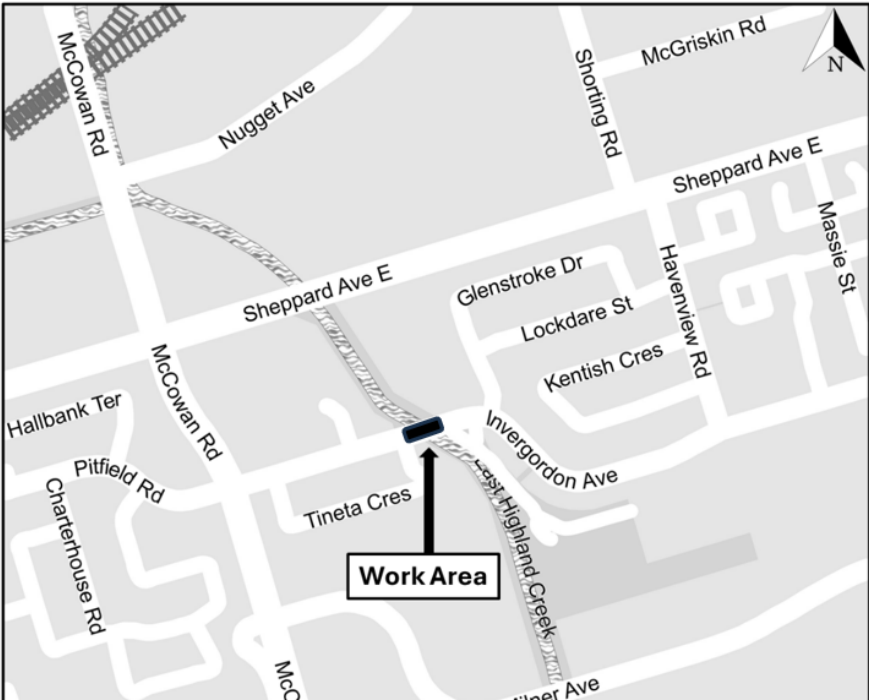

Invergordon Avenue Culvert Rehabilitation
over East Highland Creek

Contract: 25ECS-BE-09PM
Start Date: Winter 2025/2026 End Date: Summer 2026

The City of Toronto will rehabilitate the Invergordon Avenue Culvert over East Highland Creek. This work will ensure that the culvert meets today’s standards and remains safe for vehicles and pedestrians into the future. The project is part of the Council-approved 2025 Capital Works Program.





MAP OF WORK AREA & WORK DETAILS



- The City’s contractor will:
- Repair and renovate the existing Invergordon Avenue Culvert over East Highland Creek
 - Complete concrete repairs to the existing culvert structure
 - Remove asphalt above the culvert to allow for concrete repairs to the top of the culvert and installation of a new waterproofing system
 - Remove and replace steel beam guide rail
 - Remove existing parapet wall and install new cast-in-place parapet wall and railing
 - Remove sediment and vegetation build up through the culvert barrel
 - Reconstruct asphalt roadway and new sidewalk approach alignment

WHAT TO EXPECT DURING CONSTRUCTION

	<p>Work Hours: Work will take place from 7 a.m.to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Pre-Construction Inspection: Alliance Verdi Civil Inc., under contract to the City of Toronto, is conducting inspections of properties in the vicinity of the construction area before construction starts. Affected properties will receive a separate notice to set up an appointment for the inspection.</p> <p>The inspection will look at the exterior and interior of properties to verify existing conditions. Although participation is voluntary, the City encourages all property owners to participate. Without the survey, it will be difficult to confirm any claims of damage caused by construction. All inspection staff will wear photo I.D. and carry photo equipment for this work.</p>
	<p>Traffic Management and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.</p> <ul style="list-style-type: none">• Construction activities on Invergordon Avenue will be carried out in two stages. Pedestrian access will be maintained at all times via one sidewalk throughout both construction stages. During each stage, vehicular traffic on

	<p>Invergordon Avenue will be reduced to one lane of alternating traffic utilizing temporary traffic signals:</p> <p>Stage 1: The south half of Invergordon Avenue will be closed to vehicular - traffic to accommodate construction works. The north half of the roadway, including the north sidewalk, will remain open to traffic and pedestrians.</p> <p>Stage 2: The north half of Invergordon Avenue will be closed to vehicular traffic for construction. The south half of the roadway, including the south sidewalk, will remain open to traffic and pedestrians.</p> <ul style="list-style-type: none">The intersection of Invergordon Avenue and Tineta Crescent at the east end will remain closed for the entire duration of construction.
	<p>On-Site Communication: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing. If you need to speak with staff on the construction site, please ask for the Site Inspector.</p>
	<p>Parking: This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Field Ambassador listed below.</p>
	<p>Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
