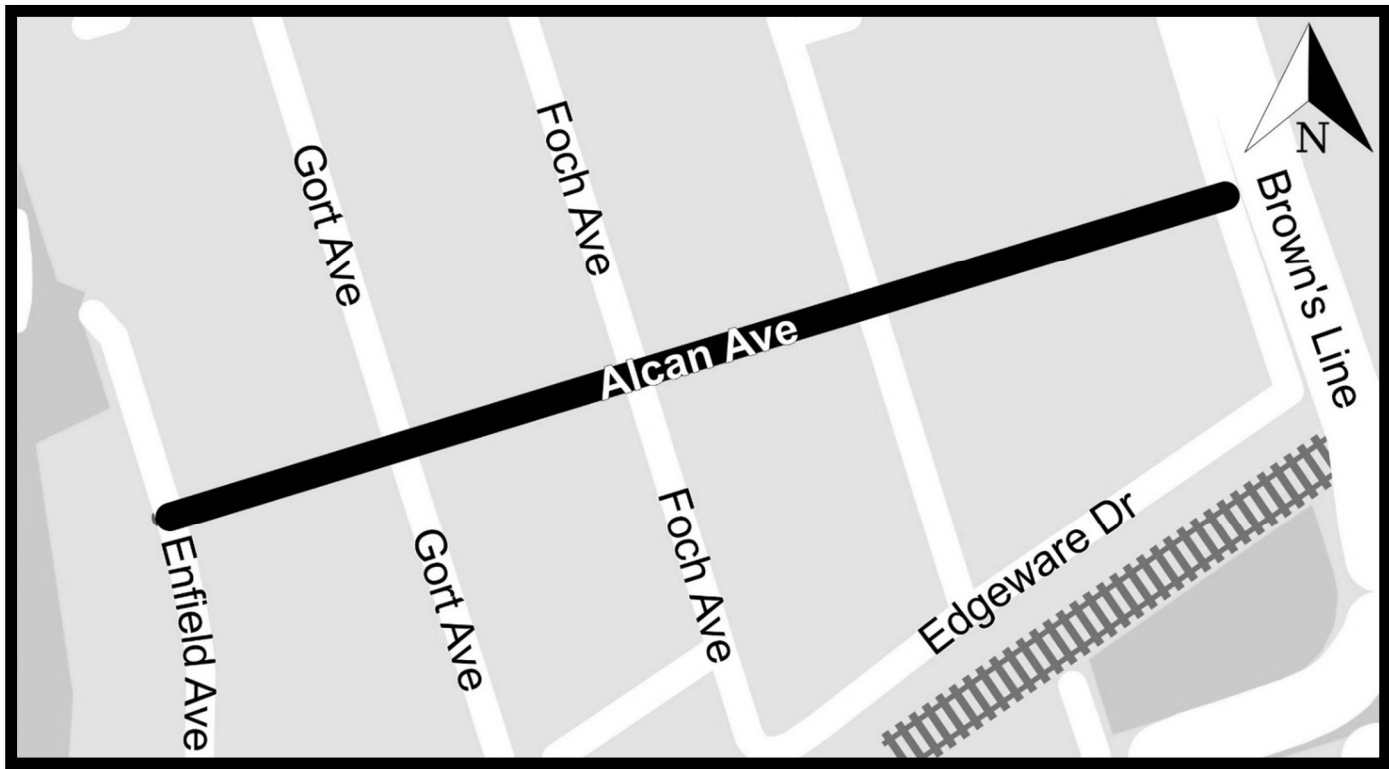
## Road Resurfacing on Alcan Avenue from Browns Line to Enfield Avenue

**Contract: 26ECS-LU-01SU**  
**Start Date: Summer 2026 End Date: Fall 2026**  
*\*Timeline is subject to change.*

The City of Toronto is planning to resurface Alcan Avenue from Brown’s Line to Enfield Avenue. The planned upgrades include repaving and the revitalization of damaged sidewalks to ensure a state of good repair. Additionally, the scope of work features an asphalt shoulder-to-grass conversion, modernizing the boulevard by replacing hard-surfacing with fresh sod. This initiative is designed to align the boulevard with current municipal right-of-way standards and optimize stormwater management by facilitating natural ground infiltration and reducing peak runoff volumes into the sewer system.


This project is part of the Council-approved 2026 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

### WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark sidewalks requiring replacement and the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- The City will not be responsible for damage to any privately owned items on City property.

	<p><b>Accessible Accommodation:</b> The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the <b>Field Ambassador</b> listed below.</p>

	<b>Access to Your Home:</b> The City-hired contractor may need access to the interior and exterior of your home to complete a pre-construction condition survey. Affected properties will receive a request to schedule a time to complete the pre-construction condition survey. Although participation is voluntary, the pre-construction survey results may be useful to confirm claims for potential damage caused by City construction.
	<b>Important information for owners of sprinkler systems / heated driveways and private landscaping features.</b> Property owners should remove items located within City property limits (boulevard) to avoid damage.  This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the <b>Field Ambassador</b> listed below.
	<b>Parking:</b> This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.
