Sanitary Sewer Upgrades – Phase 2 on Scott Street from The Esplanade to 100 m south of Front Street East

The Sanitary Sewer Upgrades – Phase 2 project on Scott Street commenced on February 2, 2026.

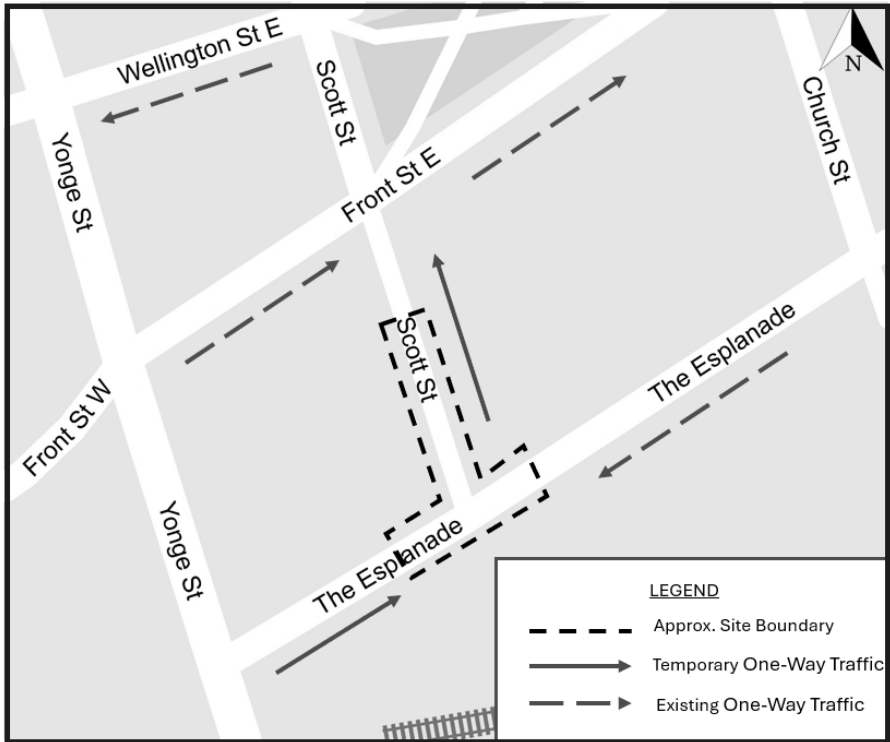
Three construction compound areas are required. The main compound is located on the west side of Scott Street (north of The Esplanade) to facilitate excavation of an access shaft to the existing buried sanitary sewer infrastructure. The additional compounds, housing bypass pumps, are located at the northeast and northwest corners of Scott Street and The Esplanade intersection.

Vehicular traffic on Scott Street is restricted to northbound only between The Esplanade and Front Street East. Two City traffic agents have been assigned to this project, and they provide guidance and direction from Monday to Friday to motorists manoeuvring through the project area.

Access to the St. Lawrence Center loading dock, Scott Lane, and the underground parking garage at 1 Scott Street will be maintained. The Esplanade between Scott Street and approximately 30m further west, the road is restricted to one lane designated for eastbound traffic only. Access to Scott Street is available from The Esplanade. Please refer to the map below demonstrating current lane restrictions.

Another update will be provided should there be any further changes to the construction schedule.

WORK DETAILS

The City’s contractor will:



- Set up construction staging areas
- Install the temporary sewer by-pass.
- Excavate the road and install a maintenance hole to connect the sewer from Phase 1 to an existing sewer.
- Reconstruct the concrete curb, sidewalk and roadway affected by construction.
- Pave the road surface
- Permanently restore all areas affected by construction.

Construction Impact Notice

	Work Hours: Work will take place from 7 a.m.to 7 p.m., Monday to Friday, with work after hours and on weekends as required.
	Site Safety: Workers on site are responsible for the work assigned to them. If you have construction questions or an issue on site – ask to be directed to the site inspector. If the site inspector is unavailable, contact the Field Ambassador listed at the end of this notice.
	Private property assets: Property owners should remove items located within City property limits to avoid damage. The City will not be responsible for damage to any privately owned items on City property.
	Telephone and Internet Services: This work may affect phone and internet cables for individual properties that aren't buried deep below the sidewalk. The contractor will coordinate with utility companies to minimize disruption. Residents who find their service has been disrupted should contact the Field Ambassador <u>and</u> notify their phone or internet service provider.
	Water Service Disruptions: From time-to-time, the water supply to your property will be shut-off to complete construction; the contractor will provide notice at least 24-hours in advance. Throughout the work, it is recommended that you temporarily disconnect any water treatment systems (i.e. softeners or filters), water-cooled air conditioners or similar plumbing fixtures. Automatic lawn sprinkler systems may also be affected, therefore, you may need to water manually. In the event you did not receive advance notice, the City may have needed to use an emergency water shut off to complete work.
	Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times. Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.
	Traffic Management: Road users should expect delays and increased traffic on nearby streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Traffic on Scott Street may be reduced to one lane to accommodate construction.
	Parking: This project will remove the on-street parking on Scott Street (northbound and southbound lane) during the construction period. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.
	Parking Violation Notices: <u>Please ensure you park in a legal parking spot at all times.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date in order to avoid additional fines or records being kept of non-payment: <ol style="list-style-type: none">1. Pay the parking violation (follow instructions on the back of the notice) or2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.

	<p>If you do not have a copy of the Construction Notice, please contact 311 to request a copy.</p> <p>Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in No Parking zones).</p> <p>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Field Ambassador listed below.</p>
	<p>Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - April to June and September to October.</p>
