## Basement Flooding Protection Program Fairbank-Silverthorn Storm Sewer System - Phase 2 Construction on Eglinton Avenue West from Gilbert Avenue to Ronald Avenue

Contract #: 23ECS-MI-02FS

Start Date: Ongoing

Expected End Date: May 15, 2026

**This notice is an update to the construction notice that was distributed in December 2025. Please visit [Toronto.ca/fairbank](https://www.toronto.ca/fairbank) to view the previous notice.**

The City of Toronto is advancing construction of a new storm sewer system that will collect, store and move stormwater (rain and melted snow) from the Fairbank-Silverthorn area to Black Creek. This work is part of the City's Basement Flooding Protection Program to help reduce the risk of future basement flooding. Once complete, the new storm sewer system will help to reduce the impact of heavy rainfall and sewer back-ups for more than 4,600 homes in your area.

The City's contractor commenced the installation of new storm sewers along Eglinton Avenue West from Gilbert Avenue in January, and will continue to Ronald Avenue until May 2026. **As work approaches the intersection of Eglinton Avenue West and Caledonia Road, the following traffic restrictions will apply during construction (Refer to Map 2 on Page 3):**

- The traffic restrictions are limited to work occurring at this intersection and are expected to be in effect from **February 9 to February 27, 2026**, weather permitting.
- Left turns will not be permitted within the work zone intersection at Eglinton Avenue West and Caledonia Road.
- Through traffic on Caledonia Road, in both the northbound and southbound directions, will not be permitted at the intersection of Eglinton Avenue West.
- Right turns onto Eglinton Avenue West from Caledonia Road are permitted. Vehicles on Eglinton Avenue West will also be able to make right turns onto Caledonia Road.
- Eglinton Avenue West will maintain two-way traffic with one lane open in each direction.

**Generally, the following traffic restrictions will apply during construction:**

- Construction on Eglinton Avenue West will be done through rolling closures in segments for the underground infrastructure upgrades. Each segment will be temporarily restored and reopened as the work progresses through the street.
- Eglinton Avenue West will maintain two-way traffic with one lane open in each direction. All intersecting roads will be open to local traffic. Periodically, left turns will not be permitted within the work zone area and detour signs will be implemented as necessary.

- Permanent road restoration, including intersecting and affected areas, will commence August 2026. During this time, minor connection work in the connecting side streets will also take place.
  - Road restoration work will be done through rolling closures during construction. Detours will be implemented as necessary.
  - During road resurfacing two-way traffic will be maintained.
- Street parking will be restricted within the active construction zones.
- Sidewalks will remain open for the duration of construction. Pedestrian access to properties will be maintained at all times.
- Driveway access may be affected for short durations during construction. A separate driveway notice will be submitted at least 48 hours before any work takes place, if applicable.

## WORK DETAILS

For this project, the contractor will:


- Excavate the road and dig a trench.
- Install new storm sewers.
- Upon completion, resurface the road and perform supplementary restoration activities.

### WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property, so please ensure that you remove/arrange for removal of each item prior to construction.

	<p><b>Work Hours:</b> Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p><b>On-Site Communication:</b> There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing. If you need to speak with staff on the construction site, please ask for the Site Inspector.</p>

	<p><b>Important information for owners of sprinkler systems/heated driveways and private landscaping features.</b> Property owners should remove items located within City property limits (boulevard) to avoid damage. This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. For details on removal of such items, please contact the <b>Field Ambassador</b> listed below.</p>
	<p><b>Road Closure:</b> During construction, two-way traffic will be maintained with one lane open for eastbound and westbound traffic. At the intersection of Eglinton Avenue West and Caledonia Road, left turns and through traffic on Caledonia Road will not be permitted.</p> <p>Vehicular parking on Eglinton Avenue West will be prohibited during the working hours of 7 a.m. to 7 p.m. Vehicles left unattended will be subject to "friendly towing." Access for emergency vehicles will be maintained at all times.</p> <p><b>Sidewalk Access:</b> Sidewalks on both sides will remain open for the duration of construction. Pedestrian access to properties will be maintained at all times.</p> <p><b>Driveway Access:</b> Your driveway may be affected during construction. Please note that you will be notified with a separate notice that specified the duration of the driveway impact if applicable.</p> <p><b>Street Parking:</b> Street parking will not be available during construction. Arrangements for alternate street parking should be considered.</p>
	<p><b>Traffic Management:</b> Road users should expect delays and increased traffic on nearby side streets. When driving, please be mindful of vulnerable road users.</p>
	<p><b>Parking Violation Notices:</b> <u>Please ensure you park in a legal parking spot at all times.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date in order to avoid additional fines or records being kept of non-payment:</p> <ol style="list-style-type: none"> <li>1. Contact the Field Ambassador listed below, and provide a photo of your ticket and ticket number, along with your contact information <b>or</b></li> <li>2. Pay the parking violation (follow instructions on the back of the notice) <b>or</b></li> <li>3. File a Parking Violation Dispute online, by mail or in person (follow instructions on the back of the violation notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction</li> </ol>

	<p>If you do not have a copy of the Construction Notice, please contact 311 to request a copy.</p> <p><b>Please note:</b> Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e., in front of a fire hydrant or in No Parking zones).</p> <p>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.</p>
	<p><b>Accessibility Accommodation:</b> The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Field Ambassador listed below.</p>
	<p><b>Garbage and Recycling:</b> Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <b><i>Please ensure that your bins are labelled with your address.</i></b></p>
	<p><b>Restoration:</b> The construction work area will be restored with sod, concrete and/or asphalt where required. Full restoration will be completed by the contractor.</p>
