
## Road Resurfacing on Chaplin Crescent from Eglinton Avenue West to Spadina Road

**Contract: 26ECS-LU-02SU**  
**Start Date: June 2026 End Date: June 2027**  
*\*Timeline is subject to change.*

The City of Toronto is planning to resurface Chaplin Crescent (from Eglinton Avenue West to North of Spadina Road). Our inspection of the road shows that it needs repaving, and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair.

This project is part of the Council-approved 2026 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

### WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark sidewalks and curbs requiring replacement and the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- The City will not be responsible for damage to any privately owned items on City property.

|  | <b>Parking:</b> This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.   |
