FIVE KEY FINDINGS



01

Cycling is both an important recreational outlet and an essential mode of travel for many Torontonians.

- **Most respondents bike.** 66% of respondents' households has someone over the age of 15 who rides a bike at least once a year.
- **Almost half bike weekly in good weather.** 48.9% of respondents report riding a bike at least one day per week in good weather.
- **A substantial share of respondents depend on non-car travel options.** 26% of respondents reported coming from households with no cars. 9.7% of those who cycle said their main reason for biking was not having access to a car.
- **Respondents cycle for both recreation and utility.** 55.7% of respondents use a bike at least occasionally for fitness or recreation, and 46.8% to get to work, school, to run errands, or visit friends.
- **Bikes are an important part of how respondents commute.** 22% of households have someone who bikes to work, and 5% of respondents reported riding bikes or e-bikes as their primary mode of commuting. An additional 39.6% of respondents say they combine cycling with public transit at least sometimes.
- **Bikes are a relevant tool for nearly a fifth of respondents' work.** 17.5% of respondents report using a bike for work in some capacity, such as for deliveries or site visits.

There is meaningful headroom to shift more trips to cycling.

- **Most respondents say they can access a bike.** Only 9.6% of respondents identified a bike not being available as a key barrier to not cycling more. 63.7% of respondents' households own at least one bicycle, pedal-assist e-bike, or cargo bike. Of those who don't, 6.6% use Toronto Bike Share, and another 73.2% are aware of the program.
- **Most respondents reported wanting to cycle more than they currently do.** 54% of all respondents agreed with the statement that they would like to travel by bike more than they currently do, and only 13% indicated they already cycle as much as they are going to.

Respondents feel that safer cycling infrastructure, especially lanes physically separated from traffic, would make a major difference in getting more people cycling.

- **Concerns about safe infrastructure hold at least 4 in 10 respondents back from cycling.** Safer infrastructure was by far the number one factor respondents identified as making cycling in Toronto more welcoming and accessible (41.9% of respondents).
- **Specifically, respondents don't want to bike in car traffic.** Insecurity in traffic was the number one reported factor for respondents deciding not to cycle or not cycle more often (31.3% of respondents).
- **Respondents identified physically separating bike lanes from traffic as the most important thing the City can do to make cycling feel safer for them.** 27% of respondents said that separated bike lanes from car traffic would be the single most important thing that can be done to improve cycling in Toronto in terms of safety.
- **Specifically, concrete separators for bike lanes are favoured.** 42% of respondents chose either poured in place concrete or concrete curbs as their number one preferred separation between vehicle and bicycle lanes.
- **Cycle track installations improved respondents' general perceptions of safety in their neighbourhood.** Of the respondents who noticed new cycle tracks installed in their neighbourhood over the past two years (n= 207), 81.1% felt the cycle tracks improved how safe they feel in the area, more than any other form of cycling infrastructure.

Most respondents support promoting cycling and see the benefits from cycling infrastructure.

- **Respondents across the board want cycling to be promoted in their city.** 64% of respondents are in favour of promoting cycling in Toronto. Support was greater than opposition for every socio-demographic group. Even among people who don't cycle, 44.7% supported, 30.2% were unsure, and only 25.1% reported opposition to promoting cycling in Toronto.
- **Where there's new cycling infrastructure installed, respondents notice, use it, and overwhelmingly perceive it positively.** Half of all respondents said they noticed new cycling-friendly infrastructure in their area over the last two years. However, higher income respondents were both more likely to have reported seeing new infrastructure in their neighbourhoods and to report positive benefits from the new infrastructure, pointing to continued opportunities to prioritize equity in network expansion planning. Of respondents who noticed these installations:
 - 89.1% said they use the new infrastructure at least sometimes.
 - 69.1% said the new infrastructure had a positive effect on at least one of the following four qualities of the area: physical appearance, perceived safety, ease of accessing services there, and ease of commuting through there.
 - 53% of the respondents who noticed these new projects reported positive effects in each of those respective categories.

Beyond the separation of bike lanes from traffic, the survey data point to several additional levers with strong potential to support cycling growth at scale.

- **Prioritizing secure and convenient bike storage at transit stations and expanding Bike Share to shorten that first and last mile:** Already, 39.6% of respondents who don't bike as their primary commuting mode report combining cycling with public transit use at least sometimes. In addition to safer and more comfortable cycling routes to transit stations (64.9%), over 63% of respondents considered convenient and secure bike parking at the station as important factors. Over half of respondents also prioritized access to Bike Share both from their homes and the station.
- **A more integrated working cycling network:** 24.2% of respondents reported that a more comprehensive and connected cycling network would get them biking more, and 23% indicated that better maintenance of existing routes would be a key enabling factor. Of new cycling infrastructure Torontonians noticed in their area, cycle tracks had the strongest perceived benefit in terms of enabling access to services in the area (76.3% indicated positive effects in this dimension).
- **Maintaining a winter-ready cycling network:** 19.5% of respondents reported that they would ride more if bikeways were better cleared or maintained during winter.

REPORTING CONVENTIONS

Cyclists

“Cyclists” refers to respondents who ride a bike for commuting and/or recreational purposes. While people often use different modes of transportation depending on weather, urgency, or infrastructure quality, this report uses “cyclist” as a shorthand for respondents who indicated that they ride a bike.

Street (cycling-supportive) Infrastructure

In one set of questions, respondents were asked whether their neighbourhood includes “cycling infrastructure or measures to reduce automobile traffic speed or traffic volume.” Throughout the report, these are collectively referred to as “new or modified street infrastructure.”

To ensure consistent interpretation, respondents were provided with the following examples:

- Bicycle lanes
- Cycle tracks
- Sharrows
- Neighbourhood greenways (may include contra-flow bike lanes and shared lane markings)
- Multi-use trails
- Speed-reduction measures (e.g., automated speed cameras, red-light cameras, reduced speed limits)
- Traffic-calming infrastructure (e.g., traffic islands, speed humps, new sidewalks, bump-outs, bollards)

Infrastructure Type Preferences

For questions asking respondents to compare or select between specific types of cycling infrastructure, images were provided. These examples followed *Toronto’s Cycling Infrastructure* definitions, available online [here](#).

RESPONDENT OVERVIEW

To ensure a sample that was representative of Toronto's vast and diverse population, the project team used the 2021 Census as a benchmark for targeting adequate respondents across various geographic and demographic groups. Across all categories, the 2025 Toronto Cycling Survey sample represents comparable population distributions to that of the City of Toronto 2021 Census, with the exception of the following limitations whereby the variation from the census is greater than 5%:

Greater representation in the sample compared to the census:

- Age groups
 - 35 to 44: +5.1%
- Education level
 - Degree from college: +8.6%
 - Graduate degree: +10.9%
- Language spoken at home
 - English: +16.4%
- Immigration status
 - Born in Canada: +17.7%
- Racial and ethnic background
 - White: +9.65%

Less represented in the sample compared to the census:

- Age groups
 - 18 to 24: -6.5%
- Education level
 - Less than high school: -13.3%
 - High school: -6.9%
- Annual household income pre-tax
 - More than \$200k: -5.2%
- Immigration status
 - Foreign born: -18.2%

PROJECT CONTEXT

In 1999, the City of Toronto launched their first ever city-wide public poll on cycling. Intended to serve as a benchmark for public perceptions of cycling, the City of Toronto conducted similar city-wide polls in 2009, 2019, and 2023. These polls captured information on the incidence of cycling in Toronto, perceptions of cycling safety, and awareness of municipal active transportation programs and initiatives. Data from the polls has helped inform Transportation policy and decision making since.

Over the last decade, the City of Toronto has greatly increased the frequency of planning and installing new cycling infrastructure. As a result, cycling is becoming a more viable mobility option for many Torontonians. As the City undergoes these changes, there is an opportunity for the City of Toronto to revisit the city-wide cycling survey with the goal of tracking mode share shifts over time, identify perceptions of active transportation, and adopting a biannual model that is more in line with other leading cycling cities like Copenhagen, Helsinki, and Amsterdam. Such a model will help the City of Toronto track the health, economic, and social benefits of their active transportation infrastructure investments.

Based in this context, and building on the lessons and examples from bike surveys conducted both globally and within Canada, the 2025 Toronto Cycling Survey was designed to:

1. Track, over time, mode share across the city and compare to the City's Transform TO mode share targets.
2. Identify barriers to greater participation in cycling and understand how these barriers evolve as new initiatives are implemented.
3. Identify perceptions of cycling safety and how these intersect with age, gender, income, geographic region, and ethnicity.

METHODOLOGY

Climate Action Partnership (CAP) and the University of Toronto (U of T) developed the 2025 survey methodology in collaboration with the City of Toronto's Cycling and Pedestrian Projects team.

The 2025 version sought to replicate as much of the 2023 survey questions and methods as possible to enable longitudinal analysis. The only substantive additions to the 2025 edition include:

- additional response options on select questions that ask about a greater range of micromobility devices
- additional questions asking respondents about their awareness, use, and perceptions of new cycling and safe street infrastructure installed in their area since the 2023 version of the survey
- an option to opt-in to being invited to participate in future longitudinal studies

CAP and U of T engaged independent polling company Research Co. to manage the data collection and advise on the survey design and overall methodology.

During the design phase, the project team set a response target of 1,500 people, balanced across the geographic regions of the city (East York, Etobicoke, North York, Old Toronto, Scarborough, and York) as well as sociodemographic characteristics such as age, gender, income, sexual orientation, and racial identity. This would ensure that mobility habits and key perceptions were captured across diverse landscapes and communities.

METHODOLOGY

Survey Administration:

The online survey comprised of 42 questions, excluding screening and demographic questions. Administering the survey online allowed the project team to seamlessly show respondents maps and other cycling related images that were required to informatively answer the questions. Additionally, the online survey allowed us to screen through self-selecting panels that set minimums on geographic diversity, age, and gender.

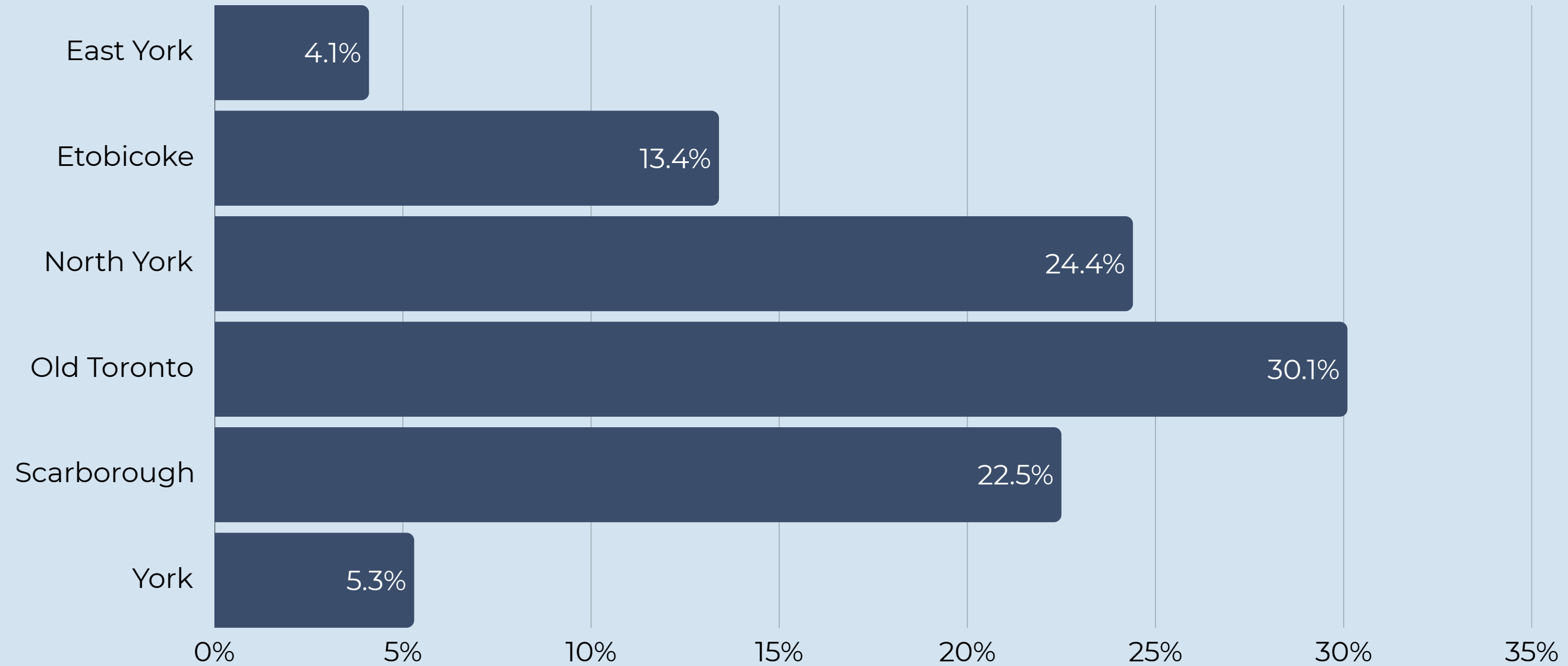
The project team collaborated with Research Co. to administer the poll, with a **final sample size of 1,660 responses**. The poll was open and collected responses between 5 November 2025 and 9 January 2026.

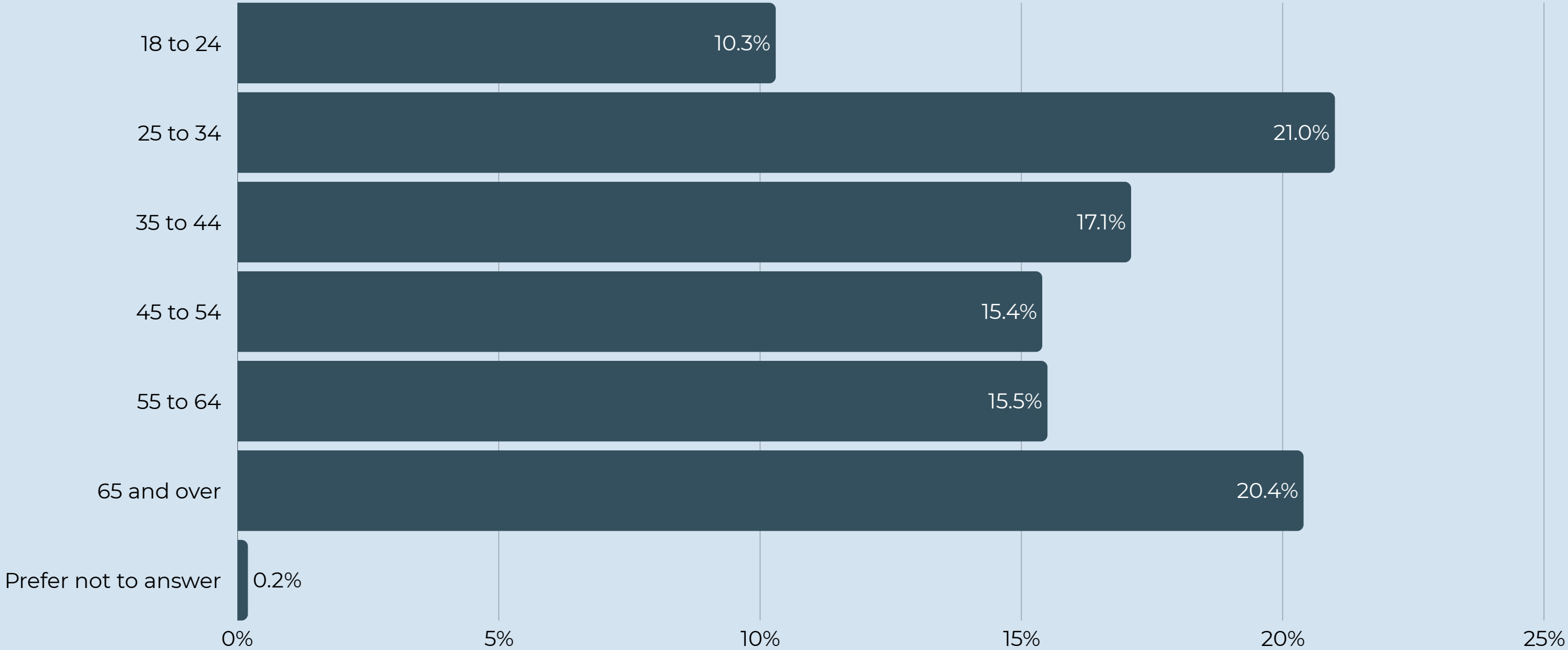

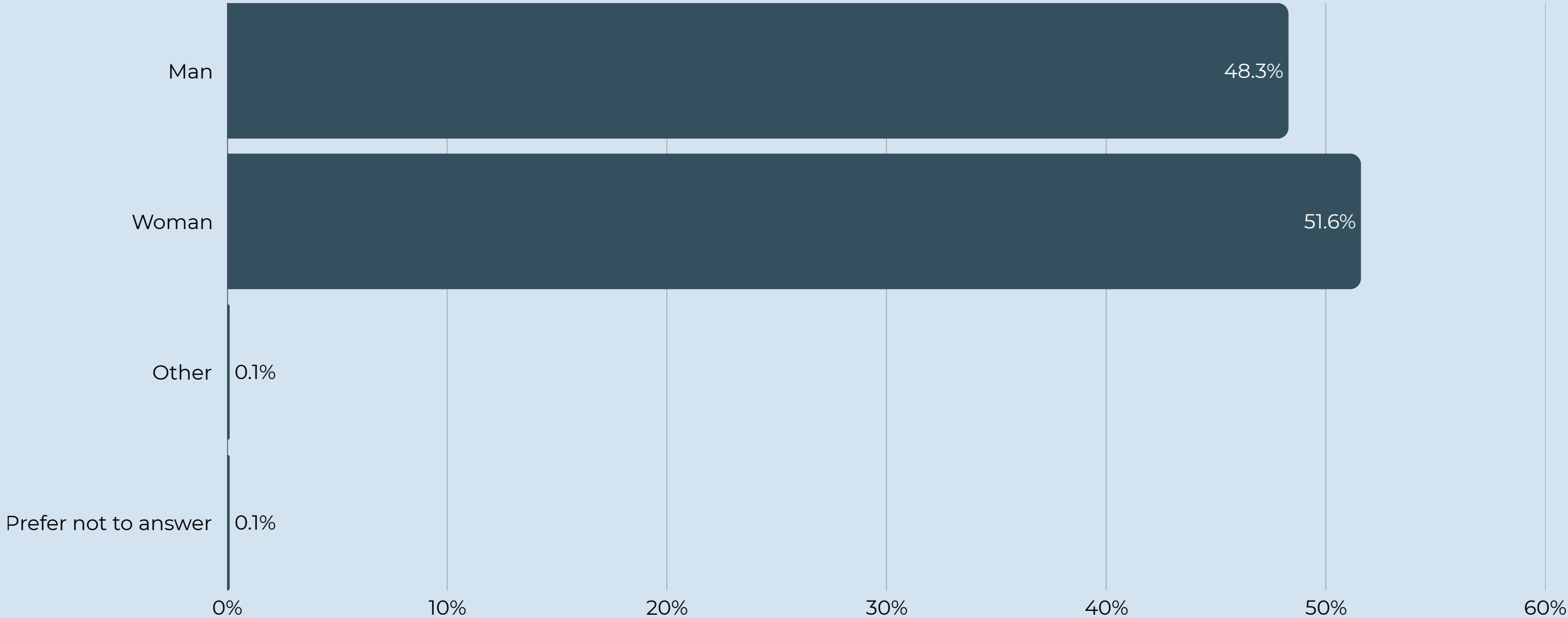

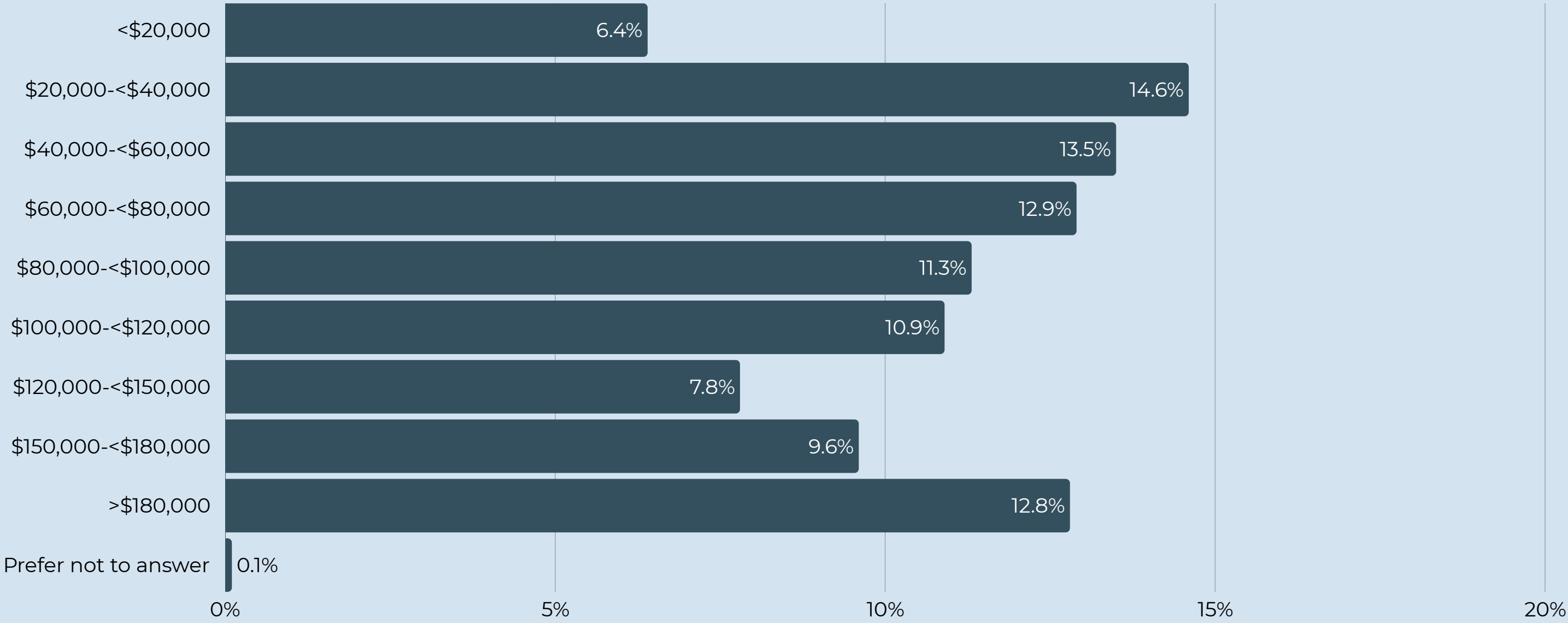

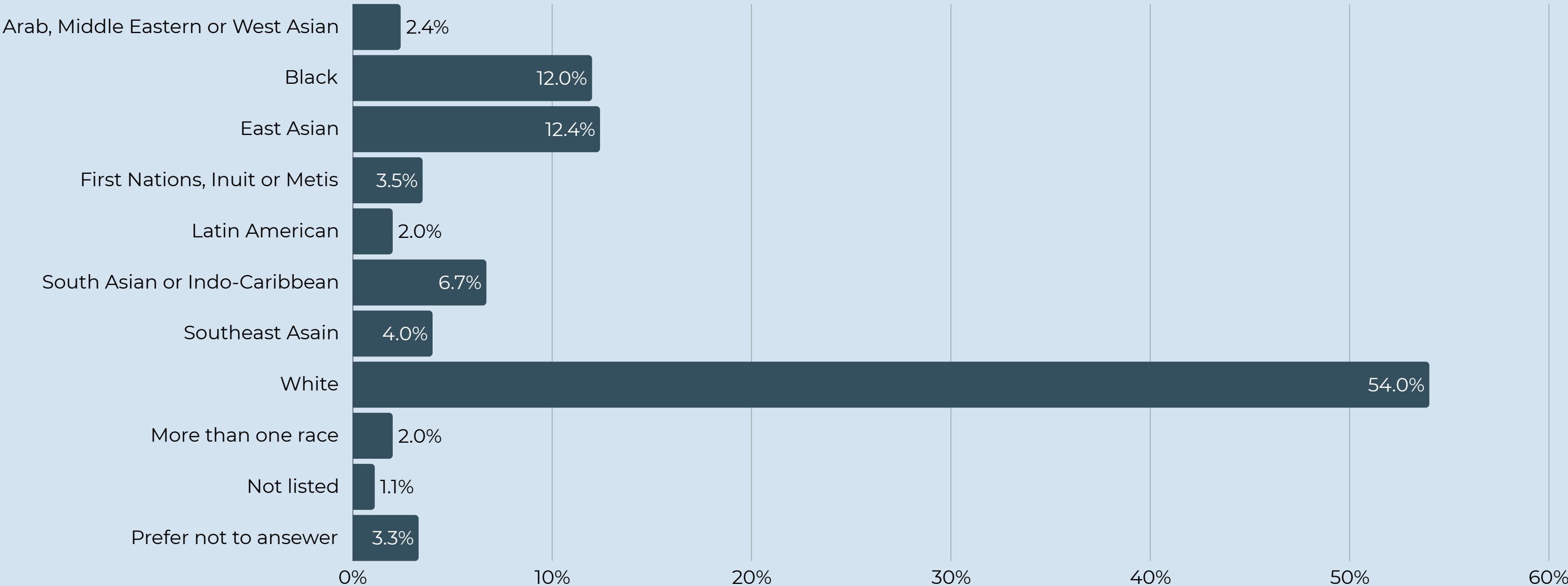

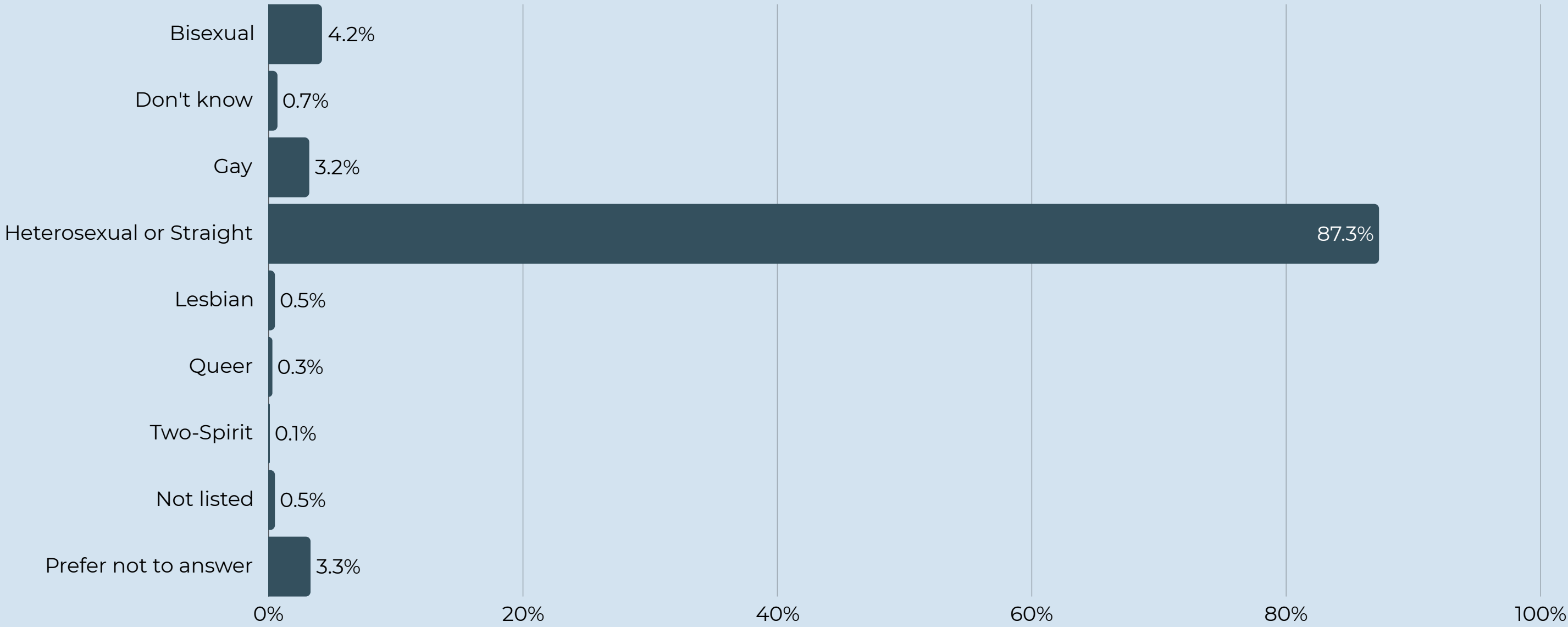

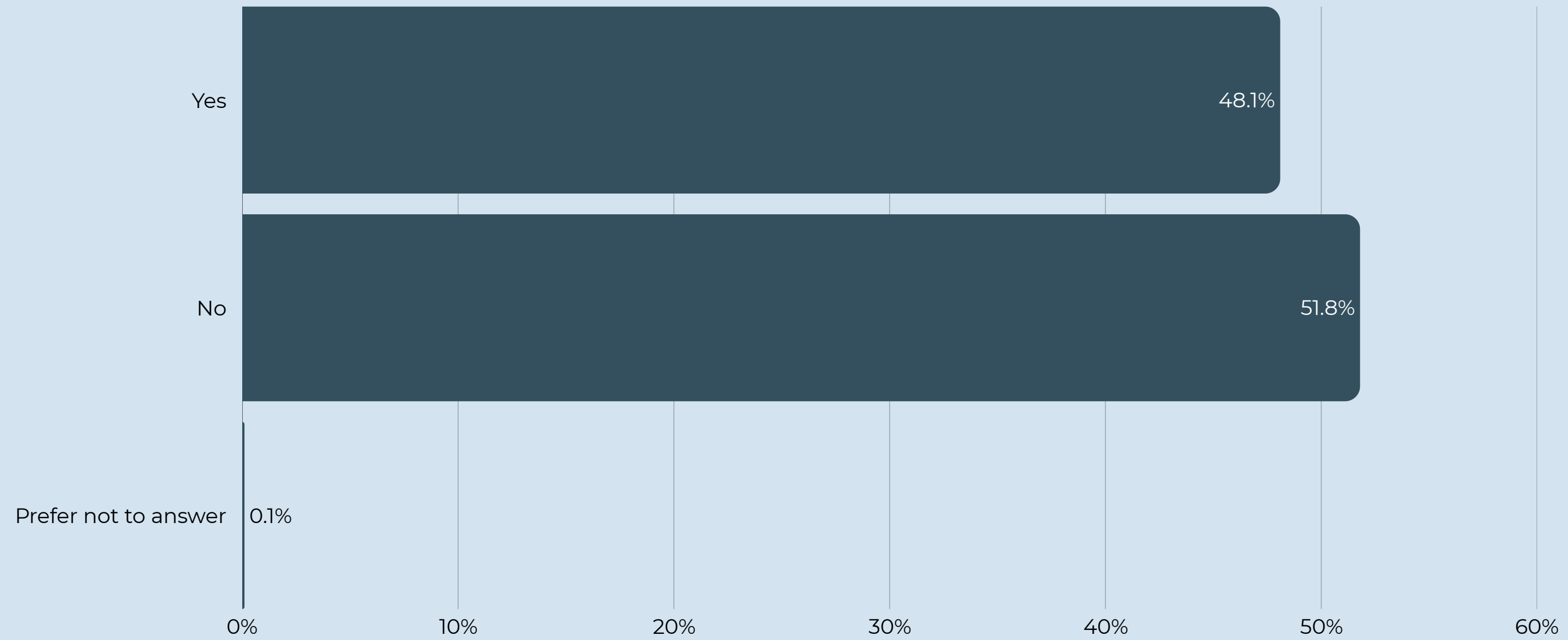

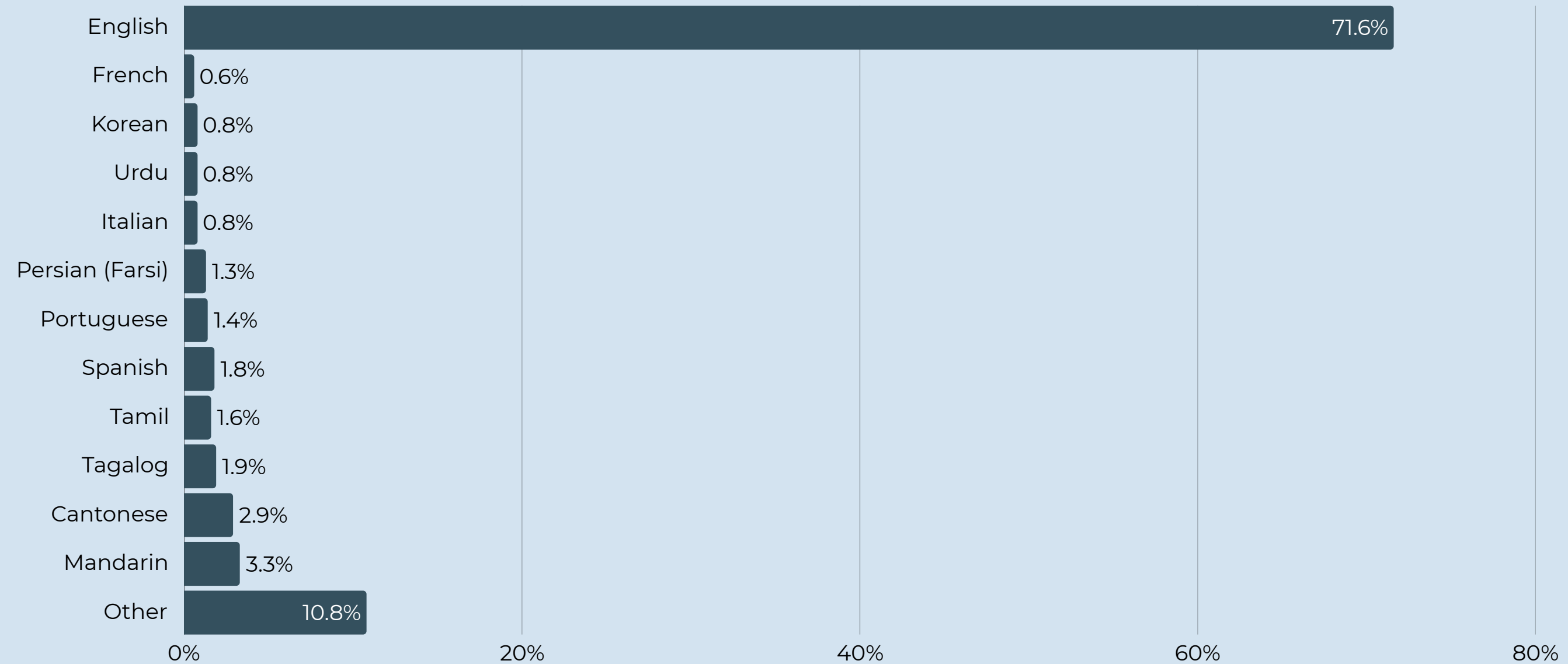

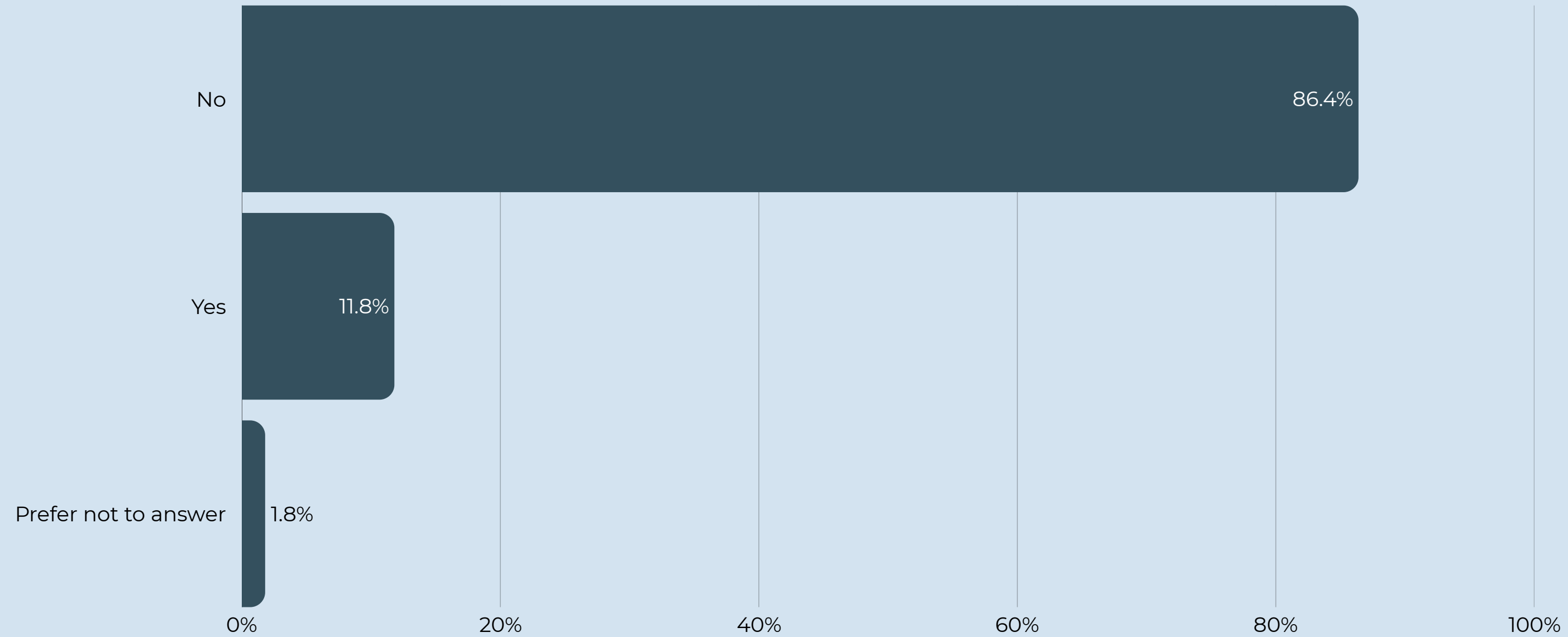

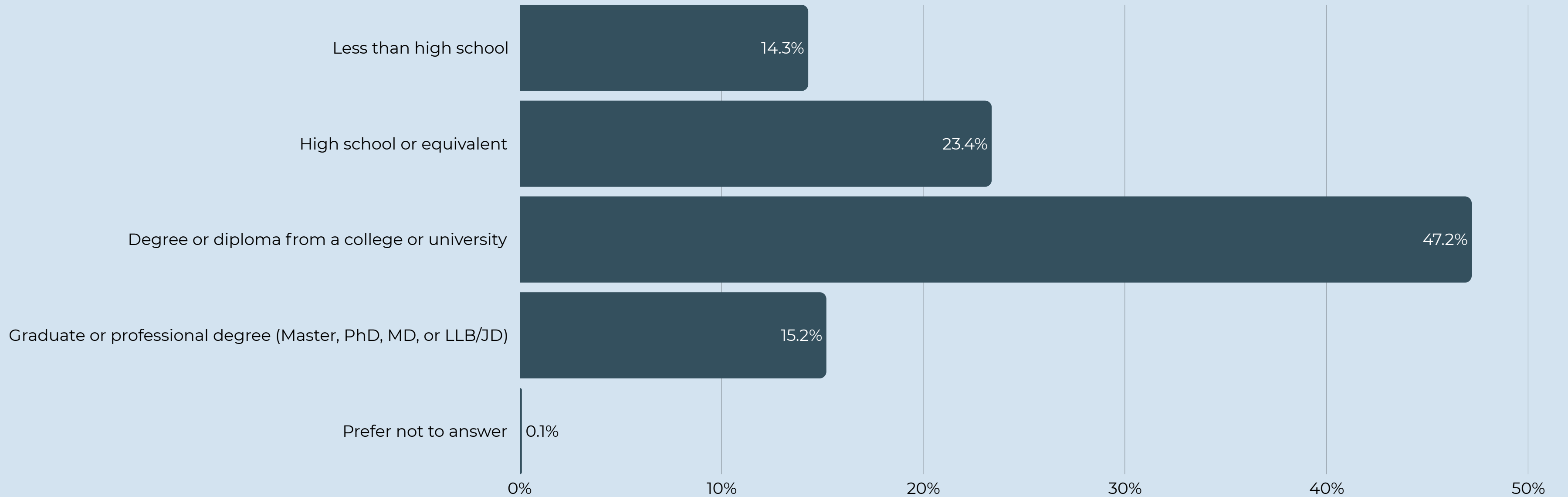

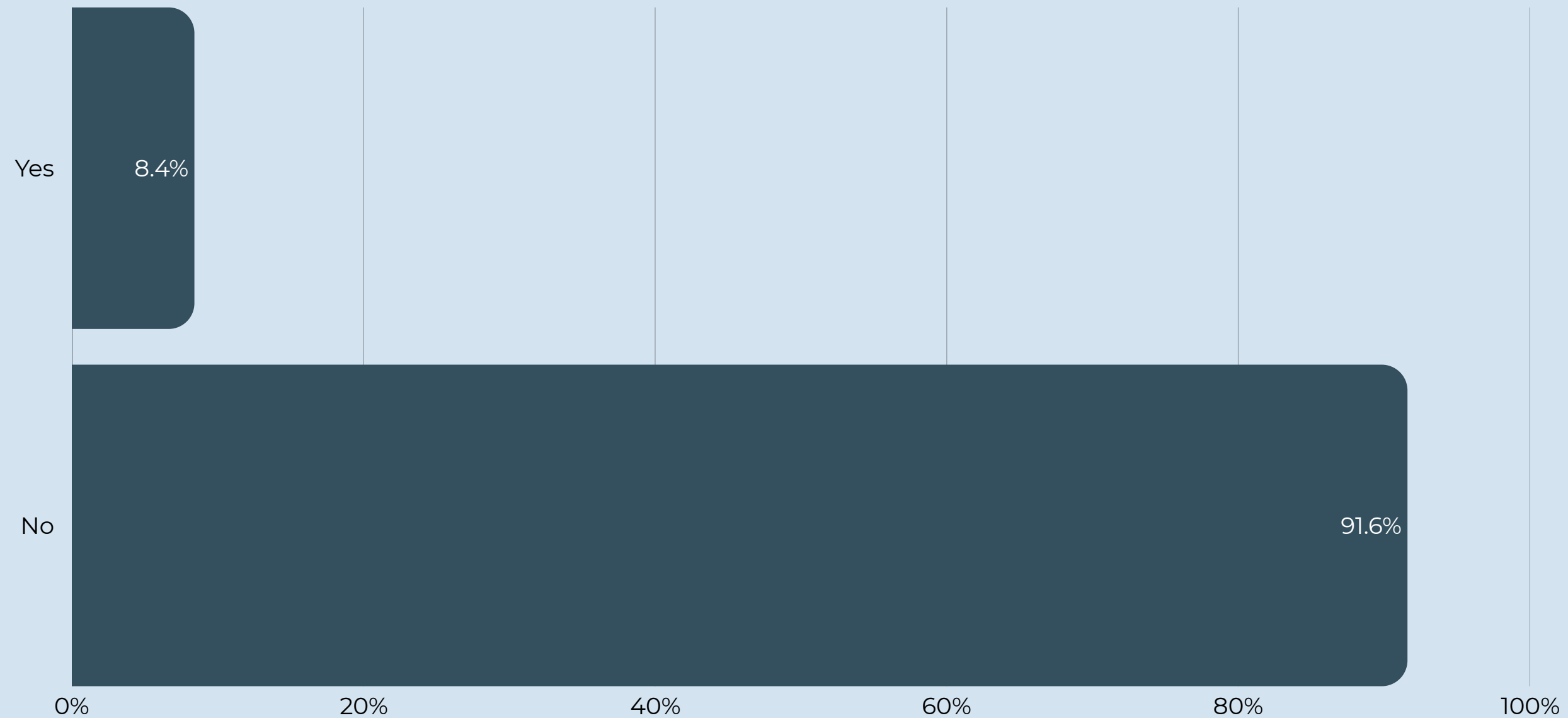

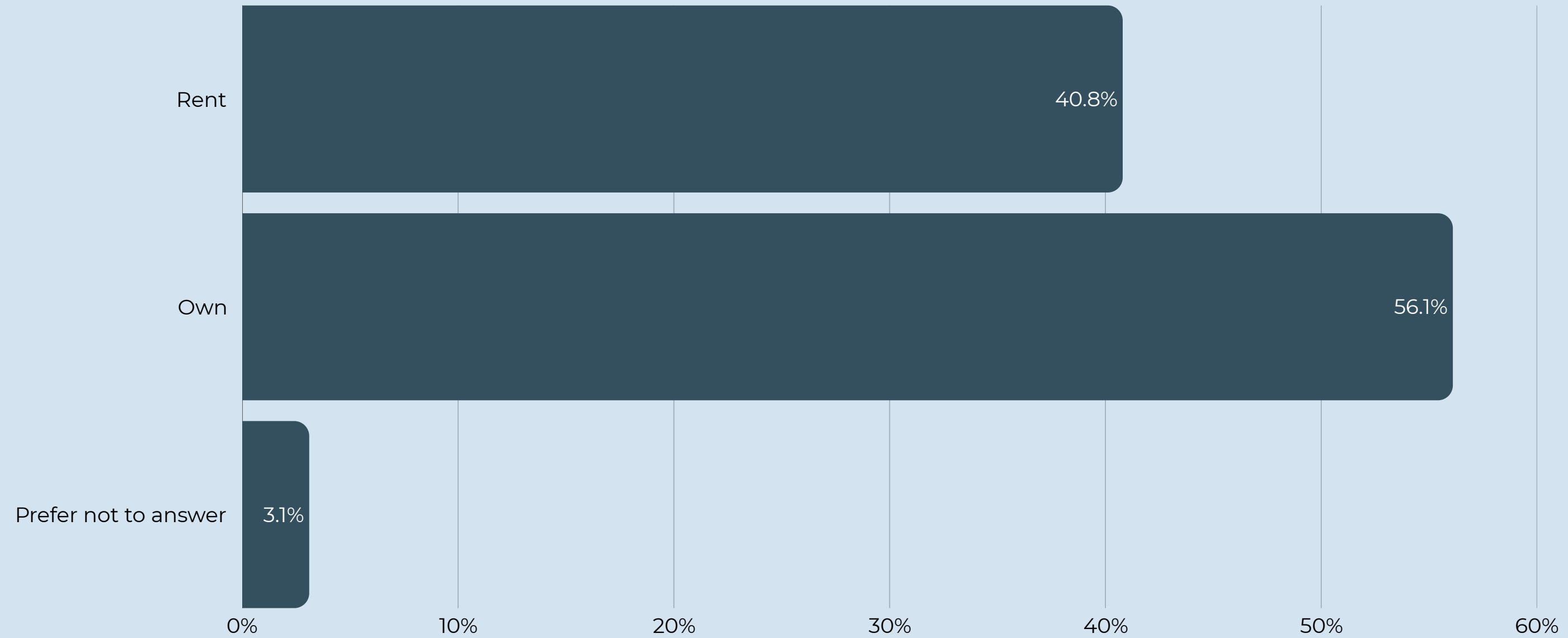

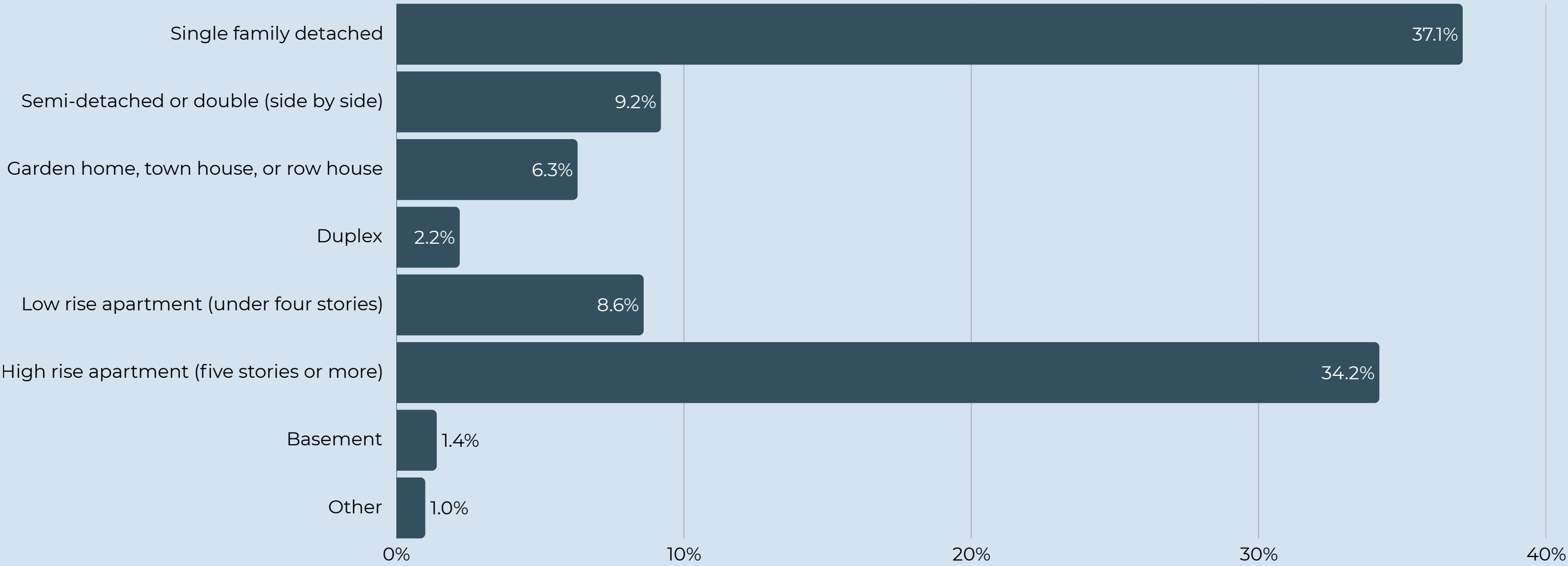

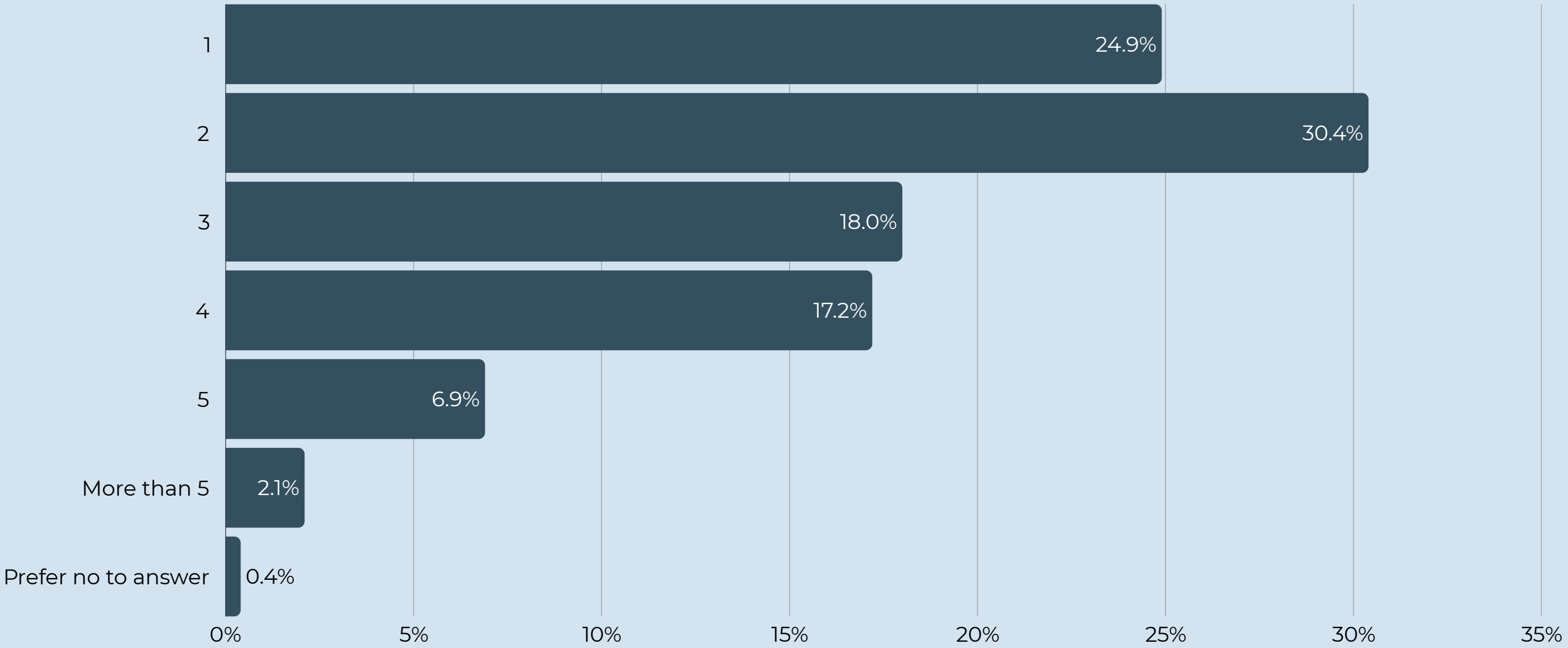

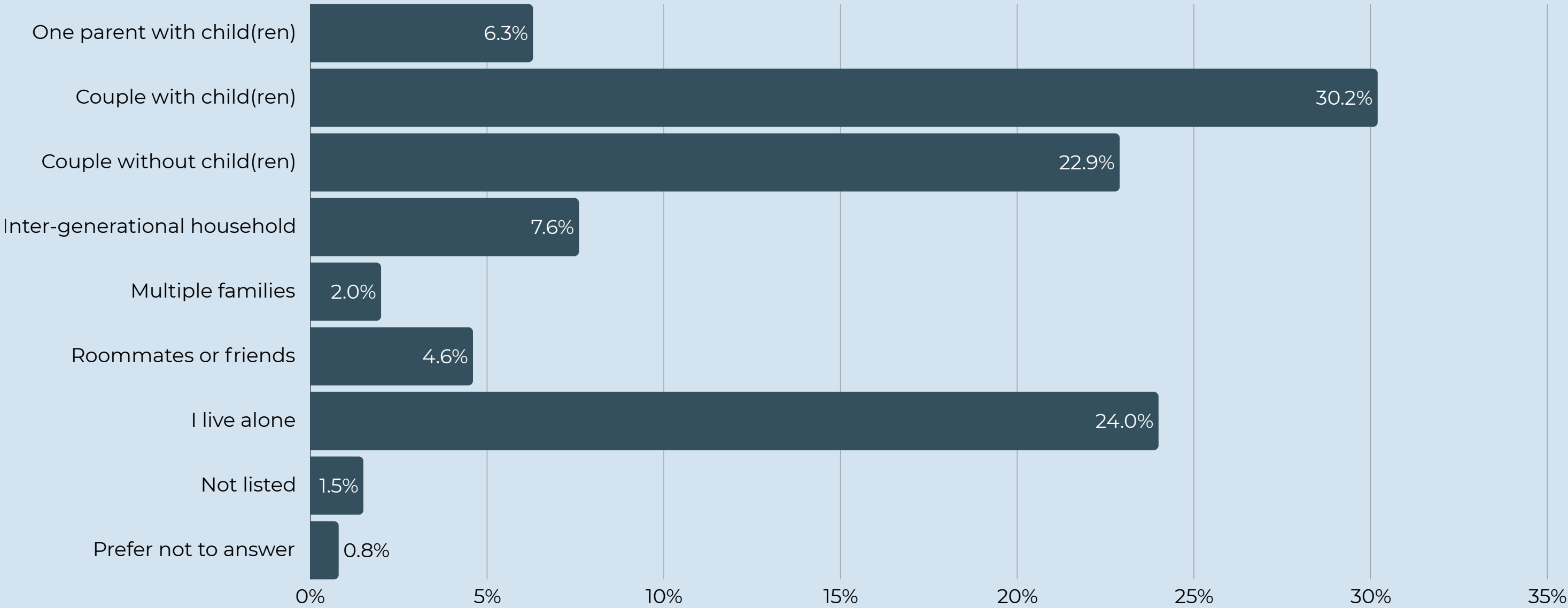

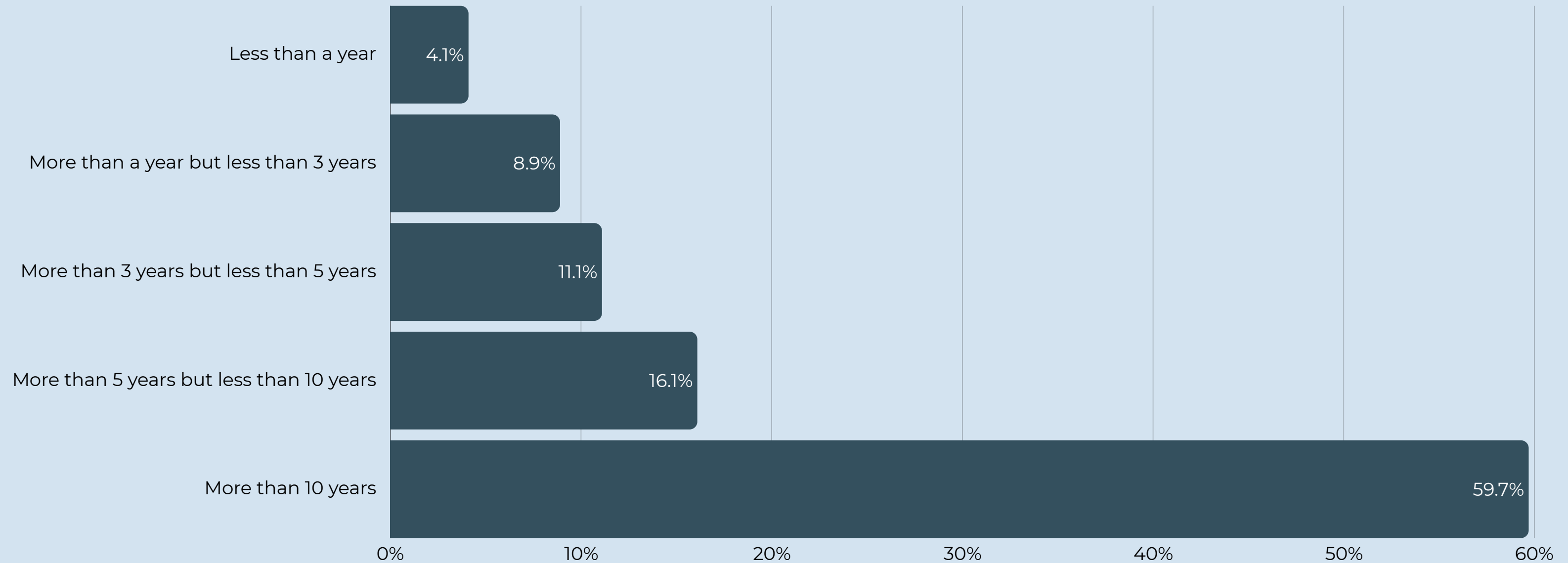

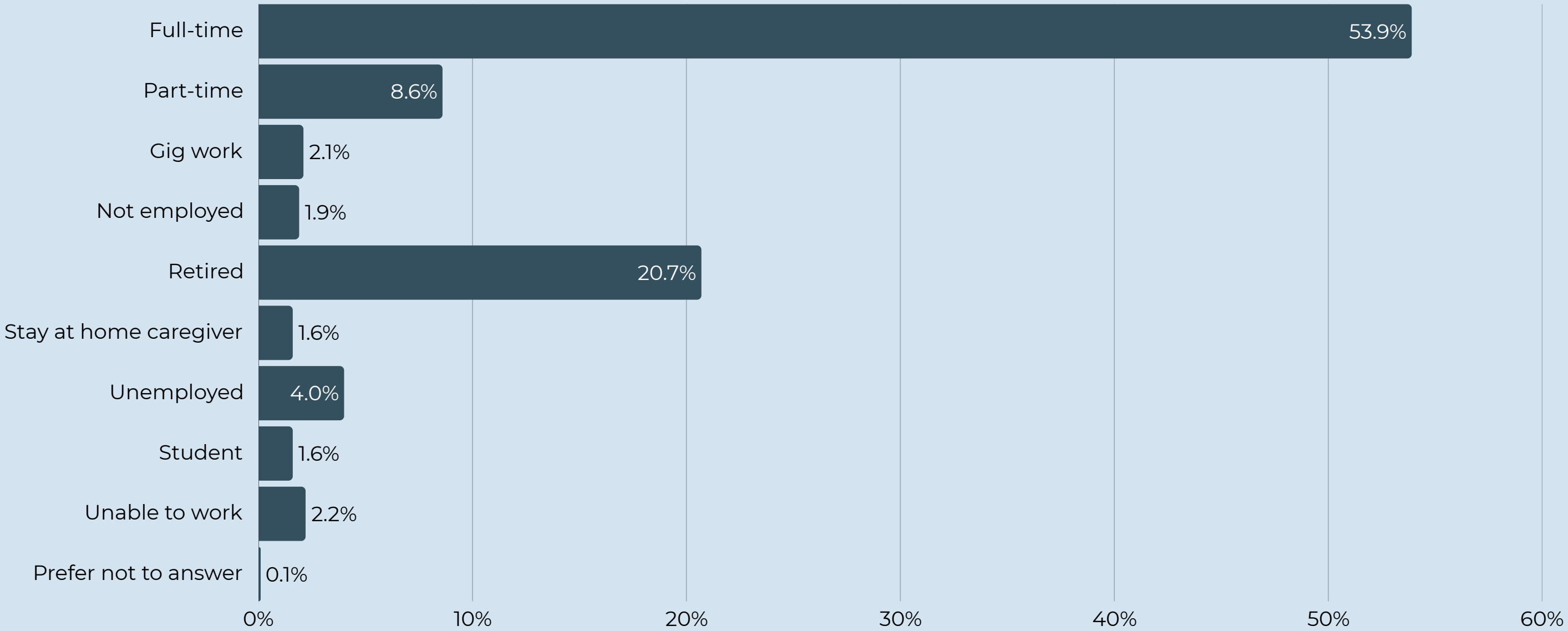

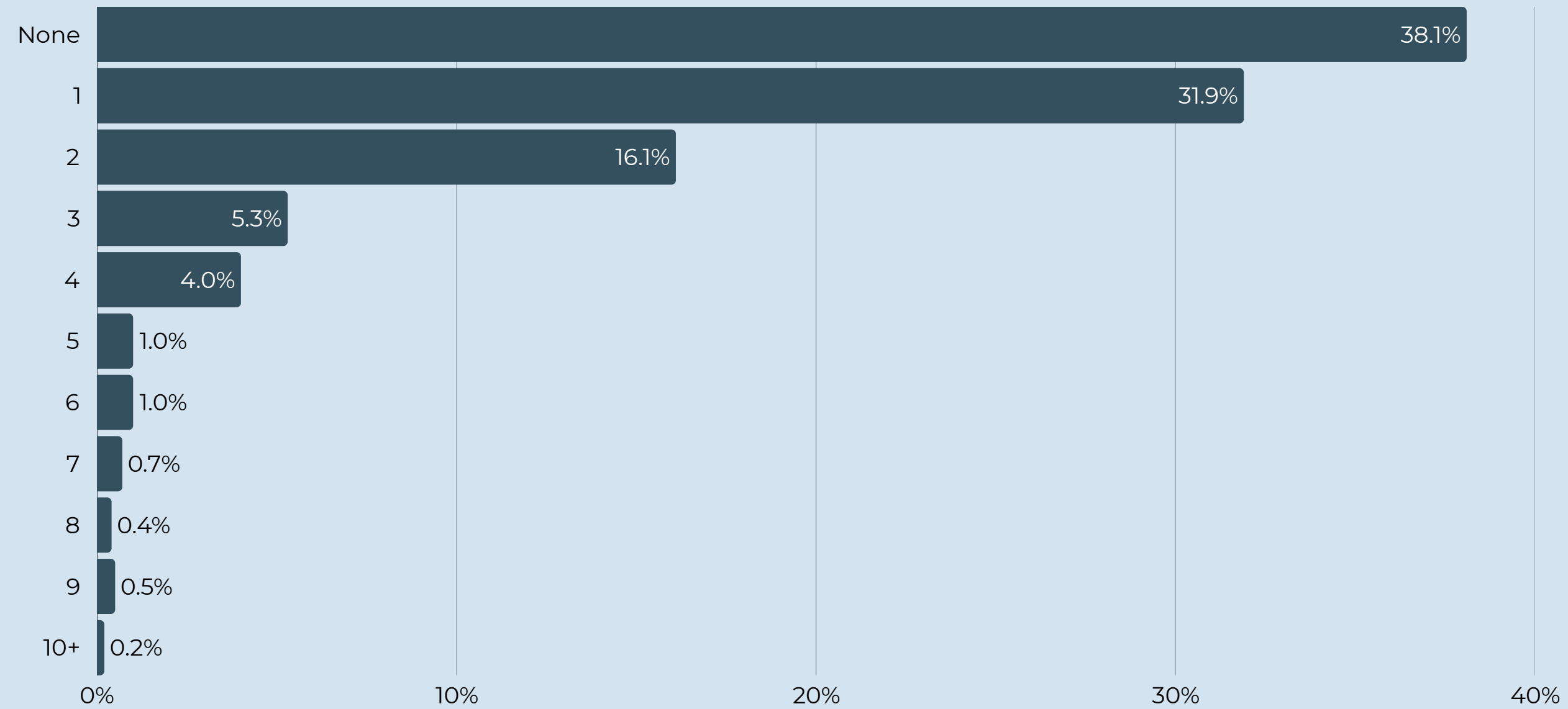

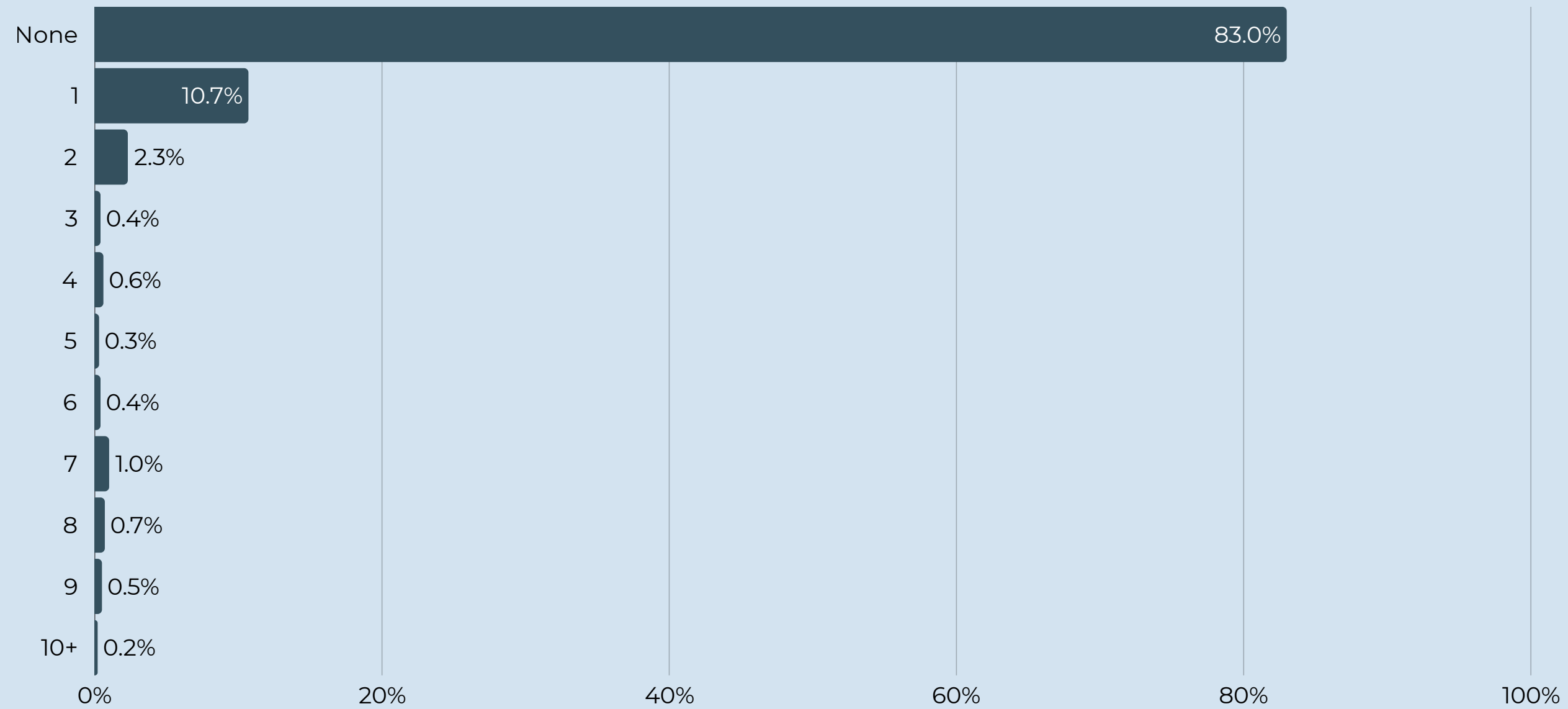

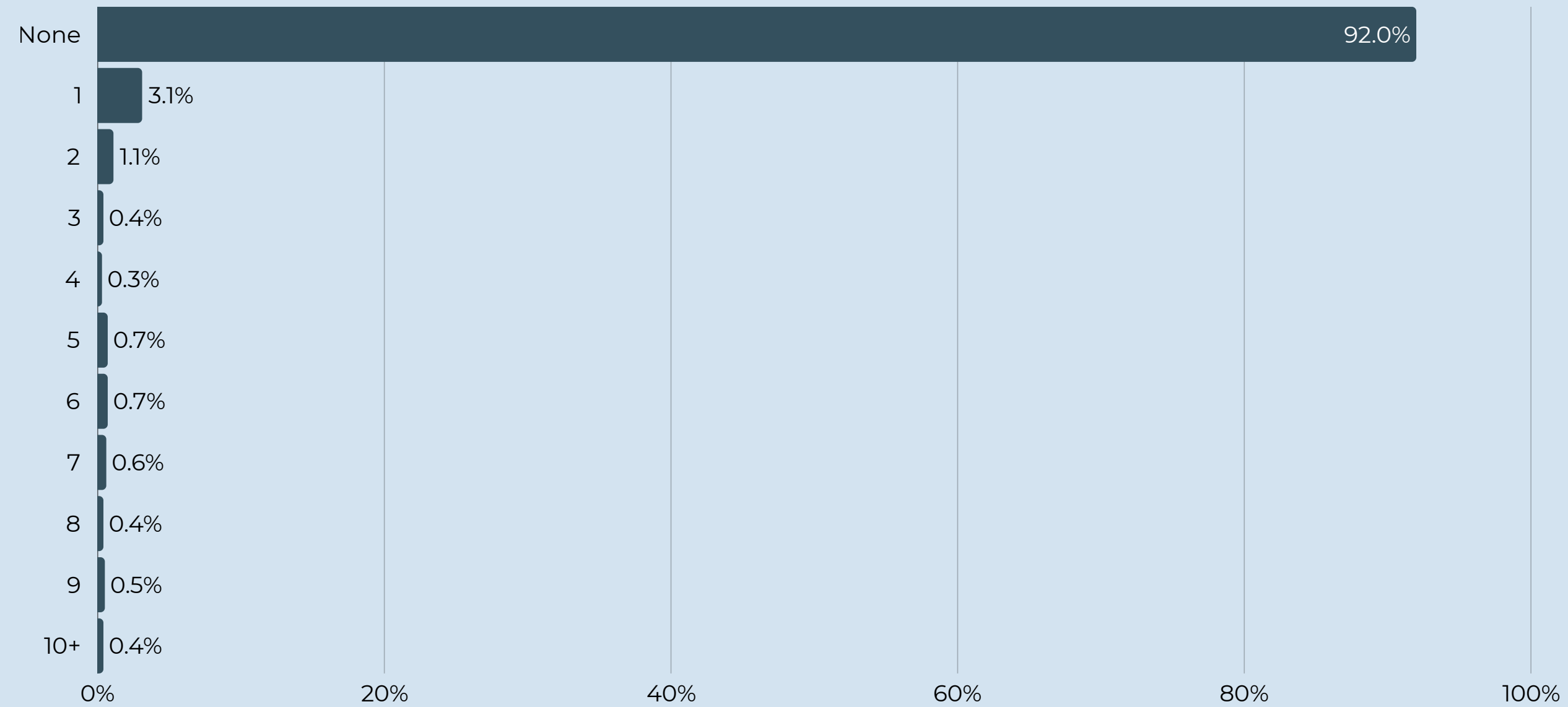

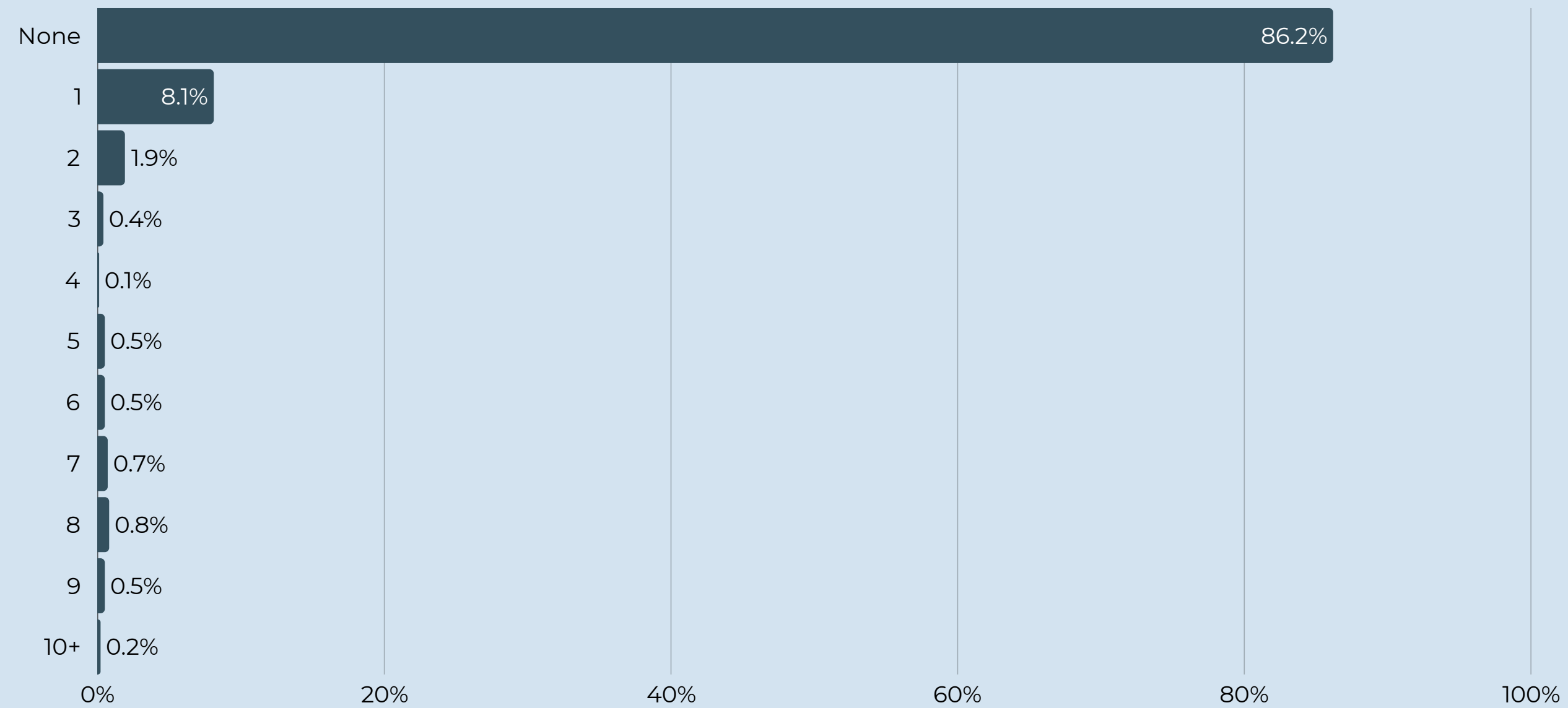

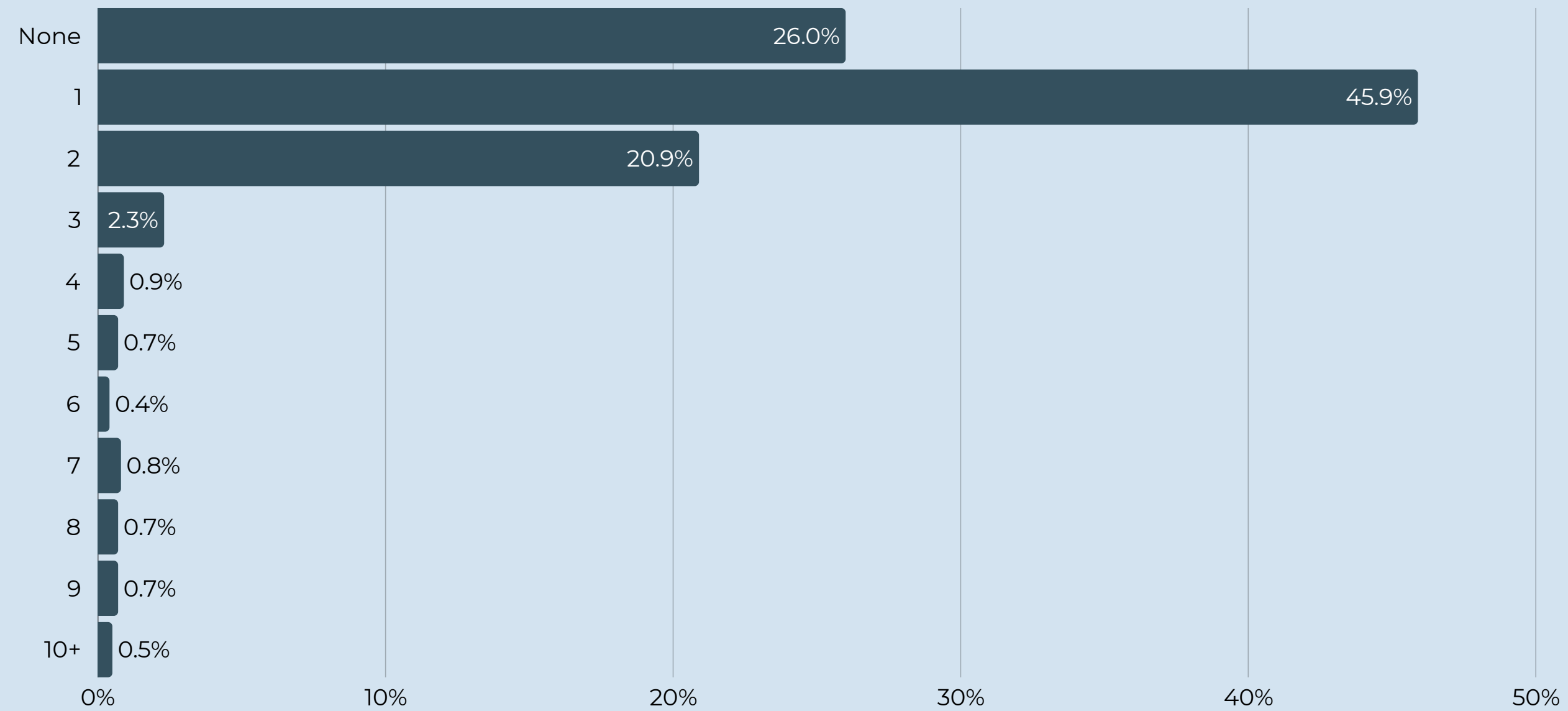

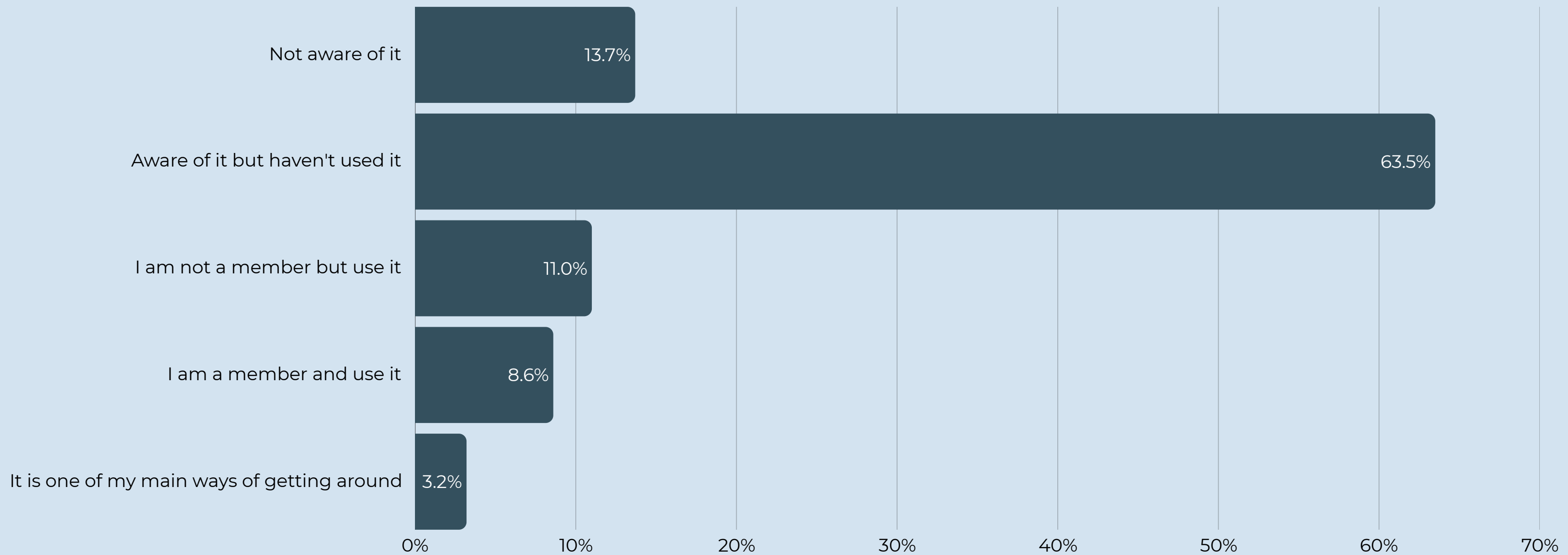

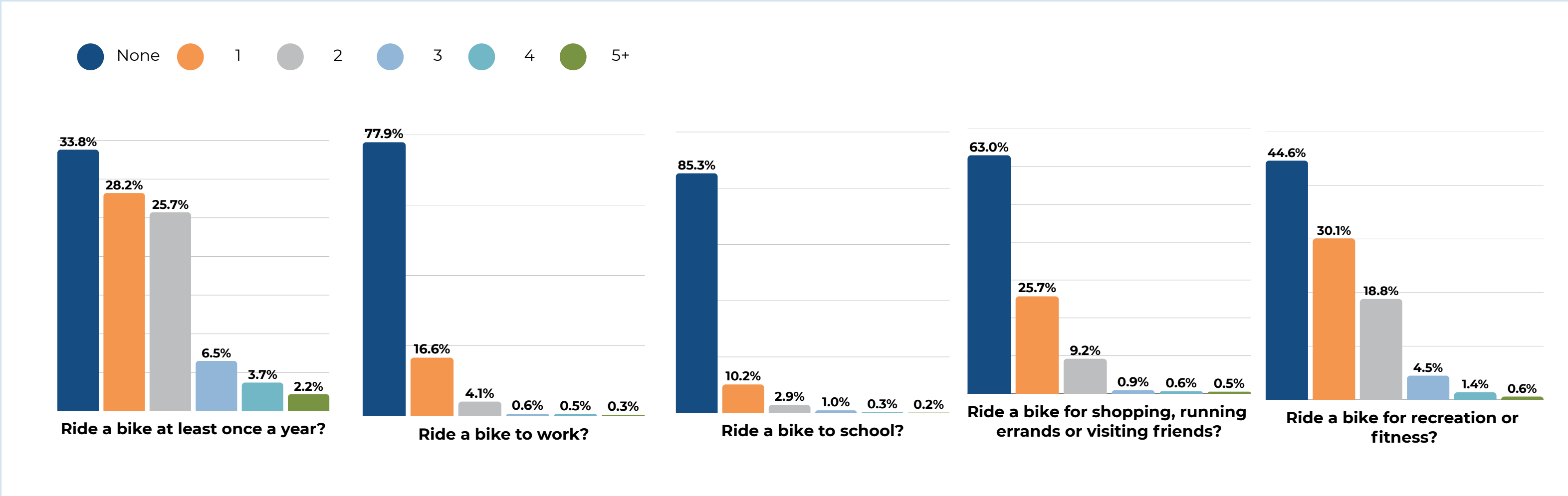

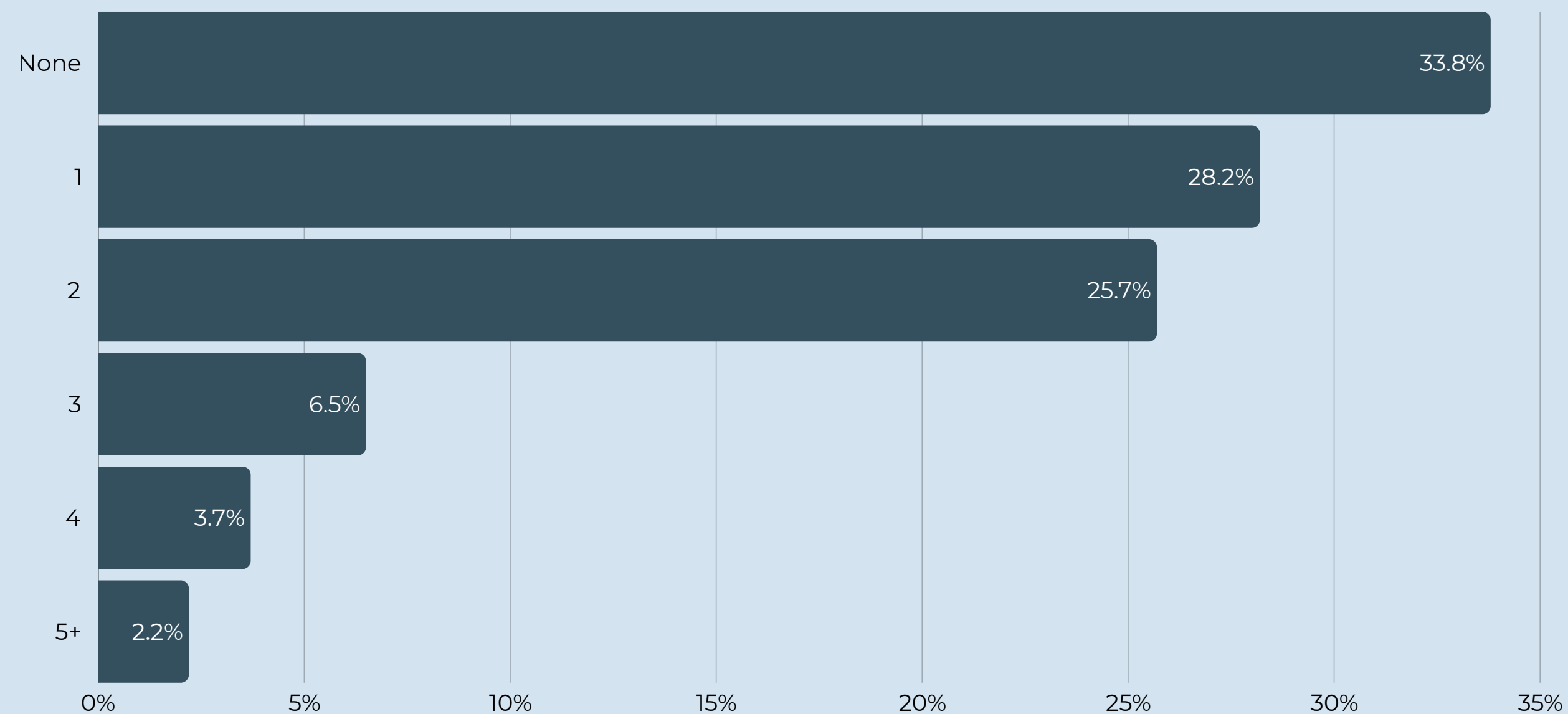

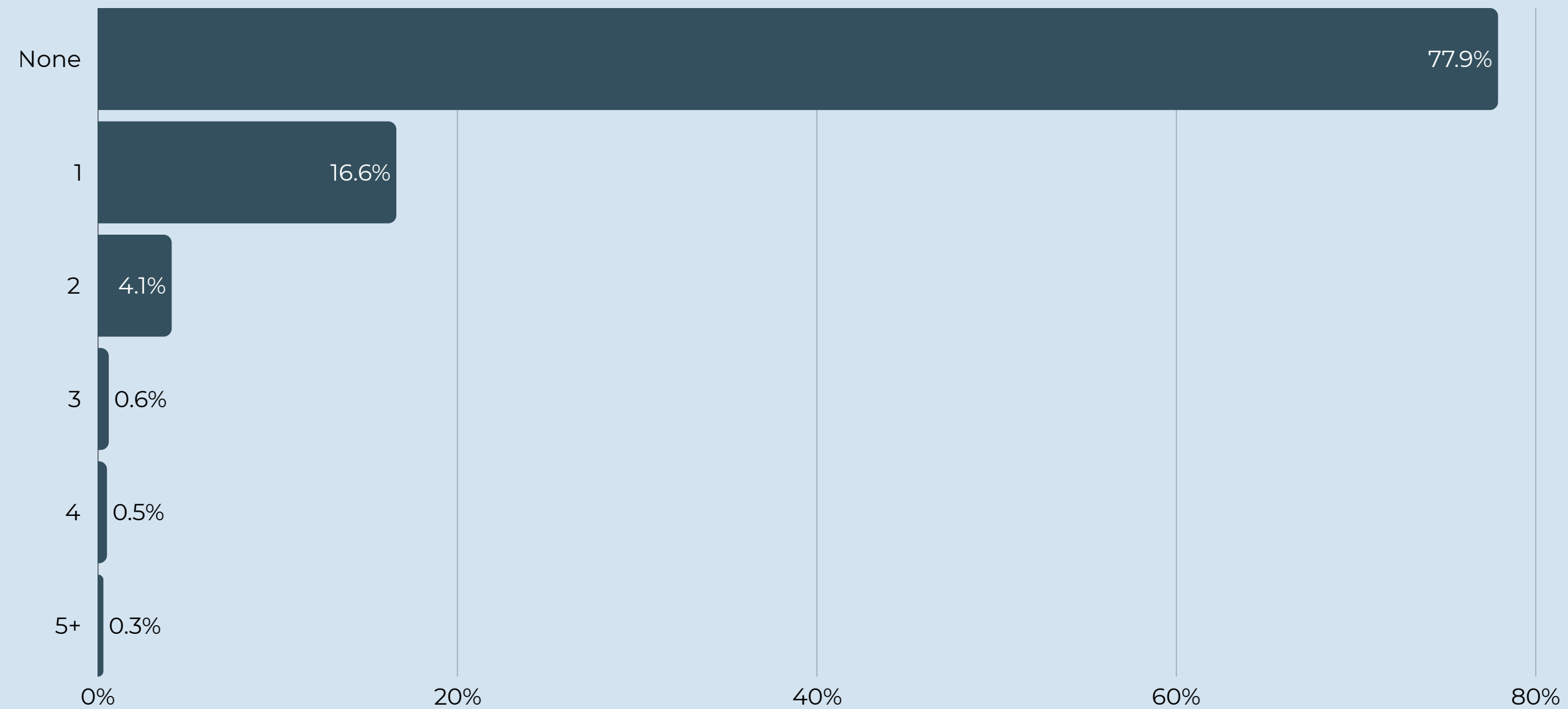

NUMBER OF PERSONS IN HOUSEHOLD WHO RIDE A BIKE



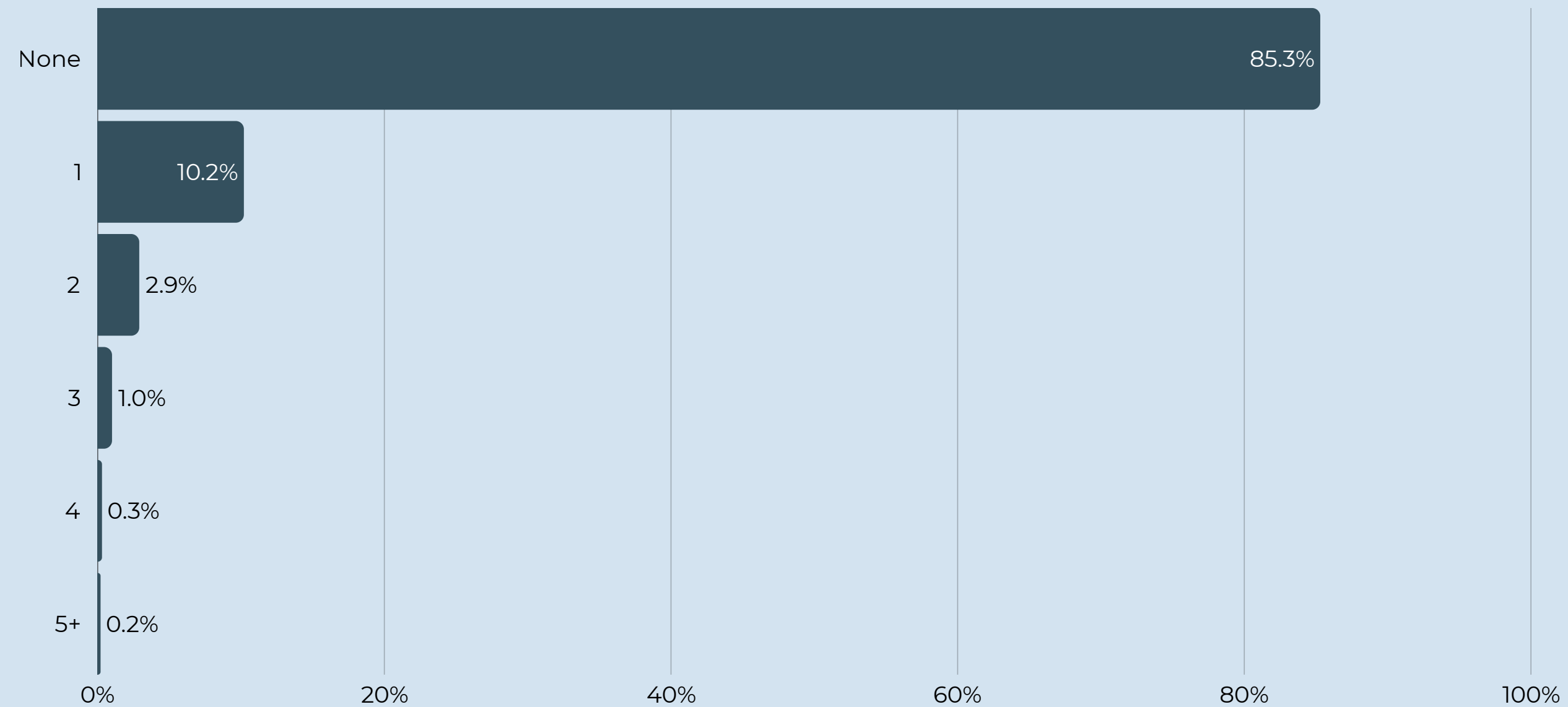

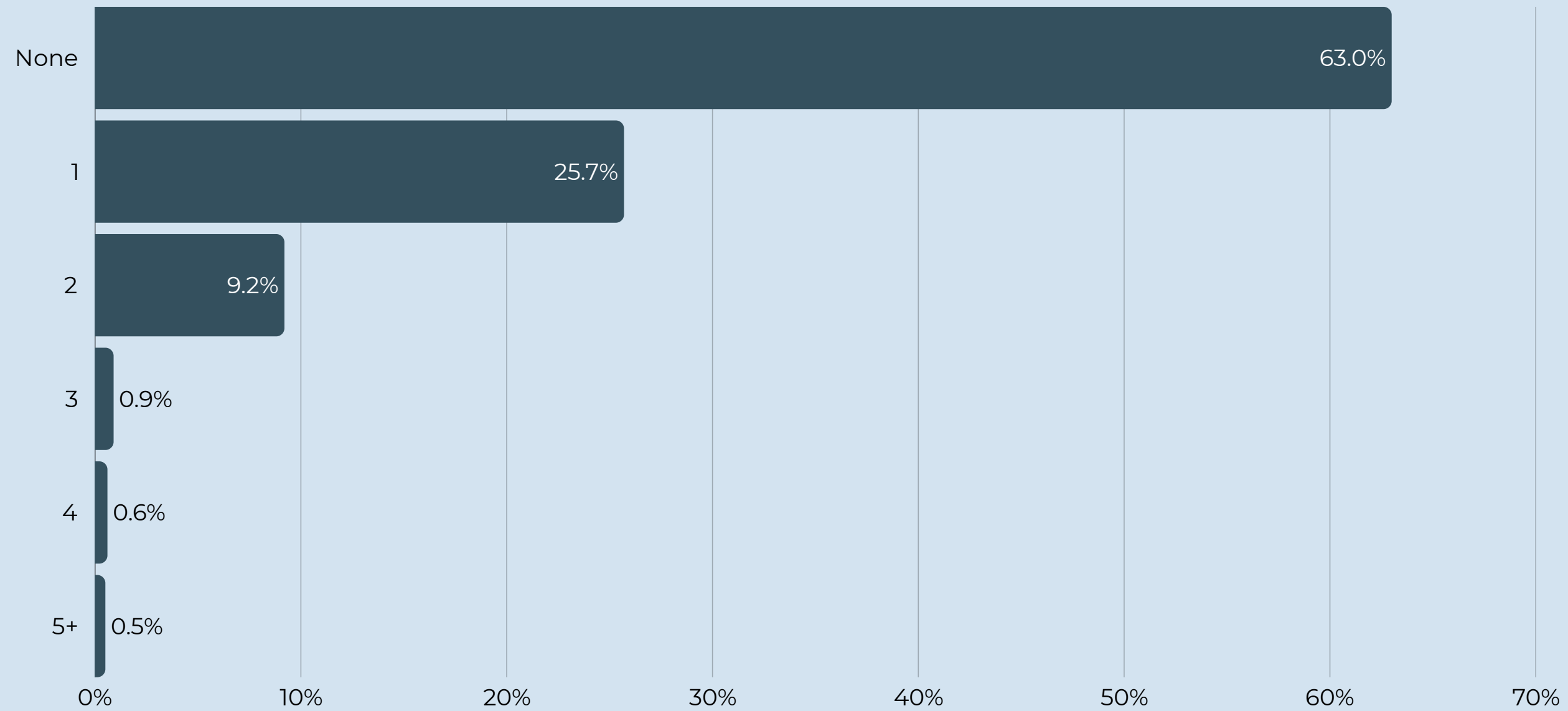

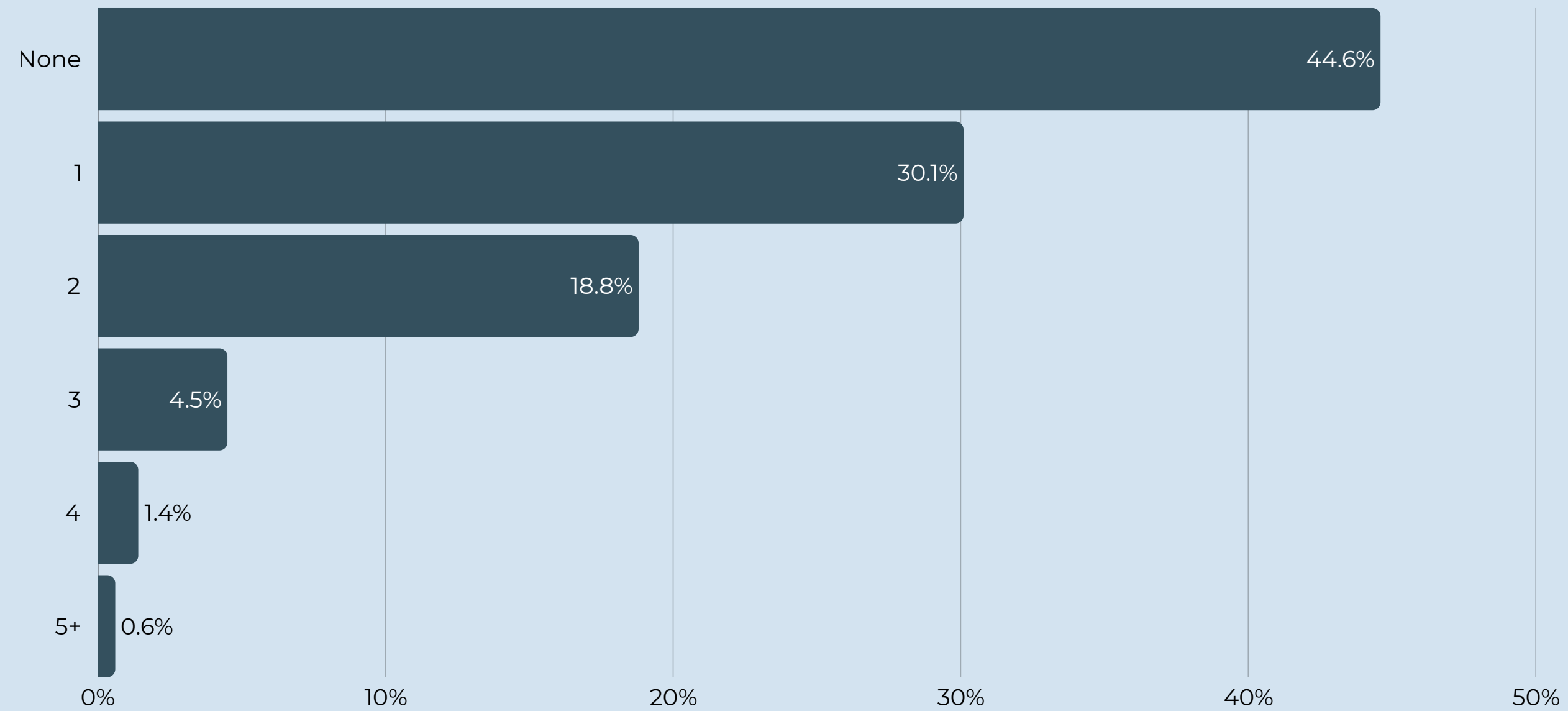

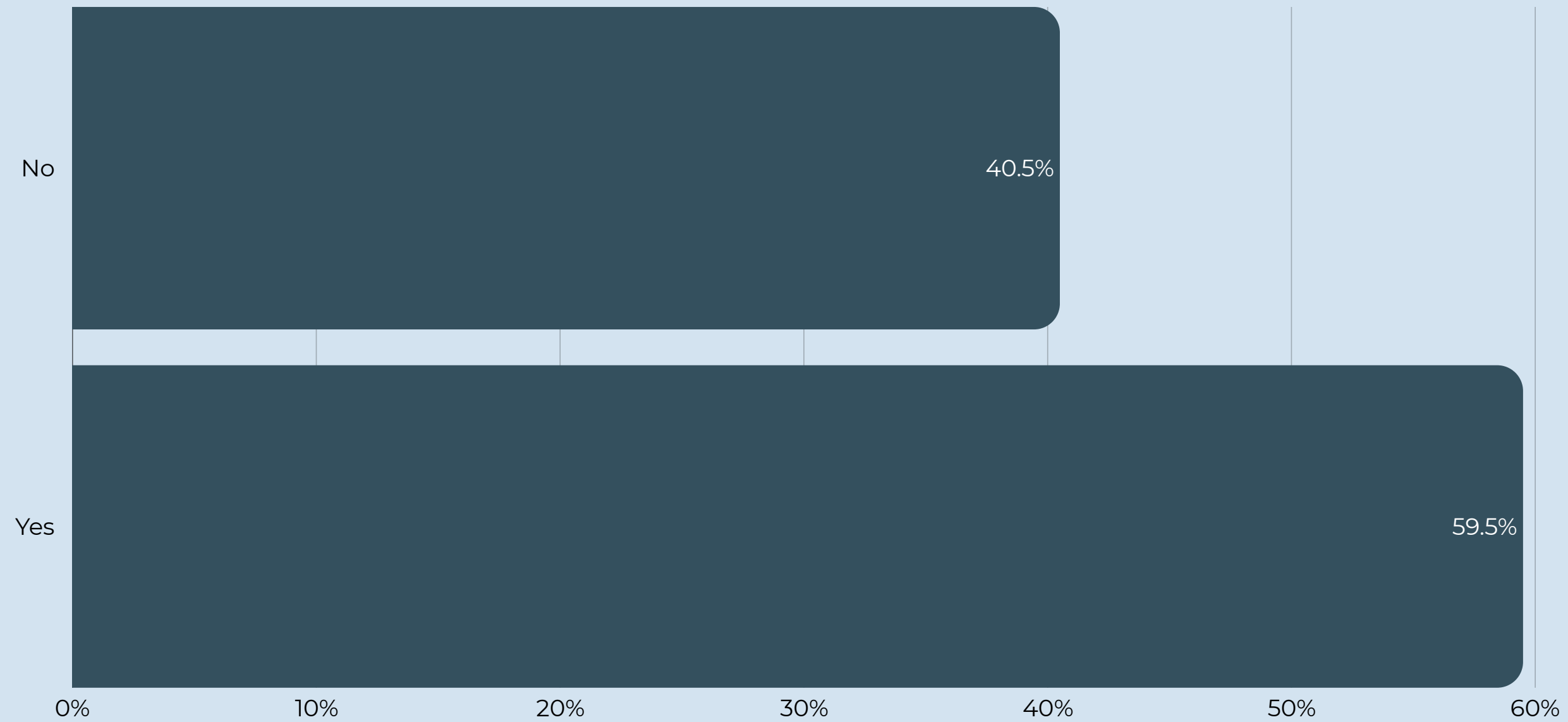

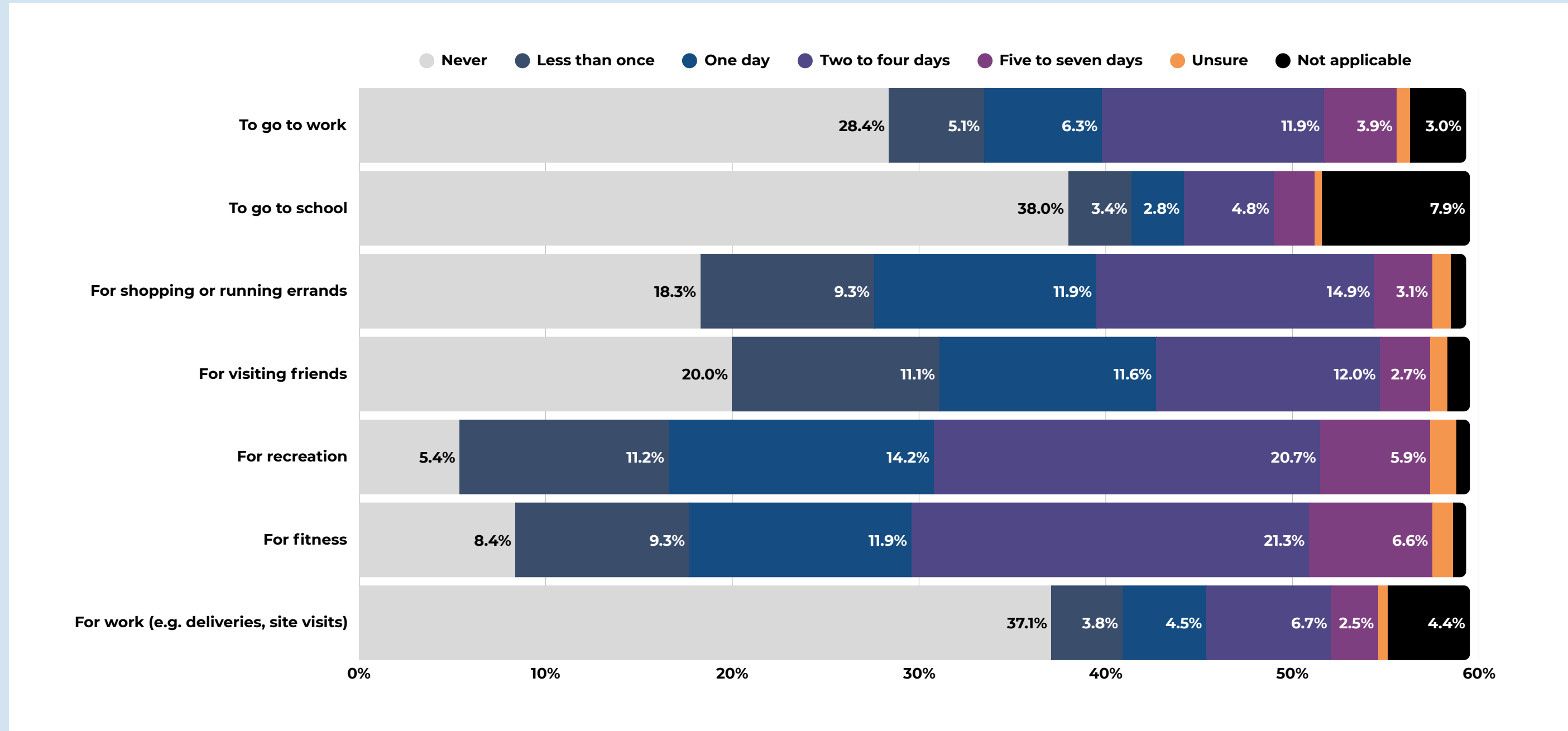

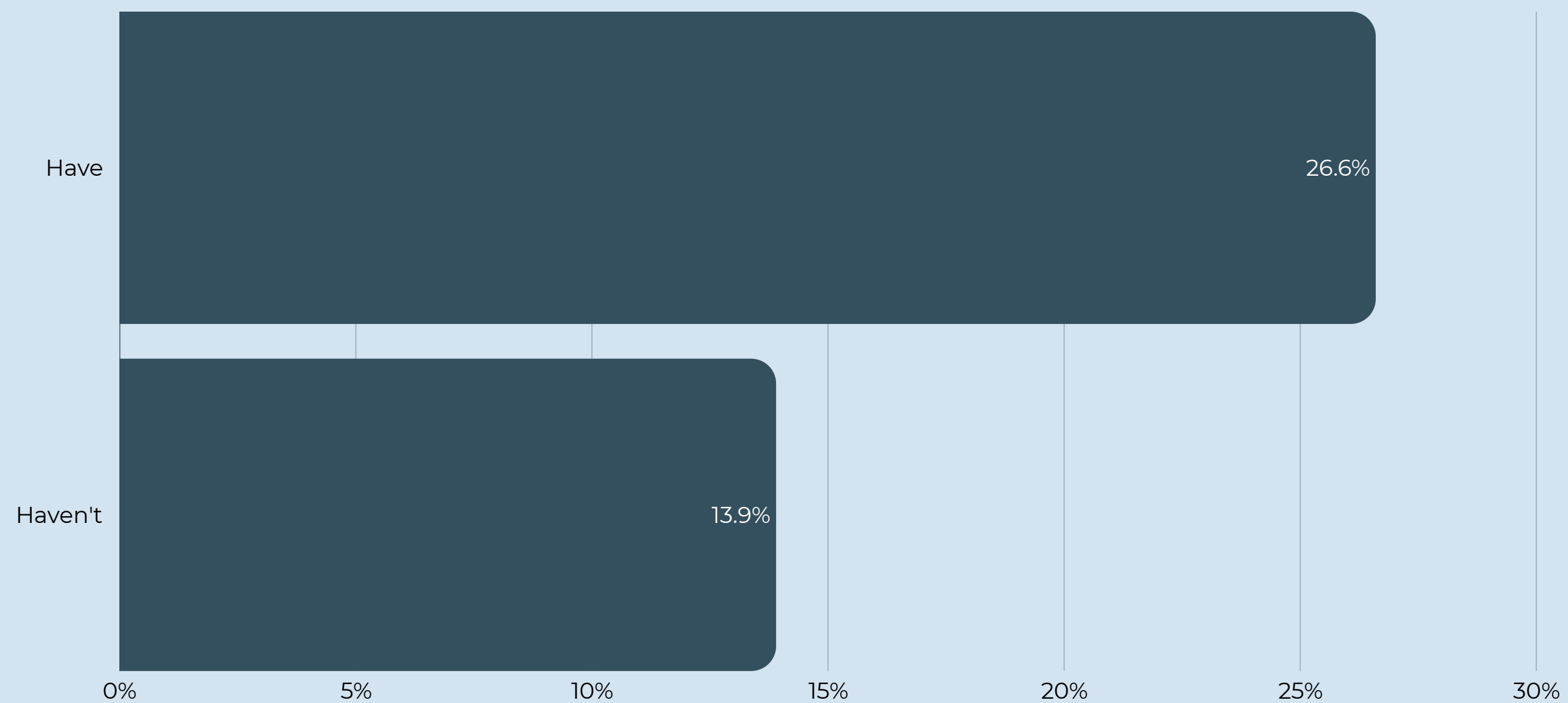

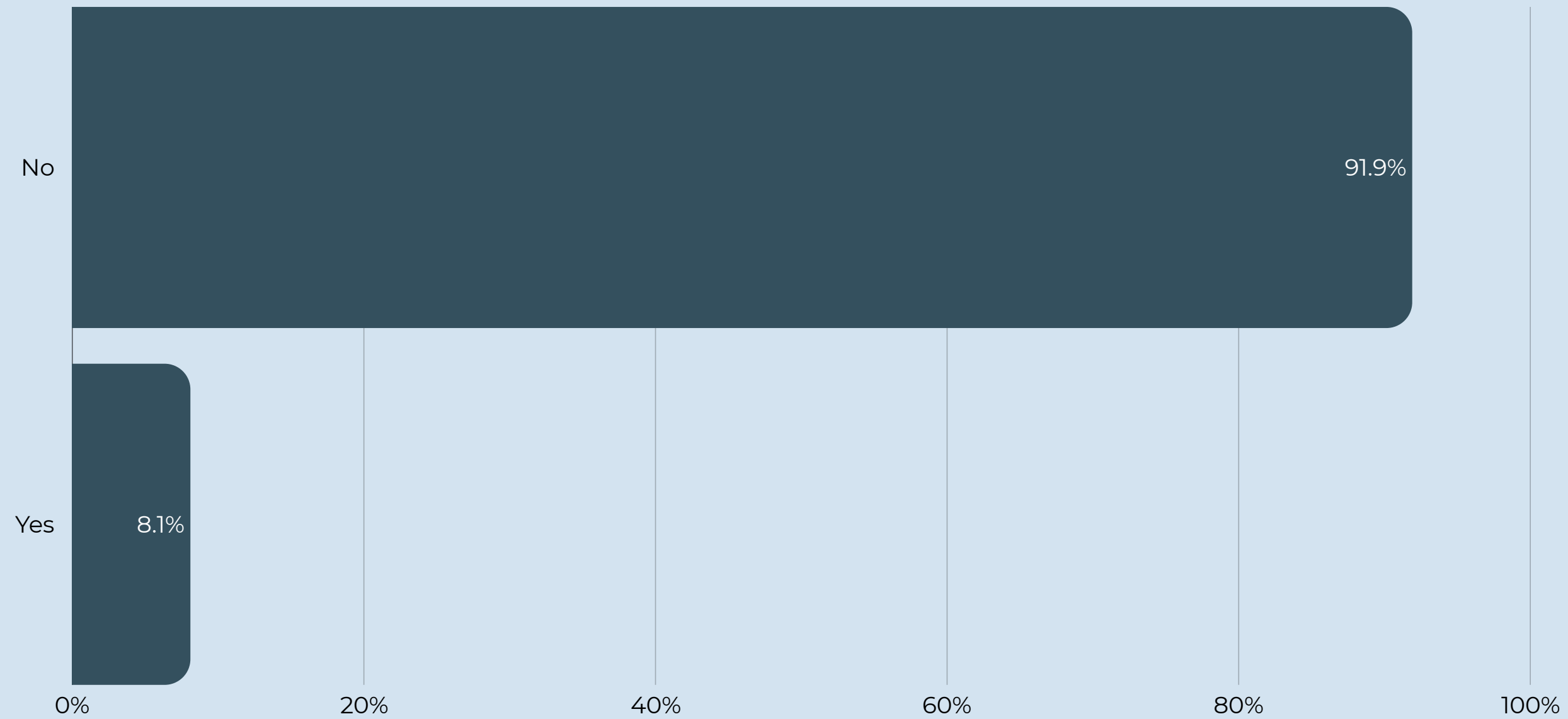

PAST BIKE USAGE AMONG RESPONDENTS WHO DO NOT RIDE



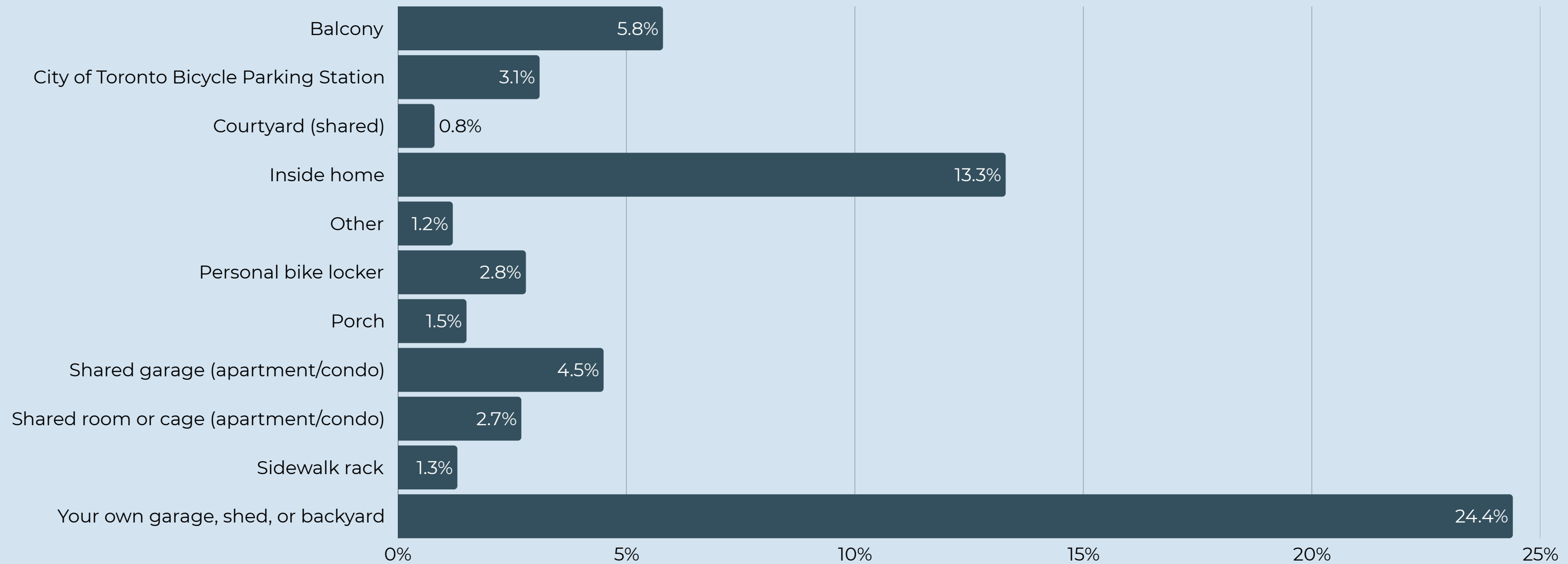

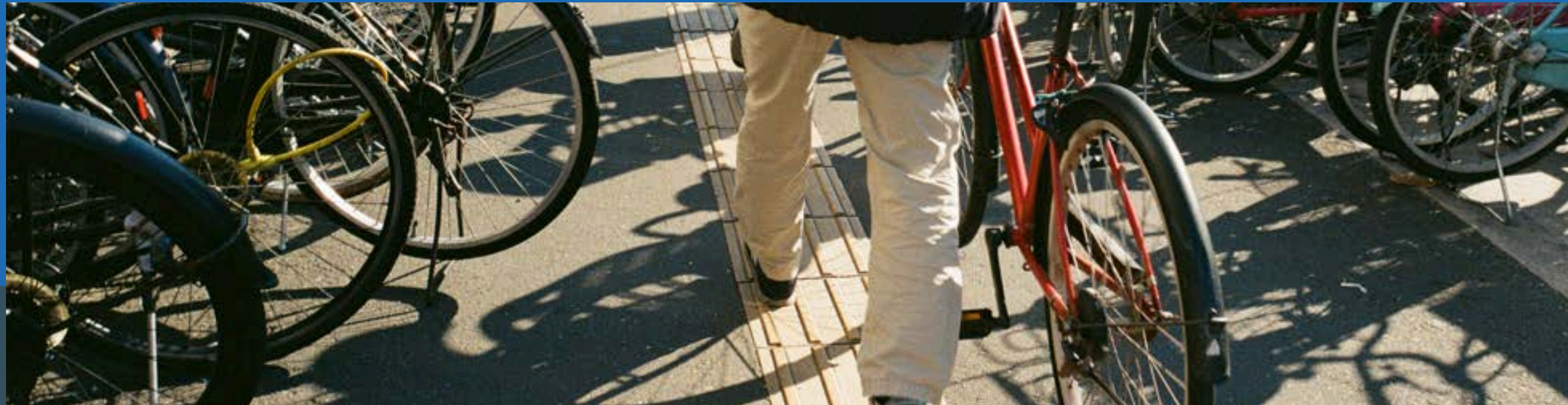

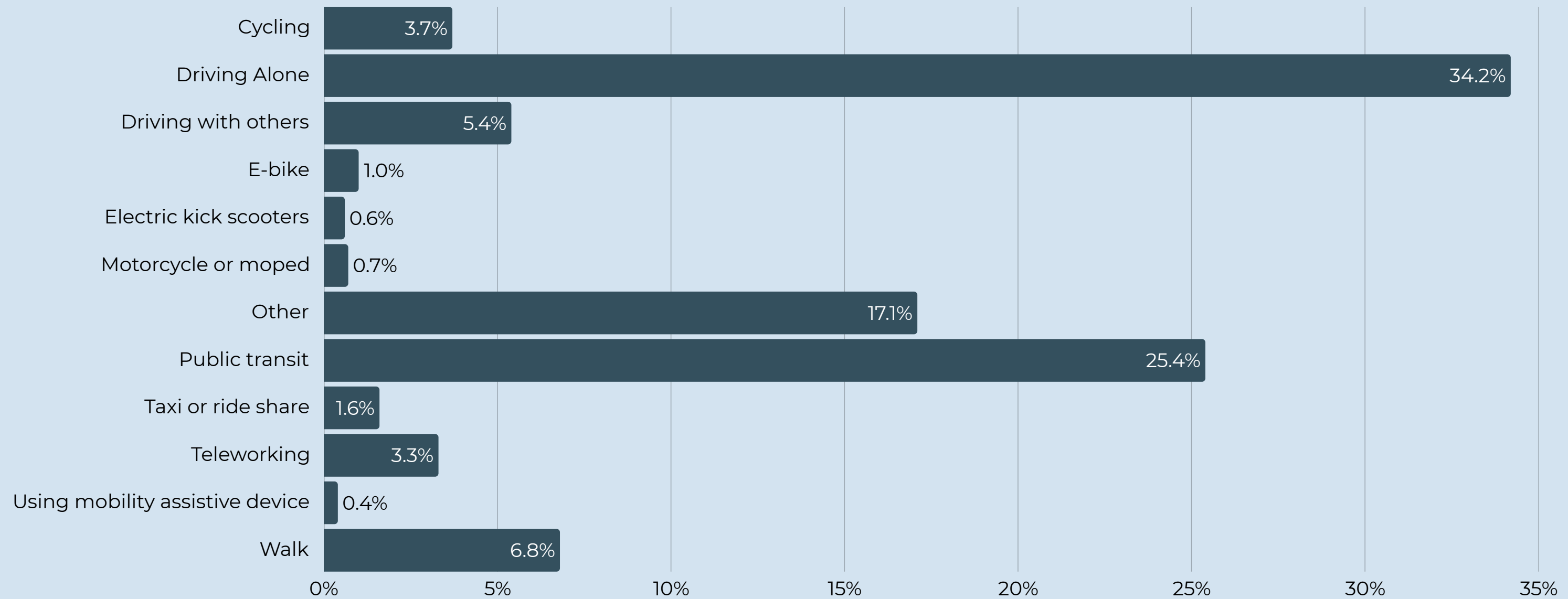

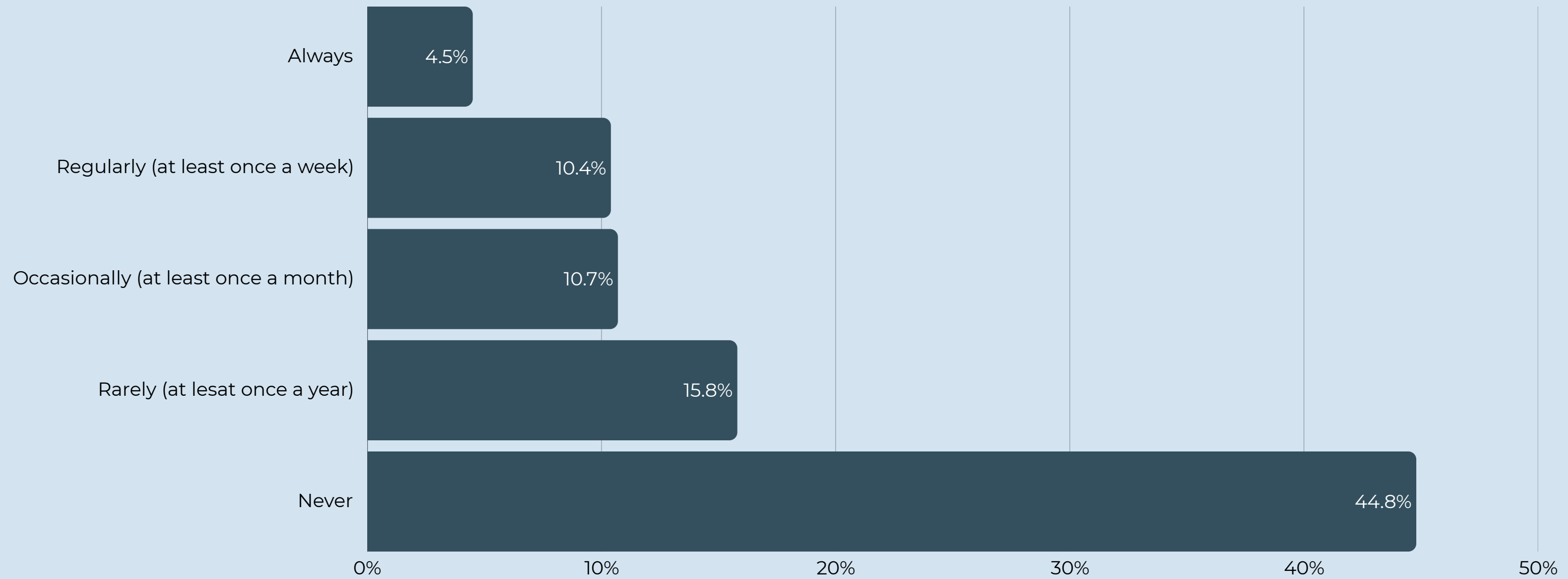

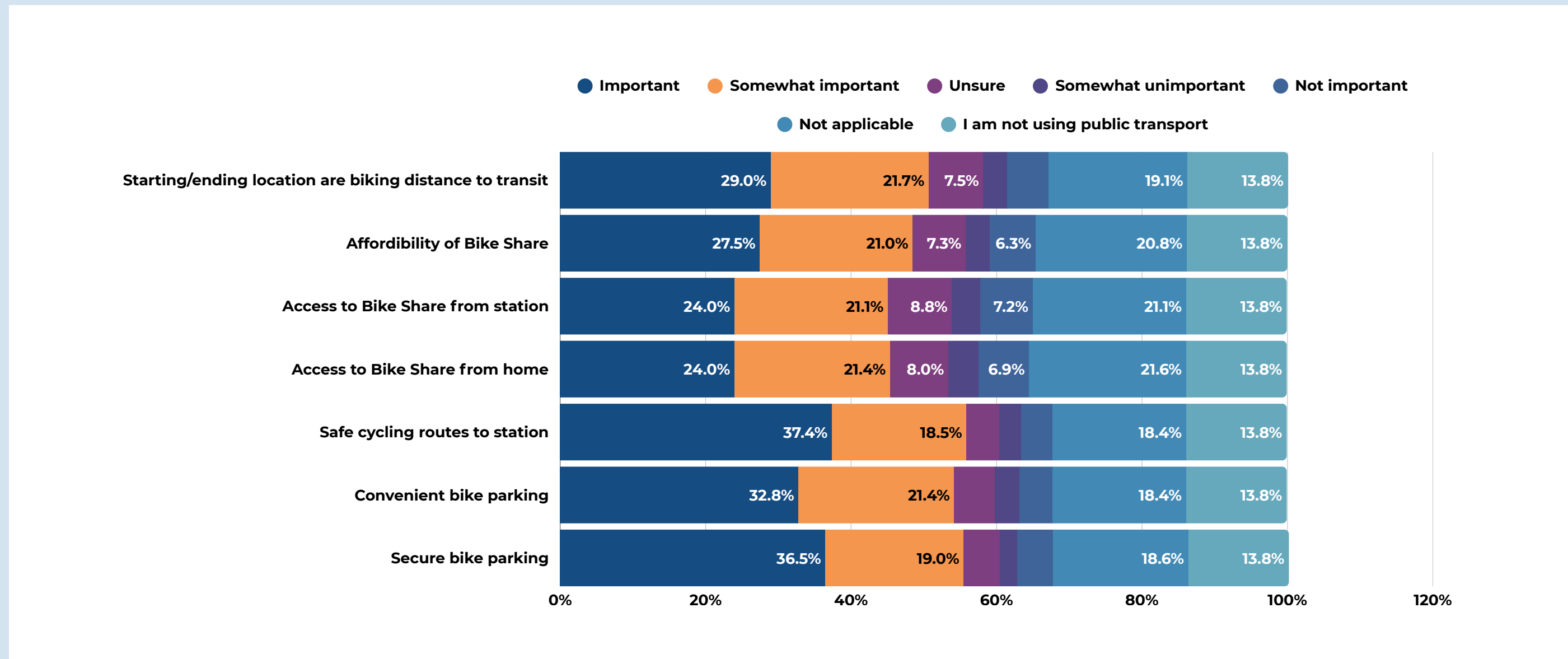

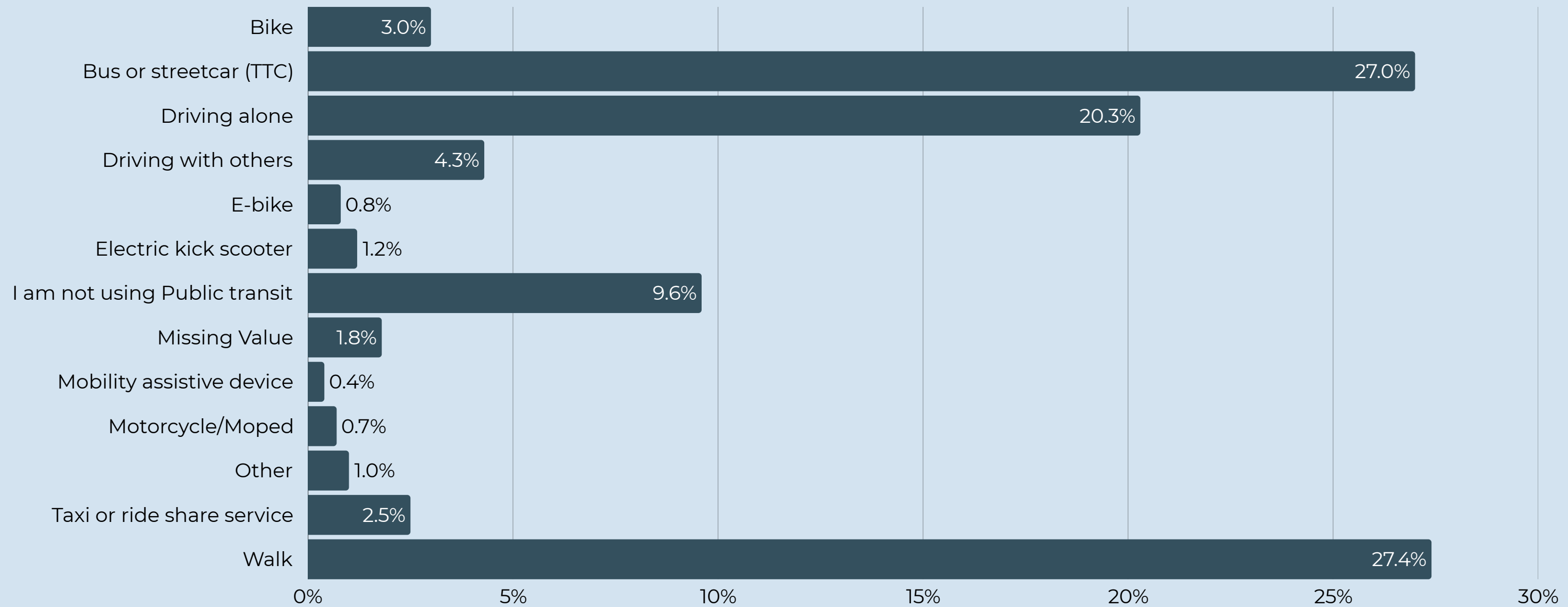

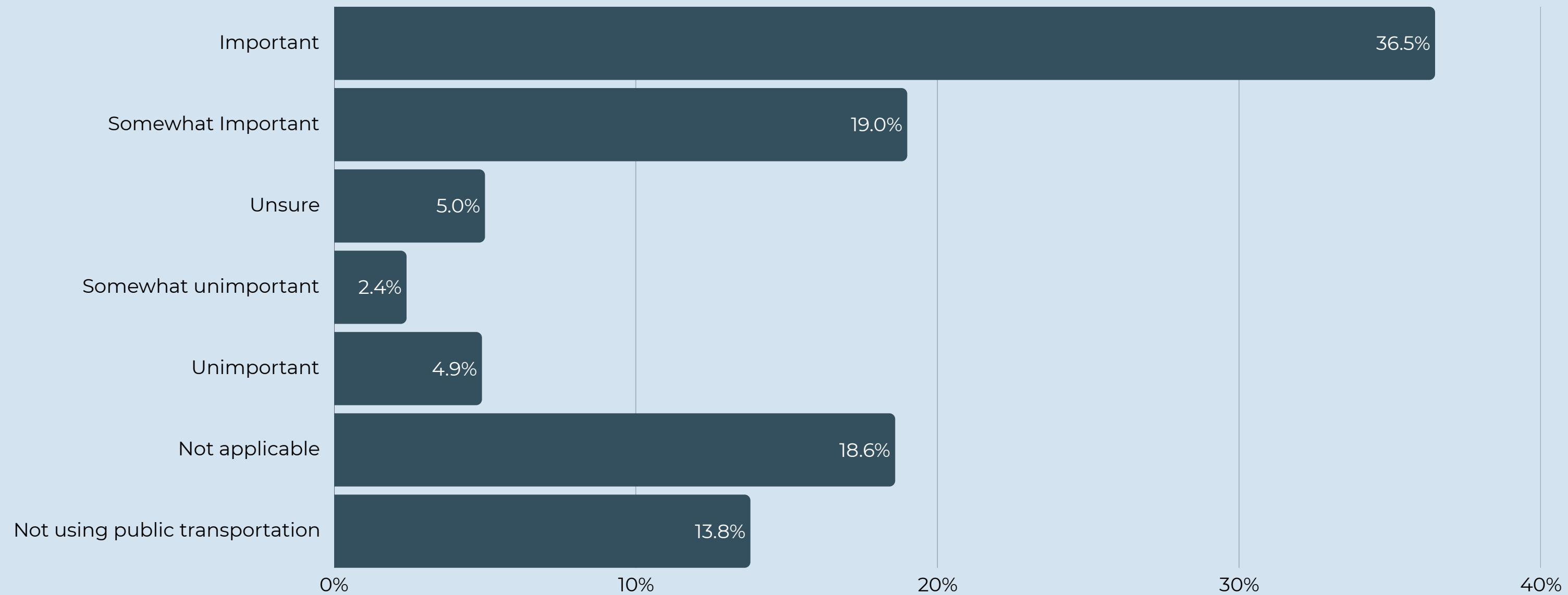

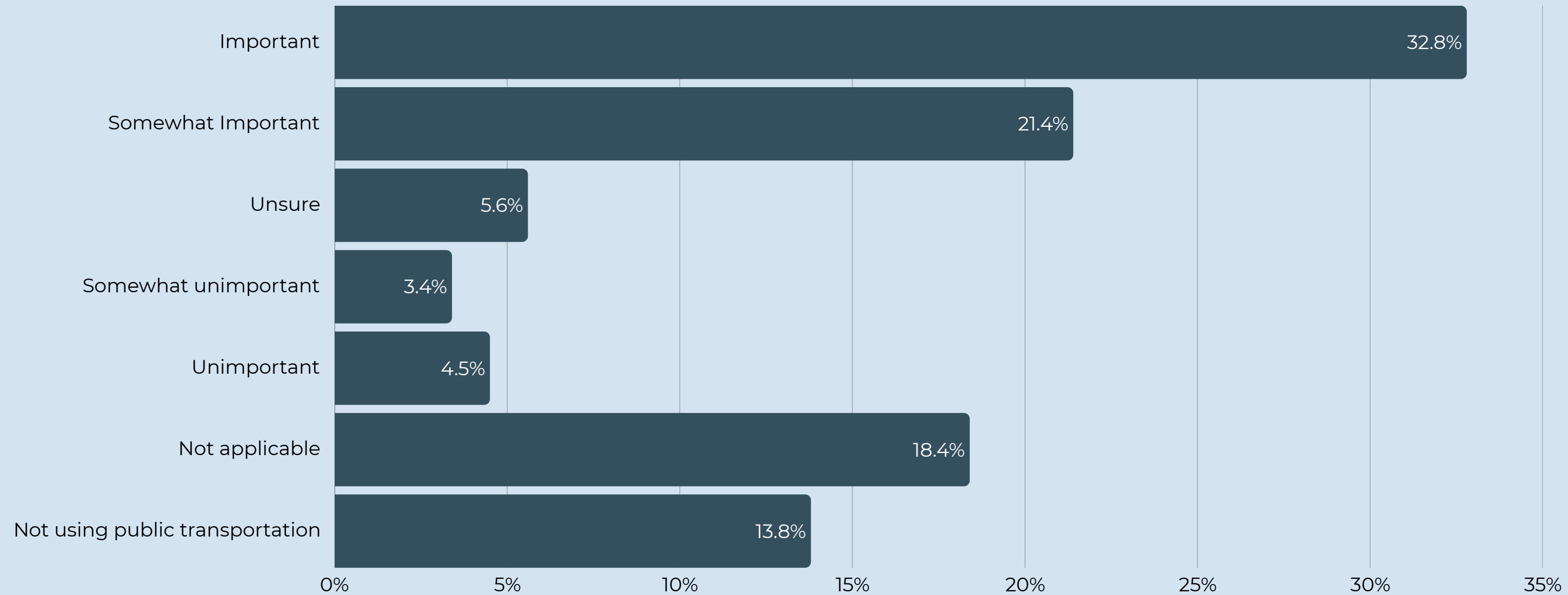

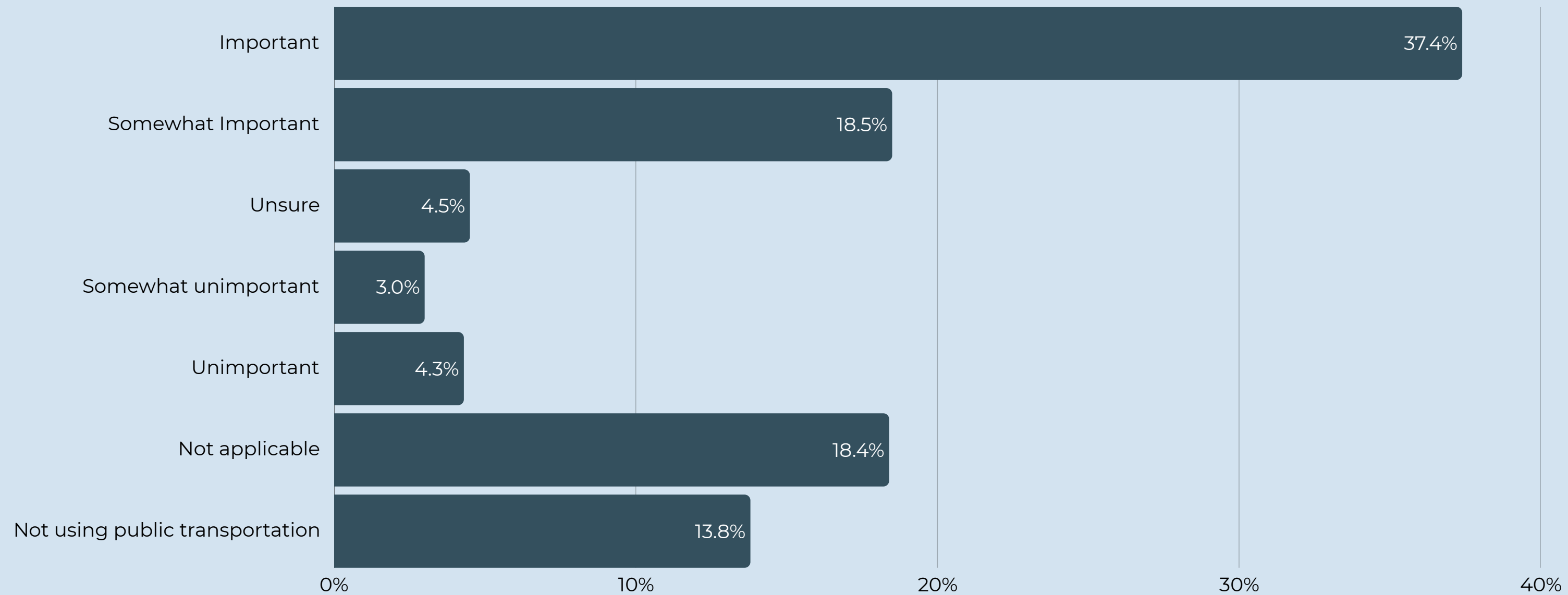

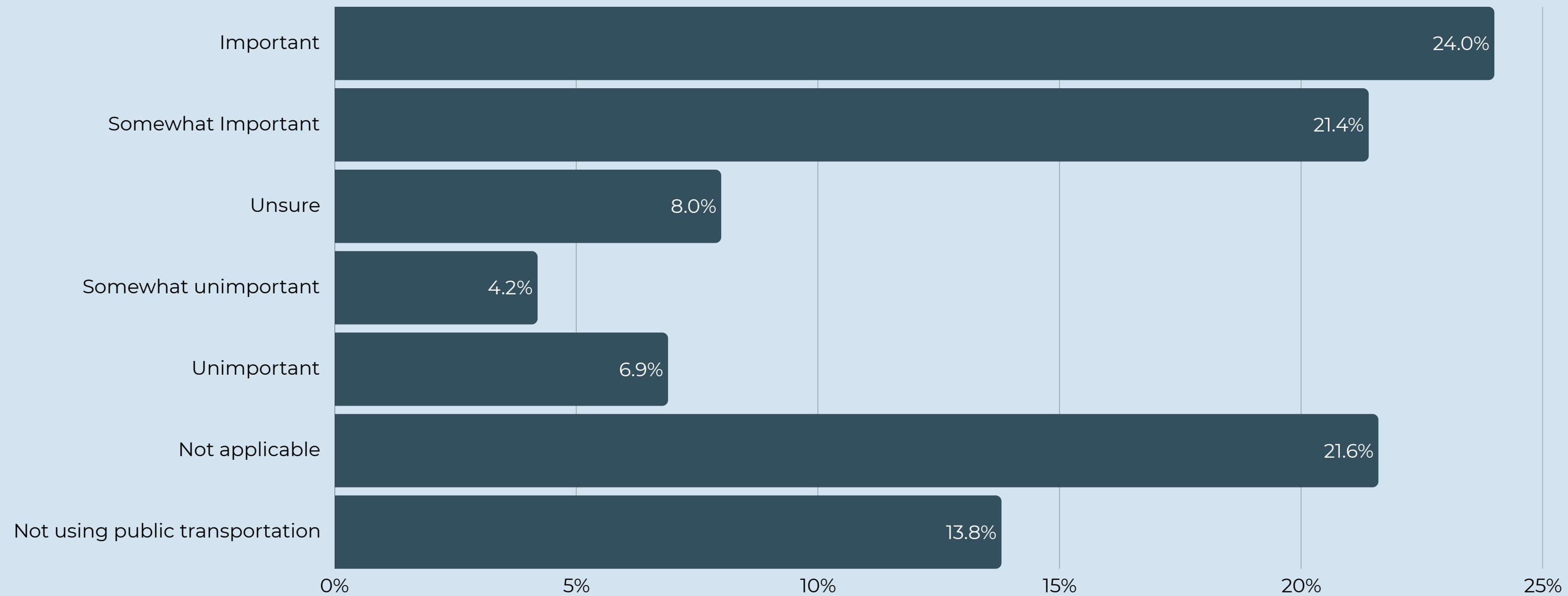

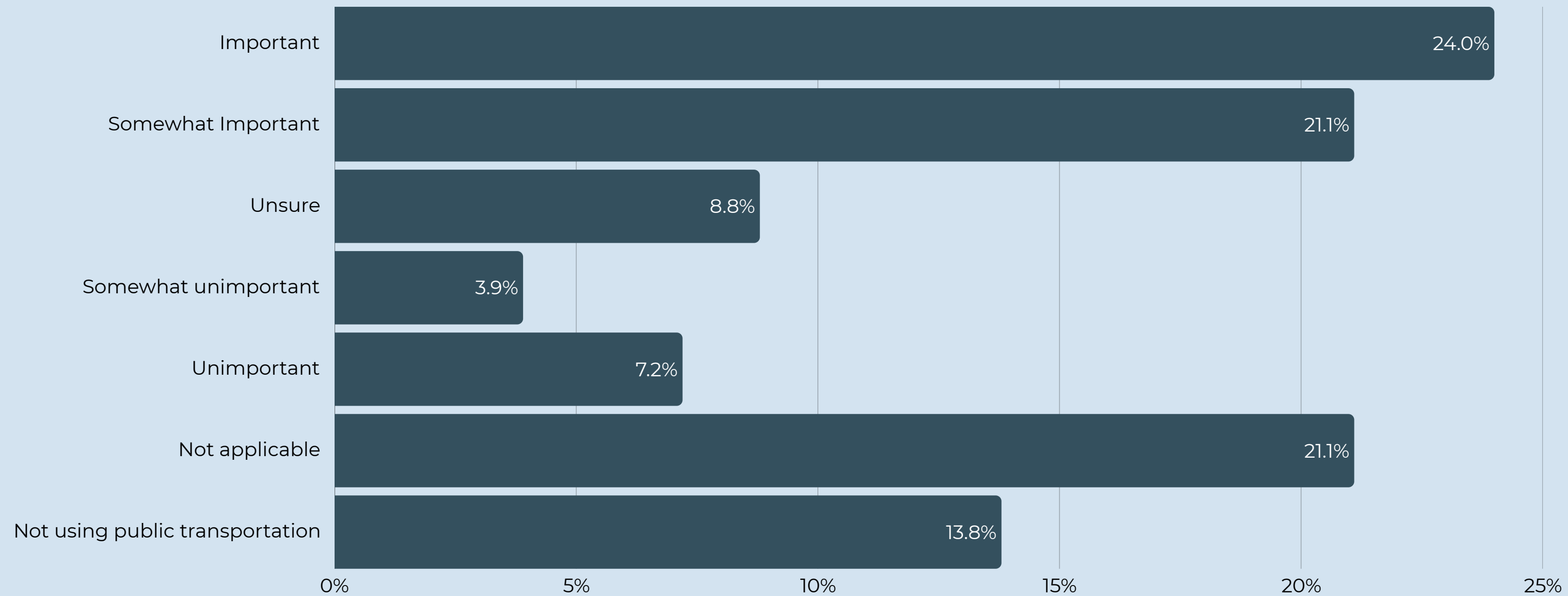

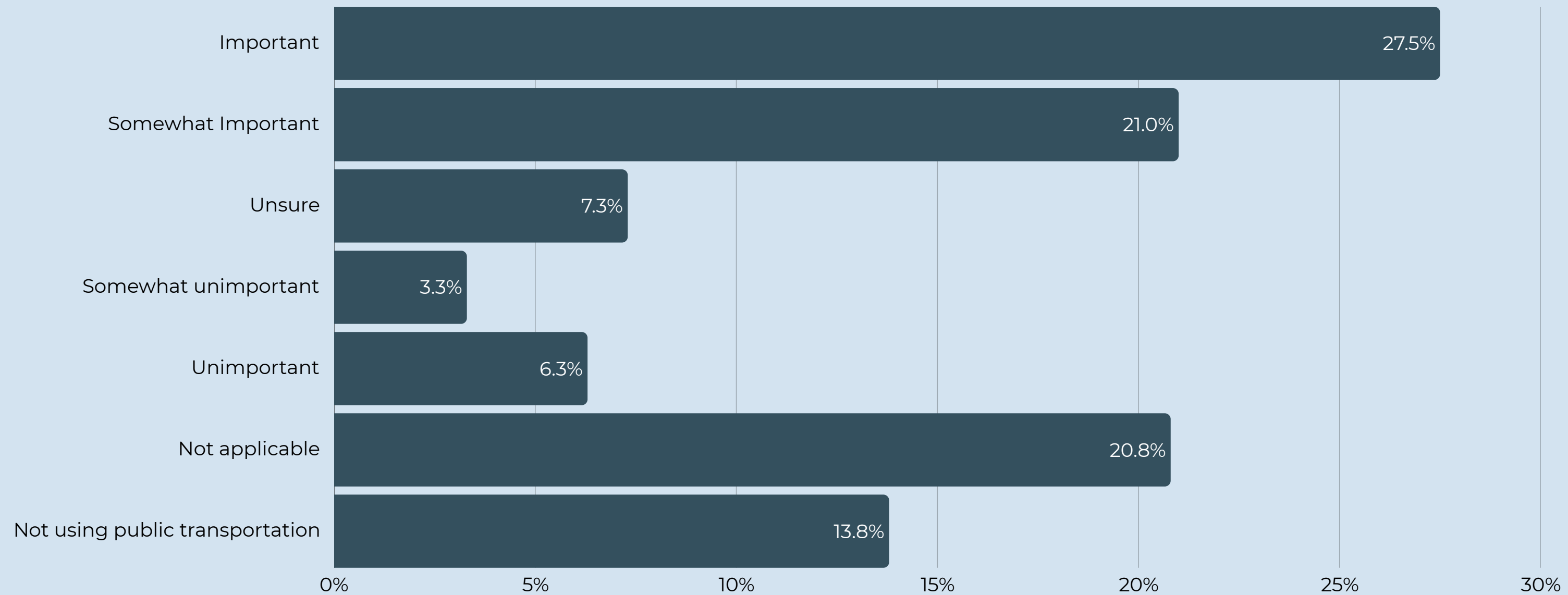

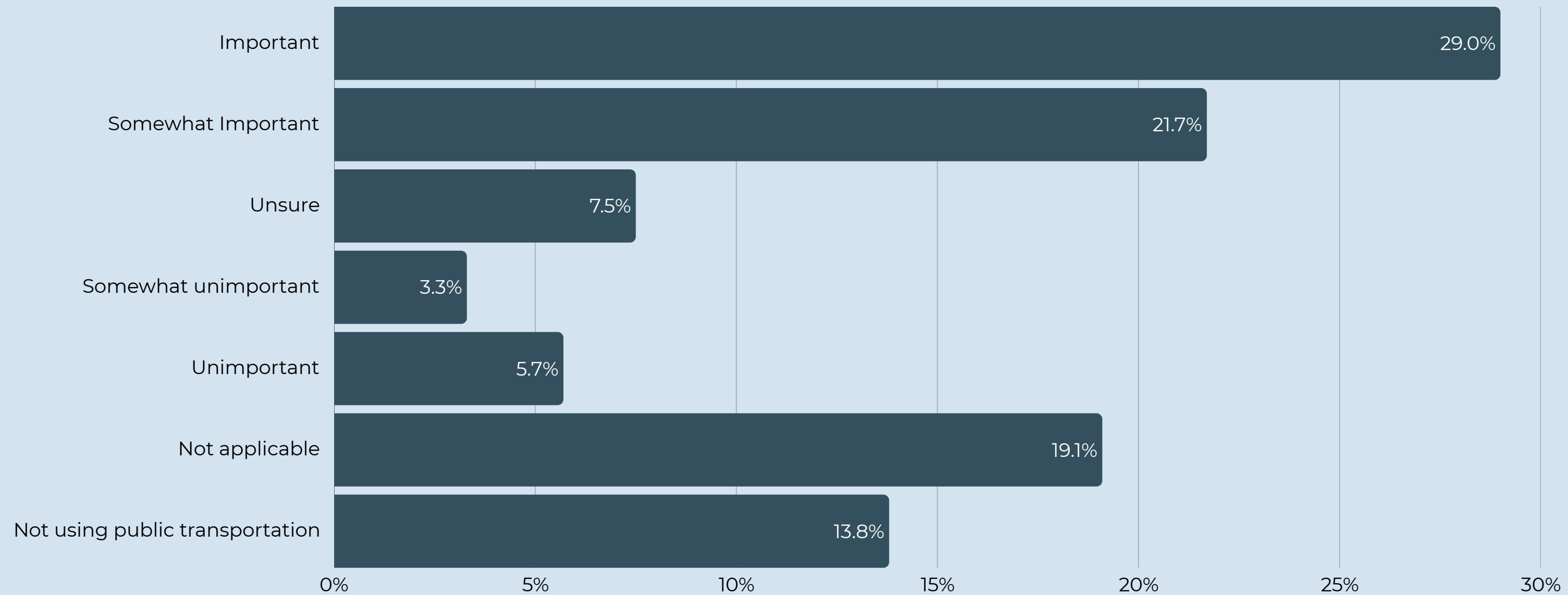

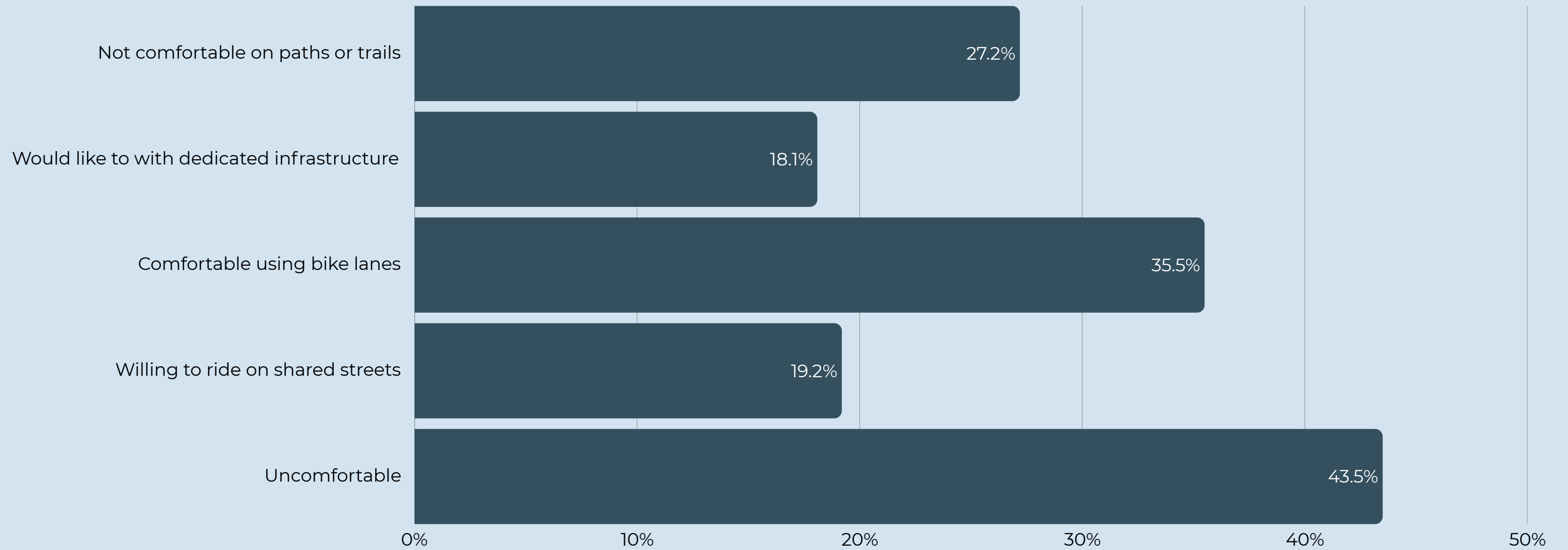

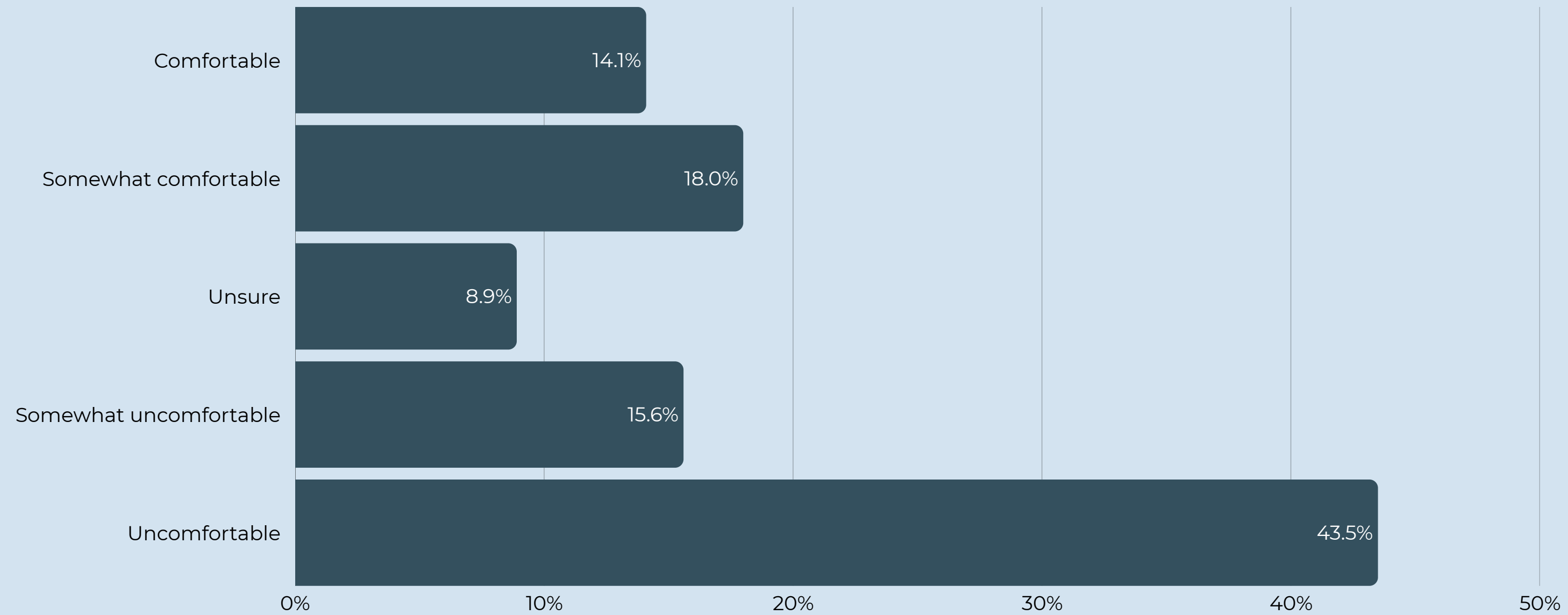

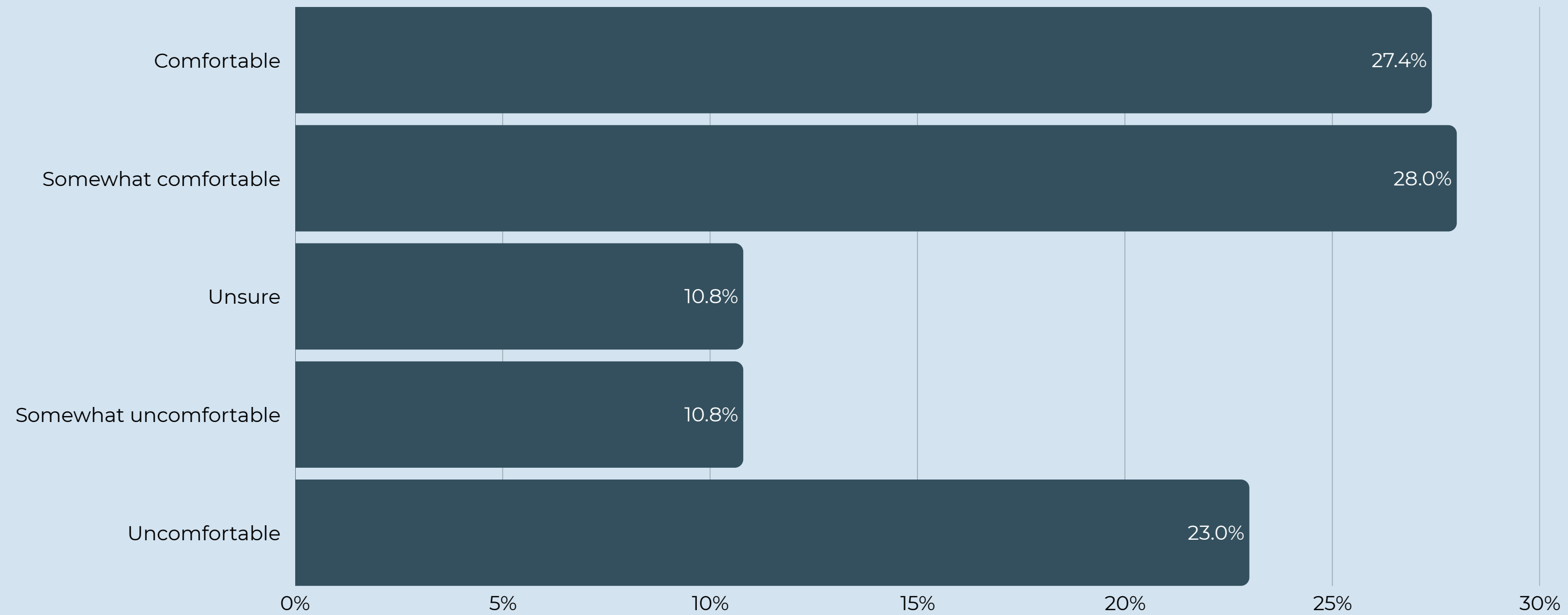

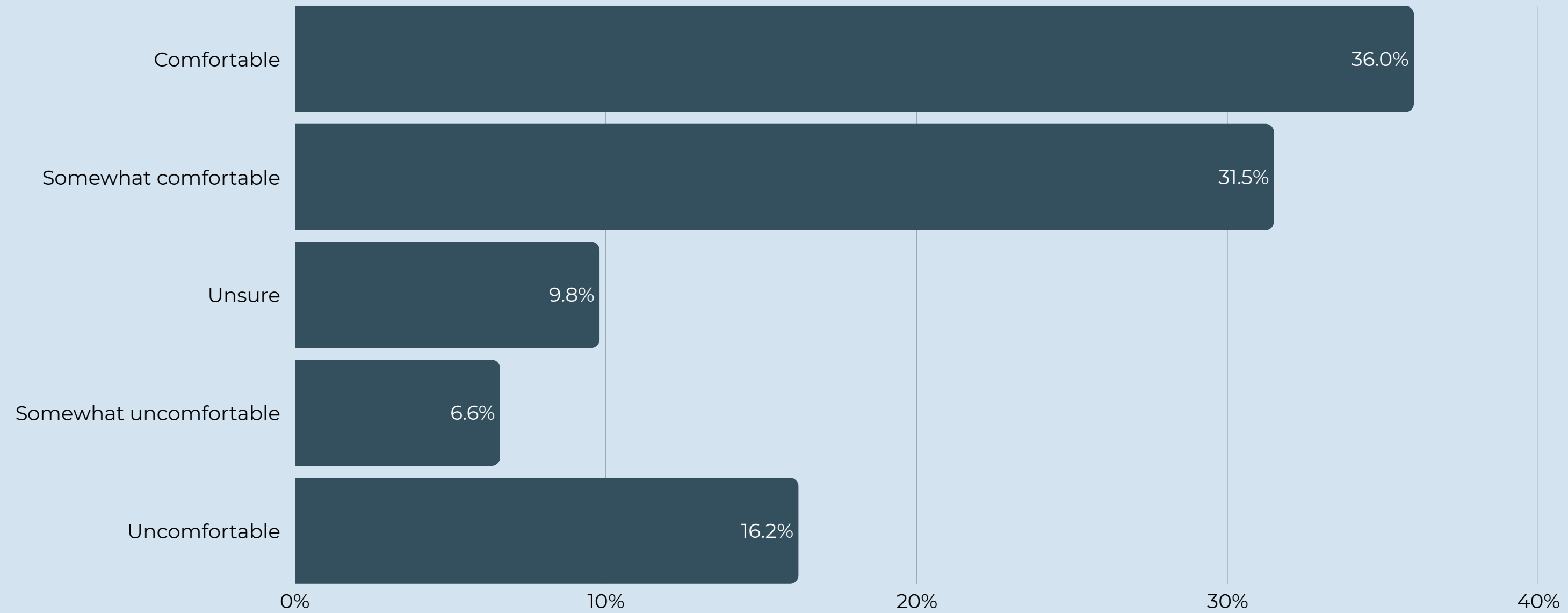

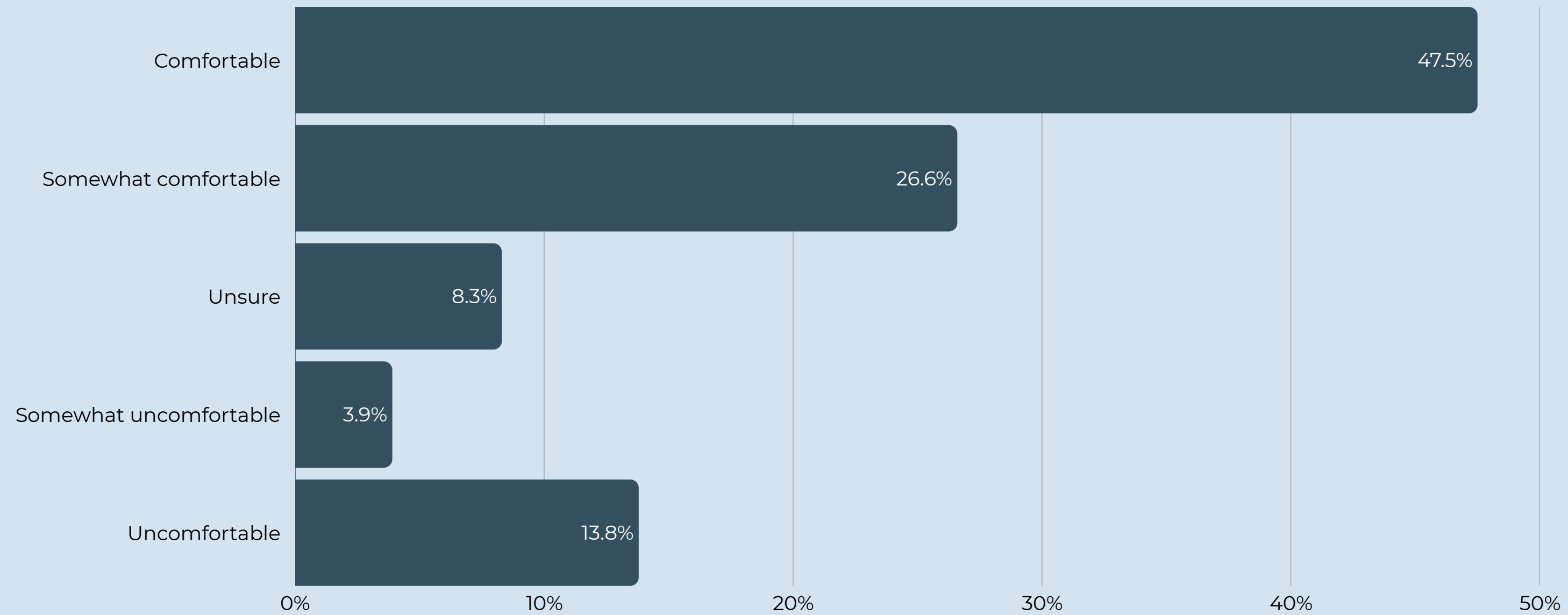

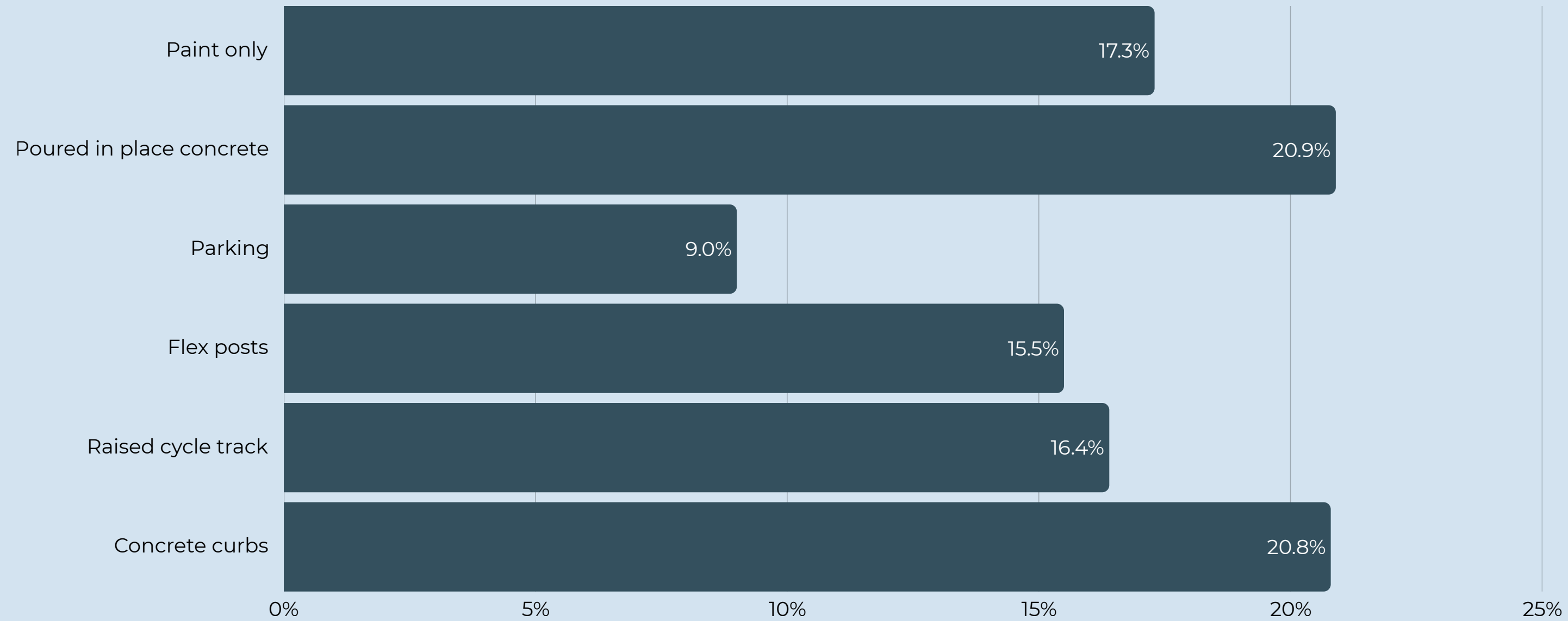

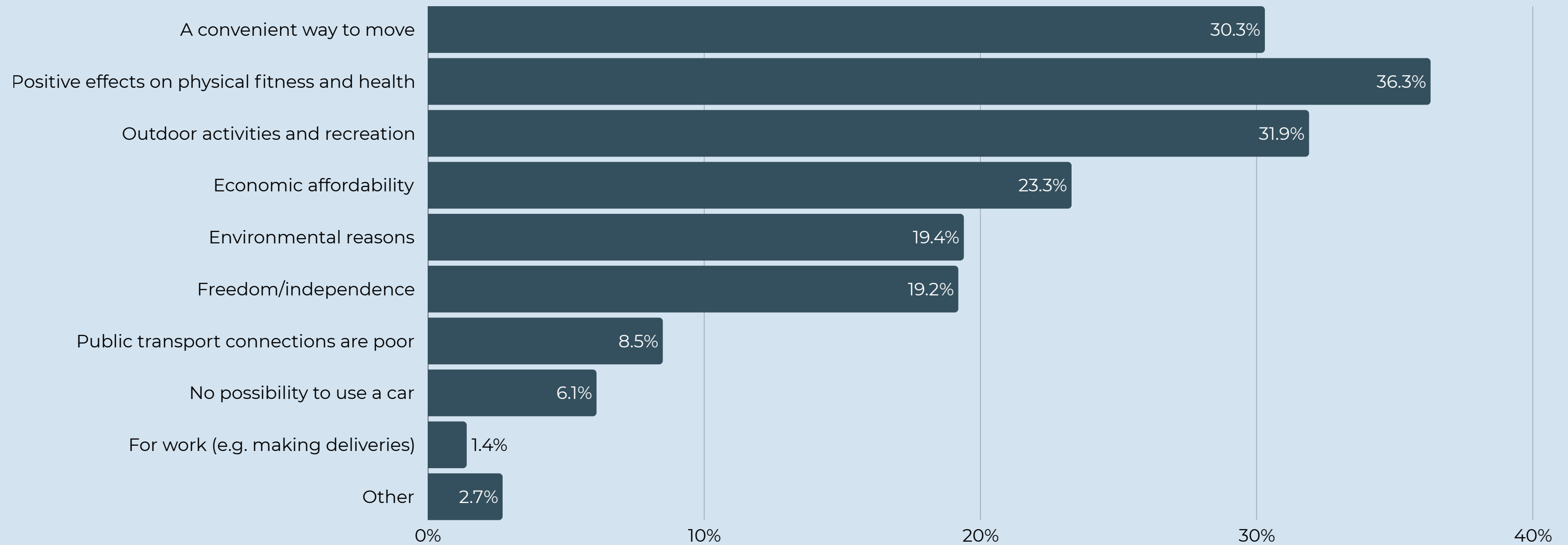

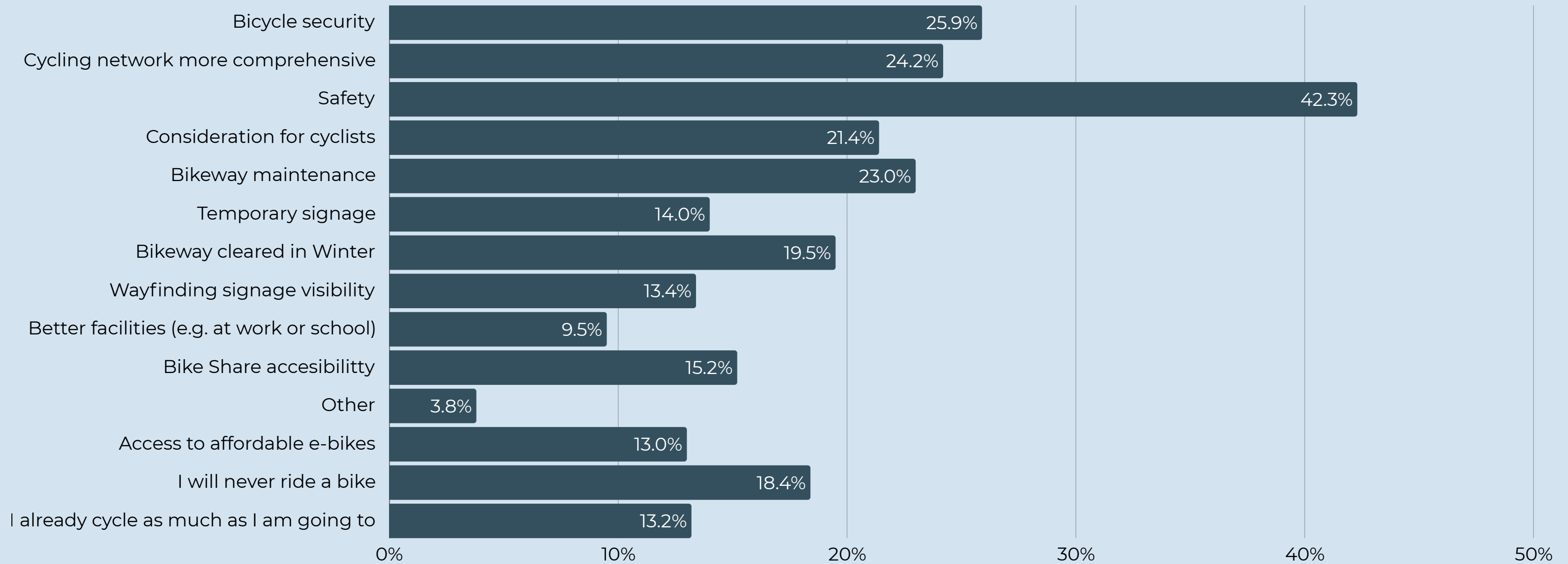

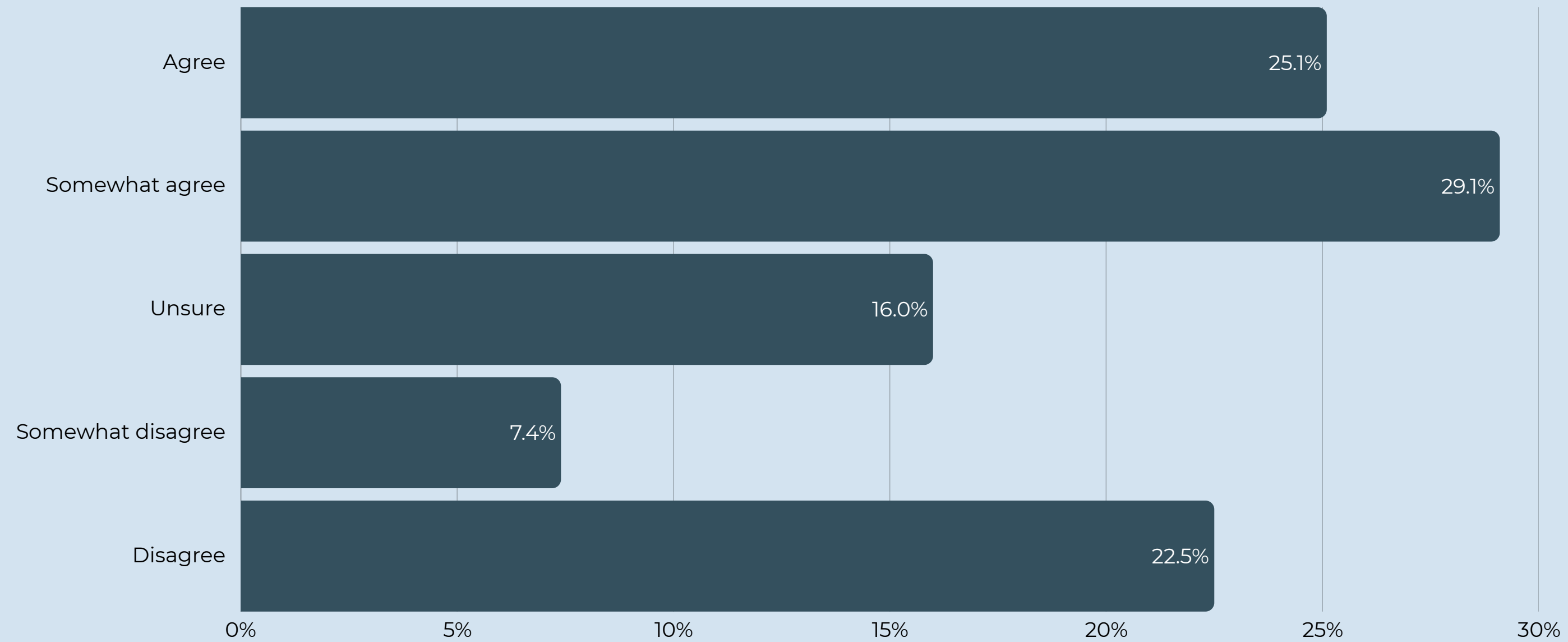

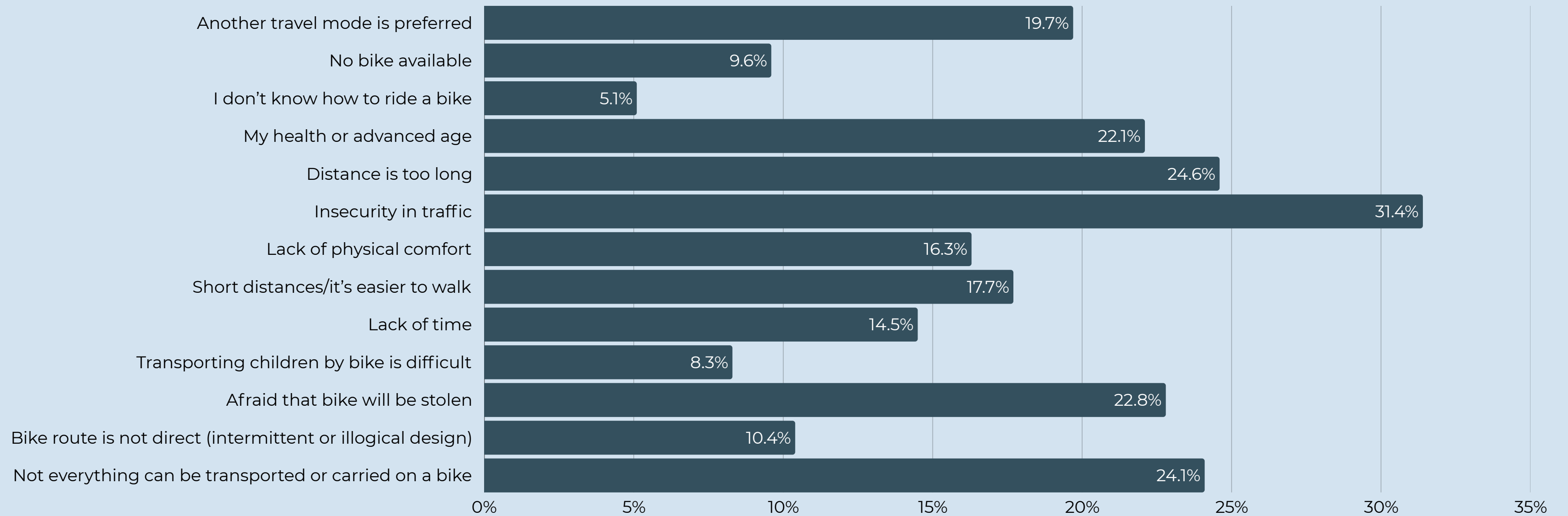

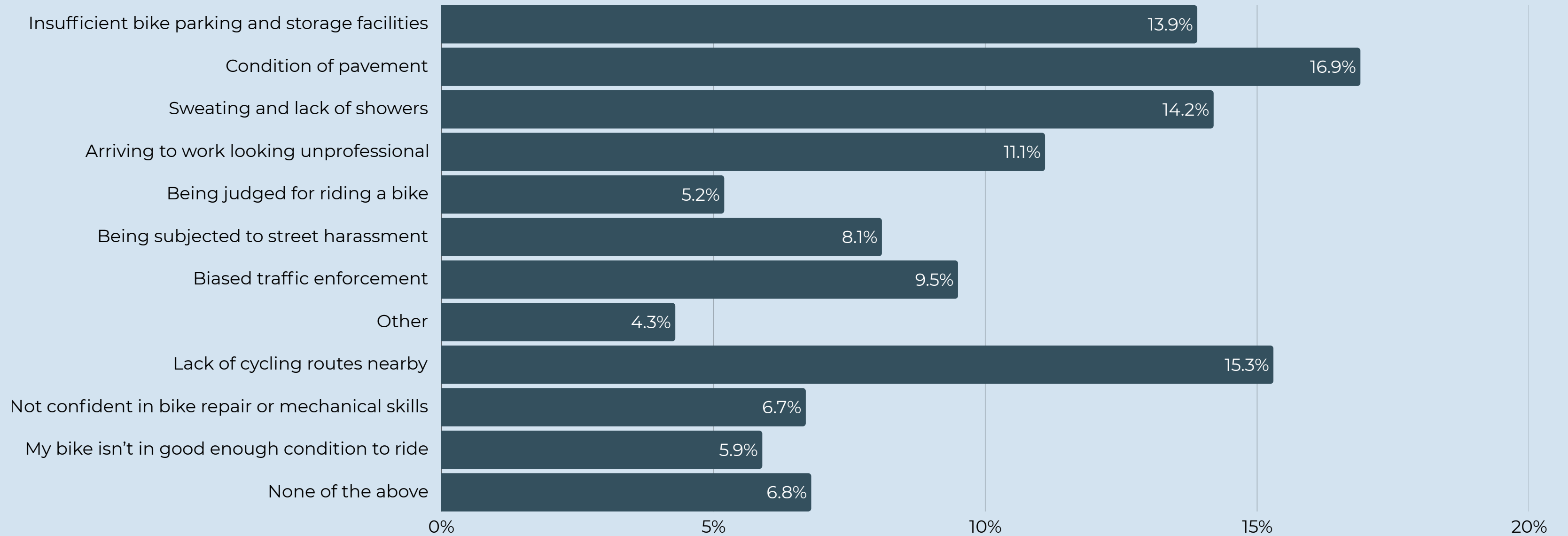

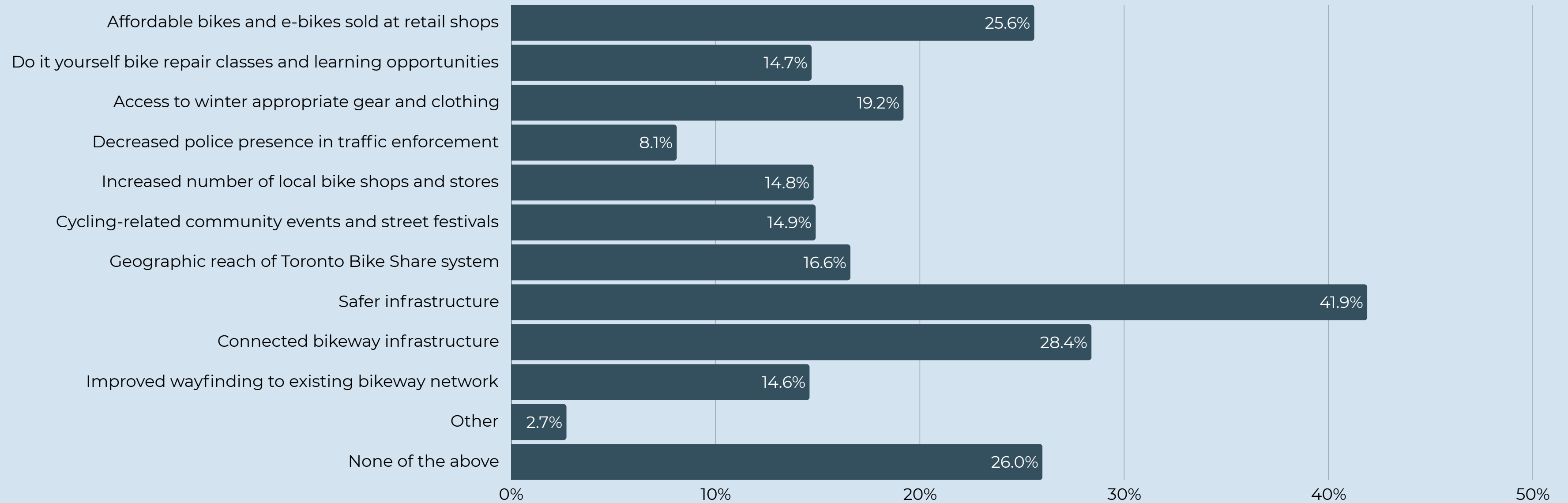

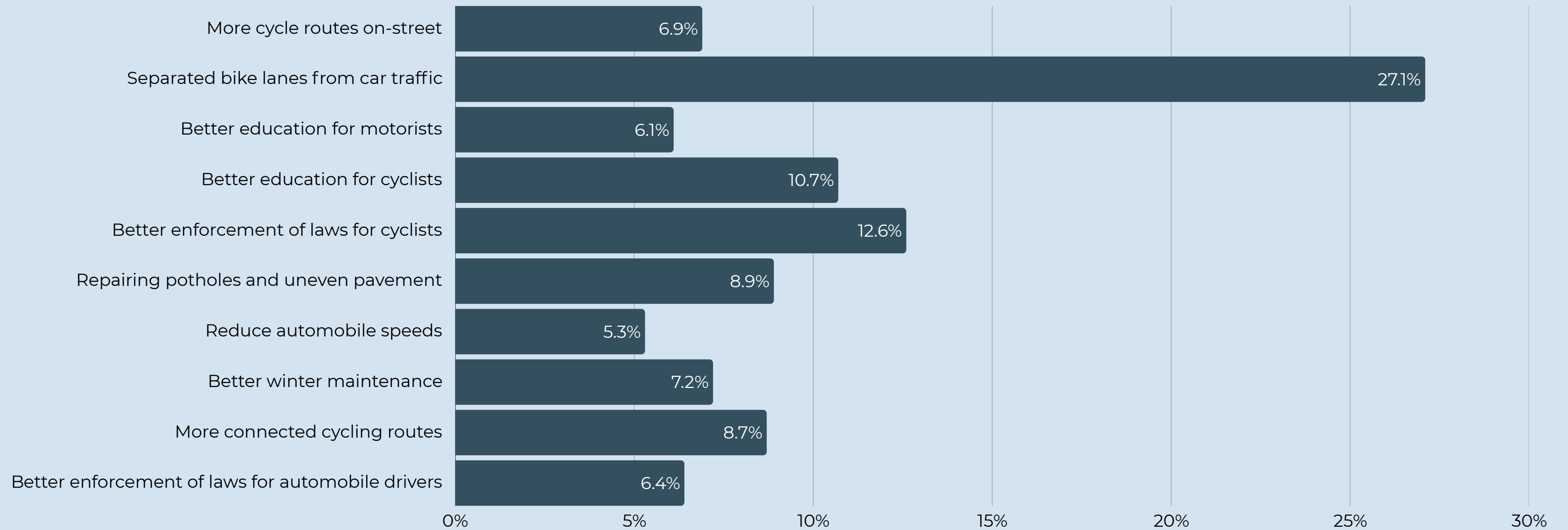

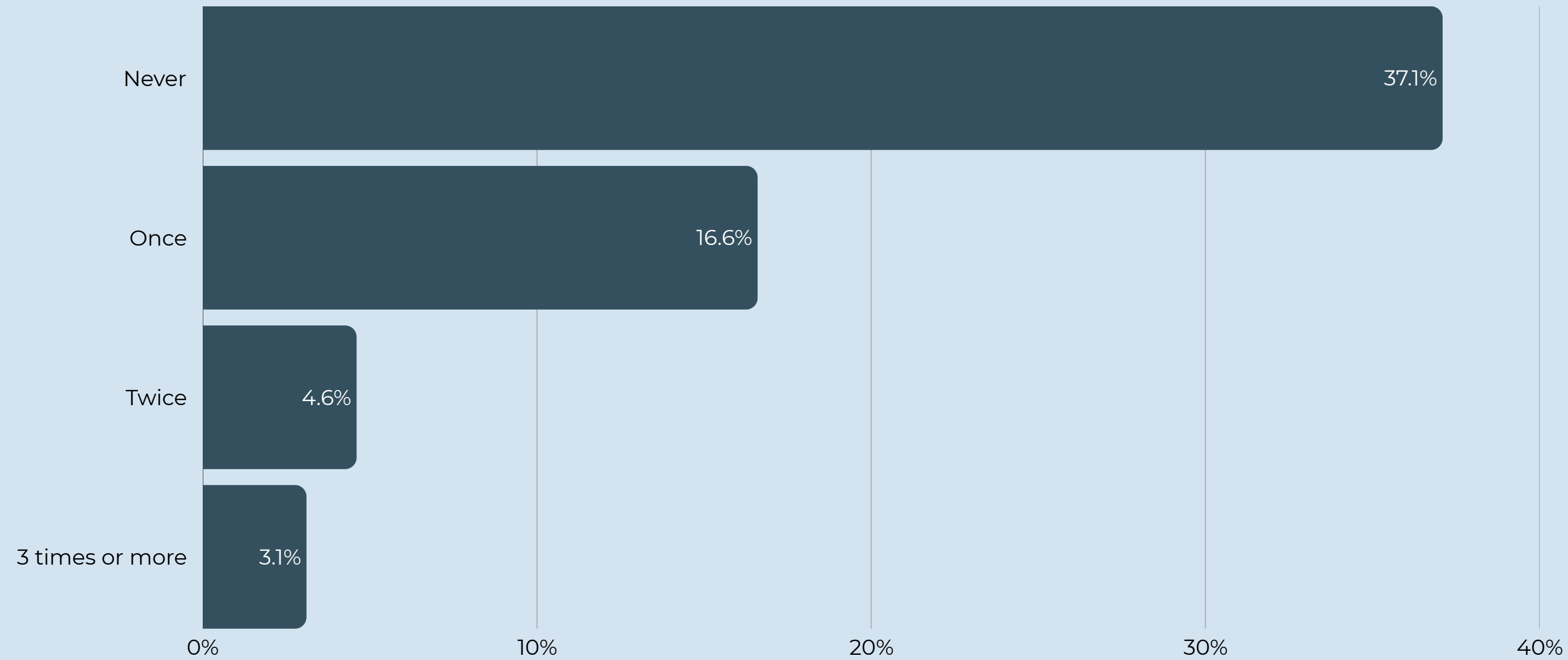

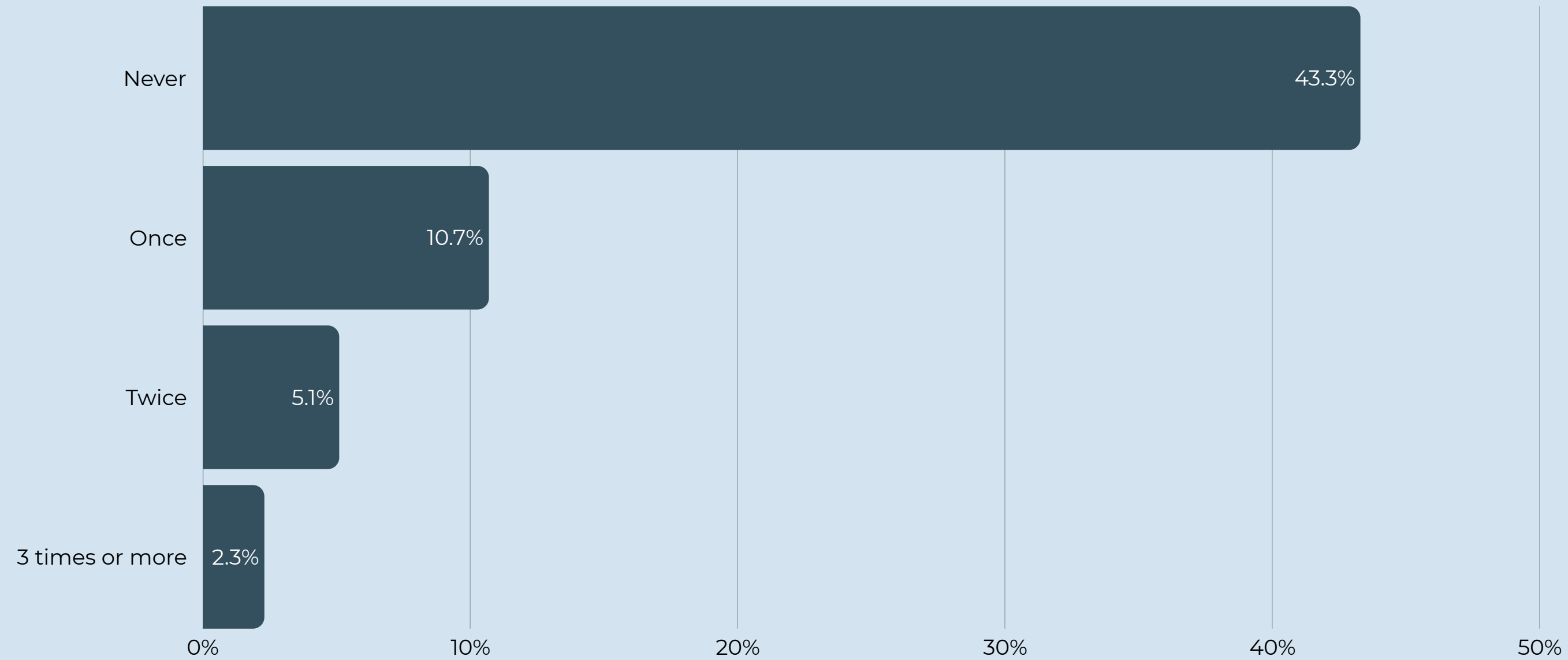

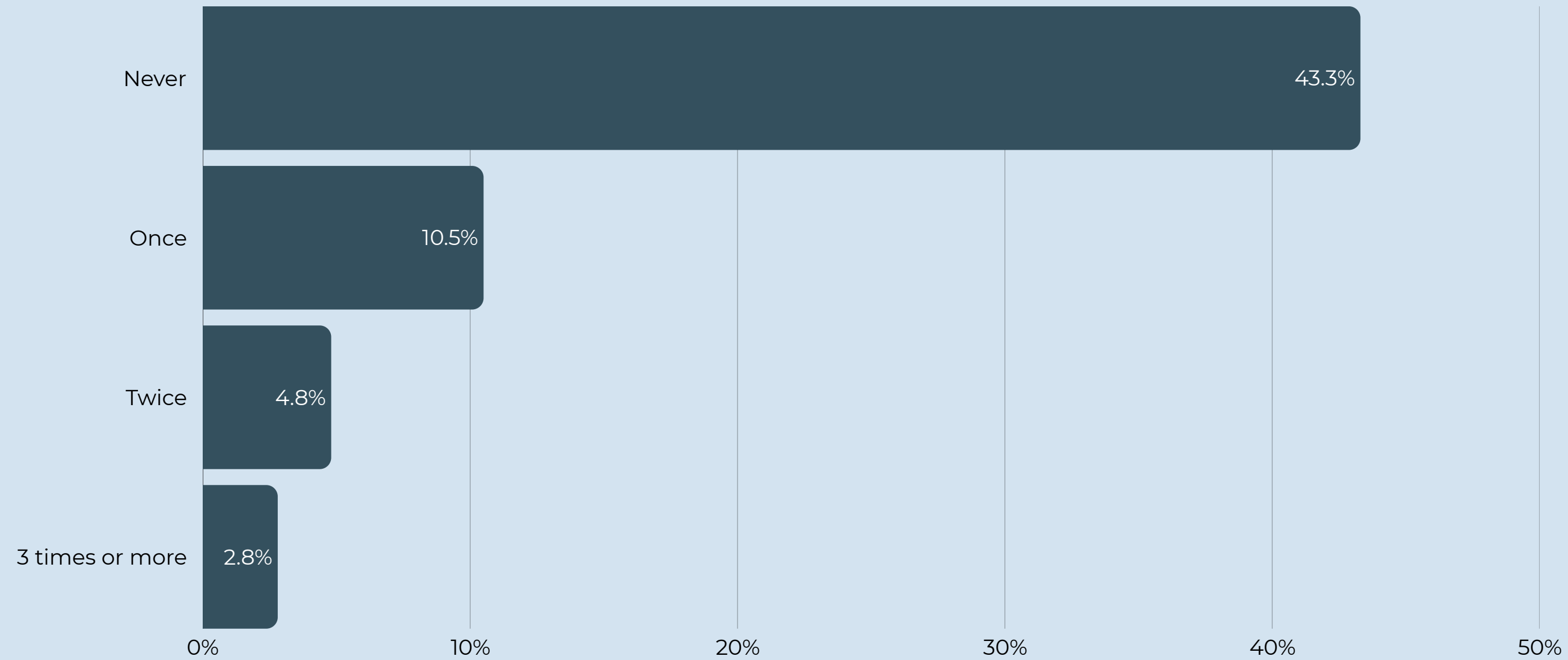

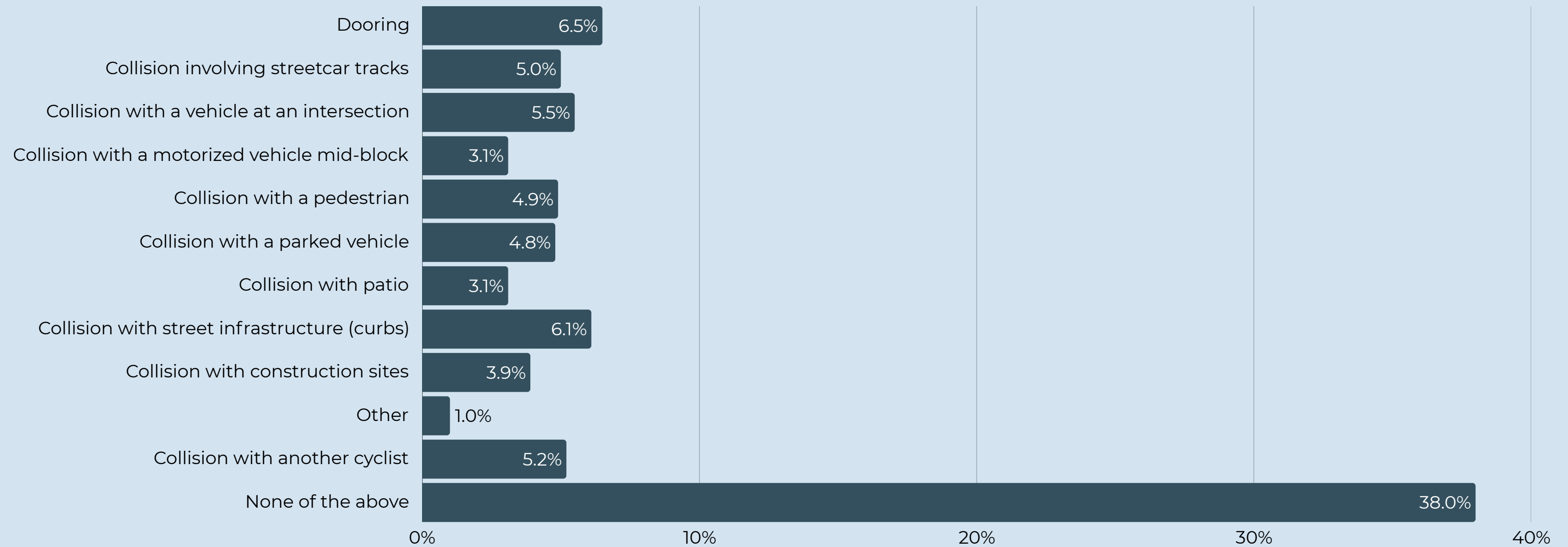

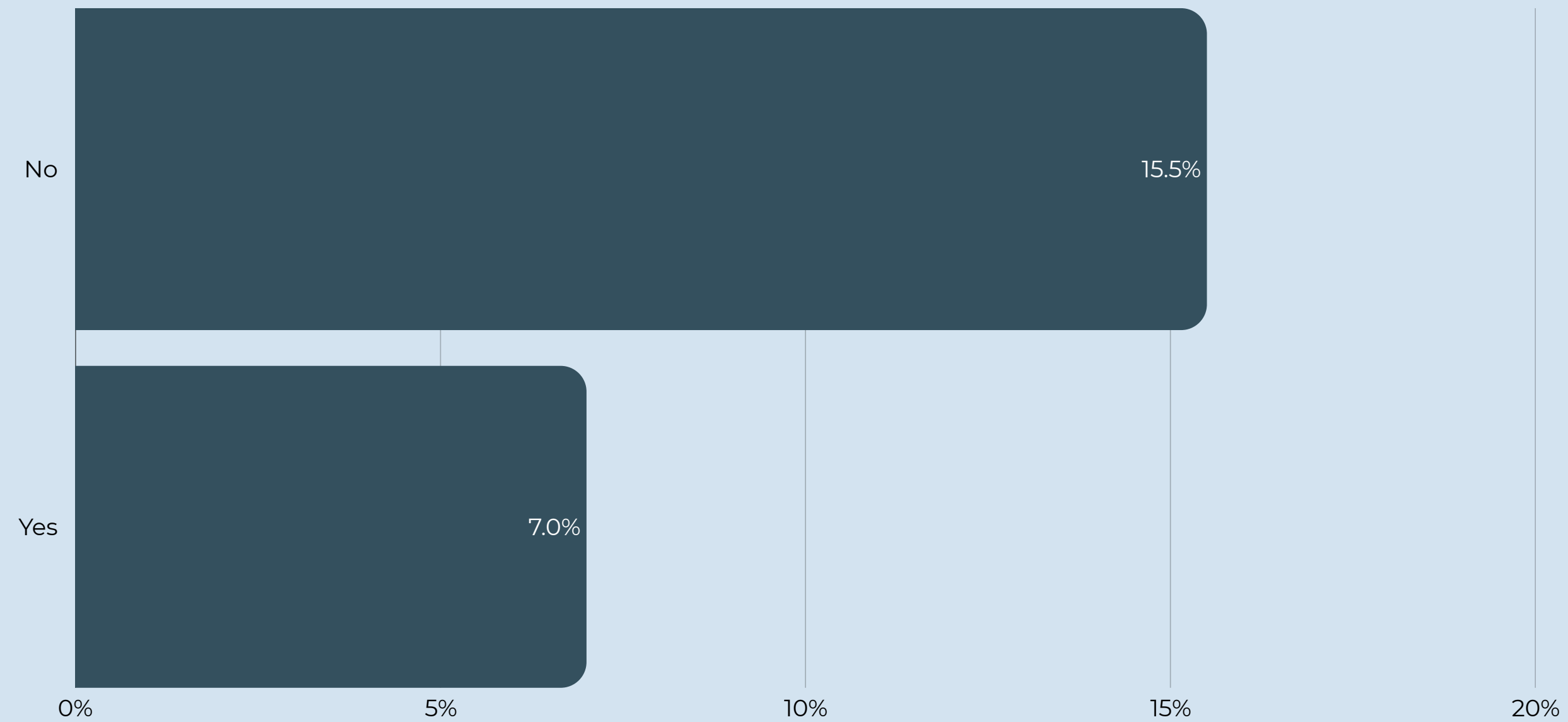

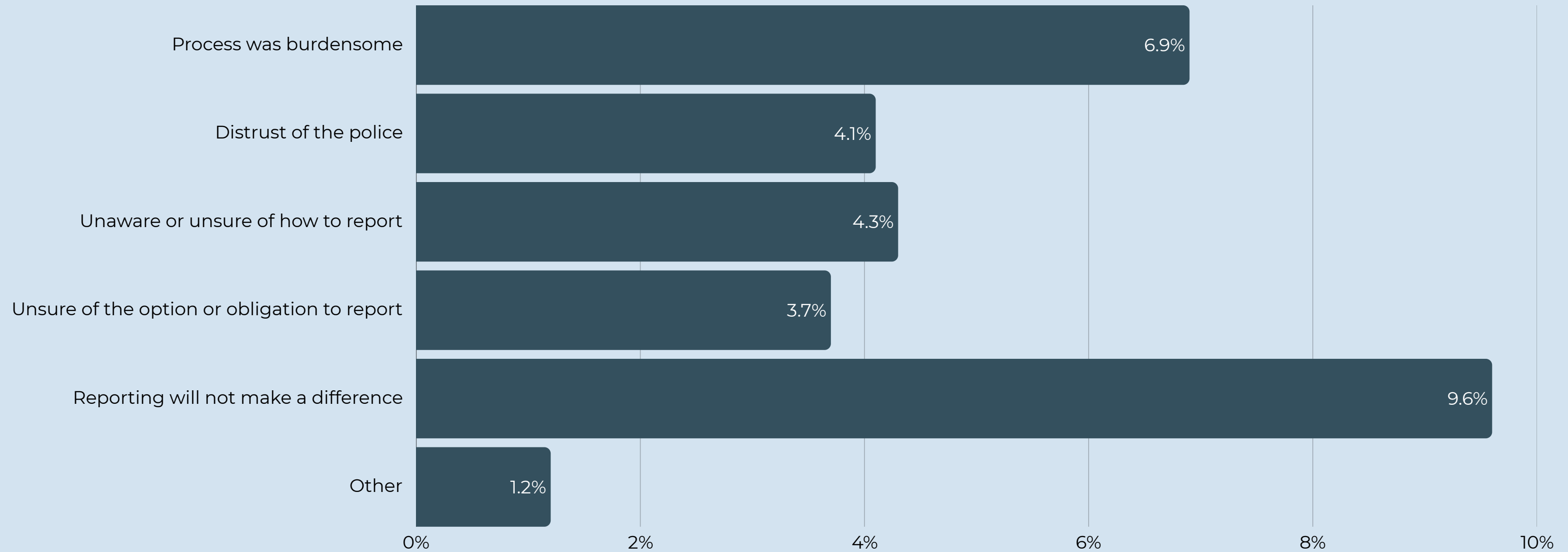

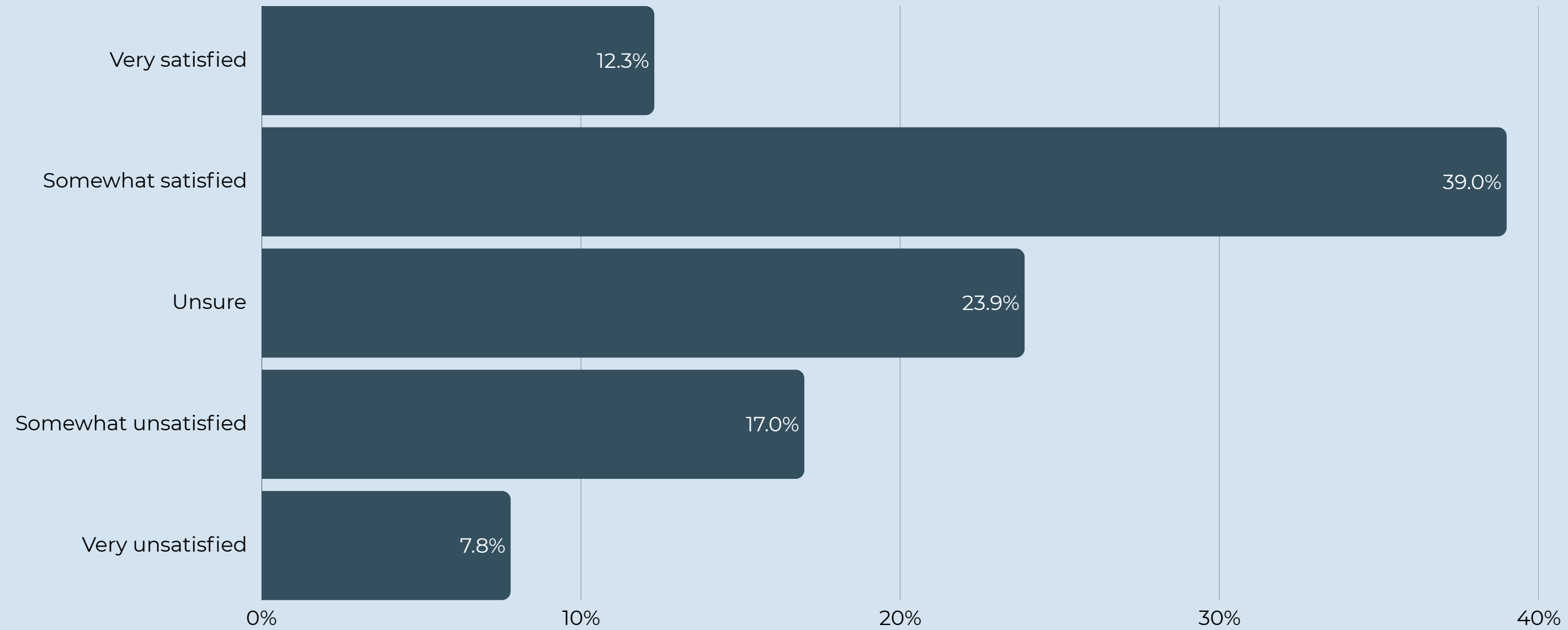

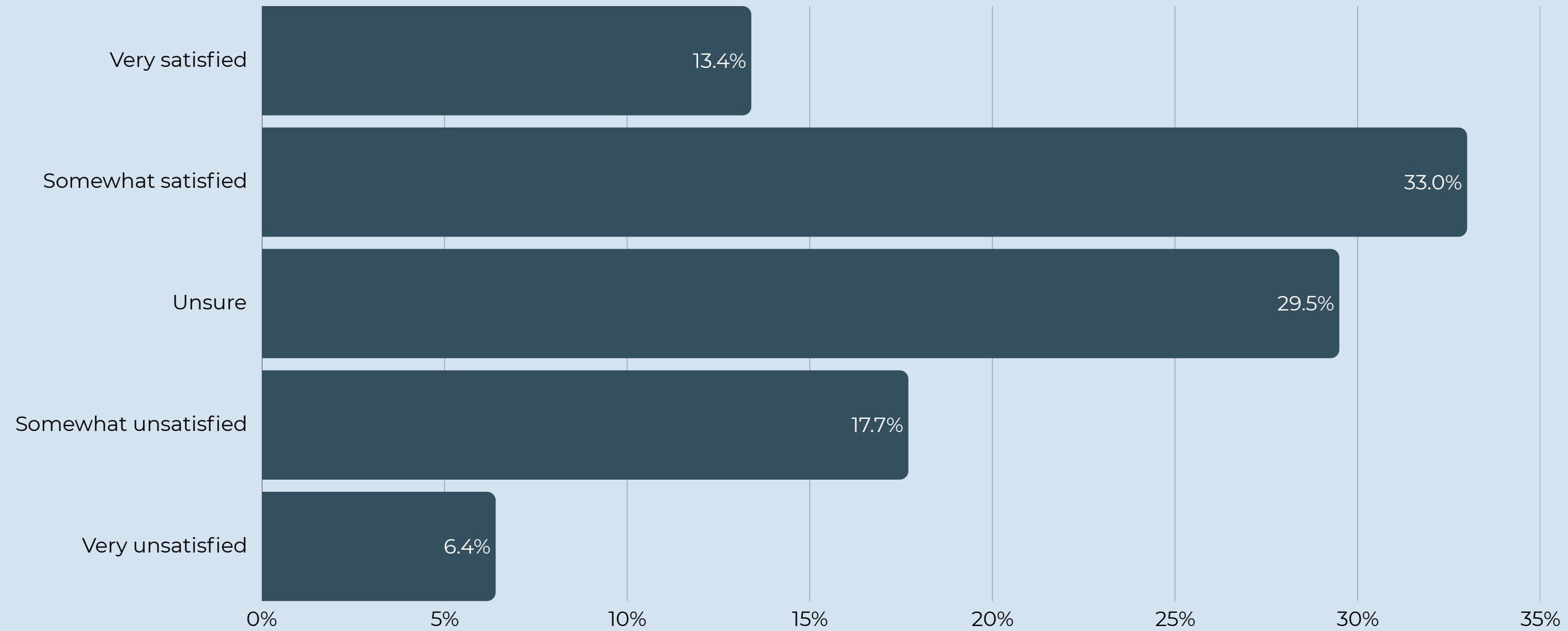

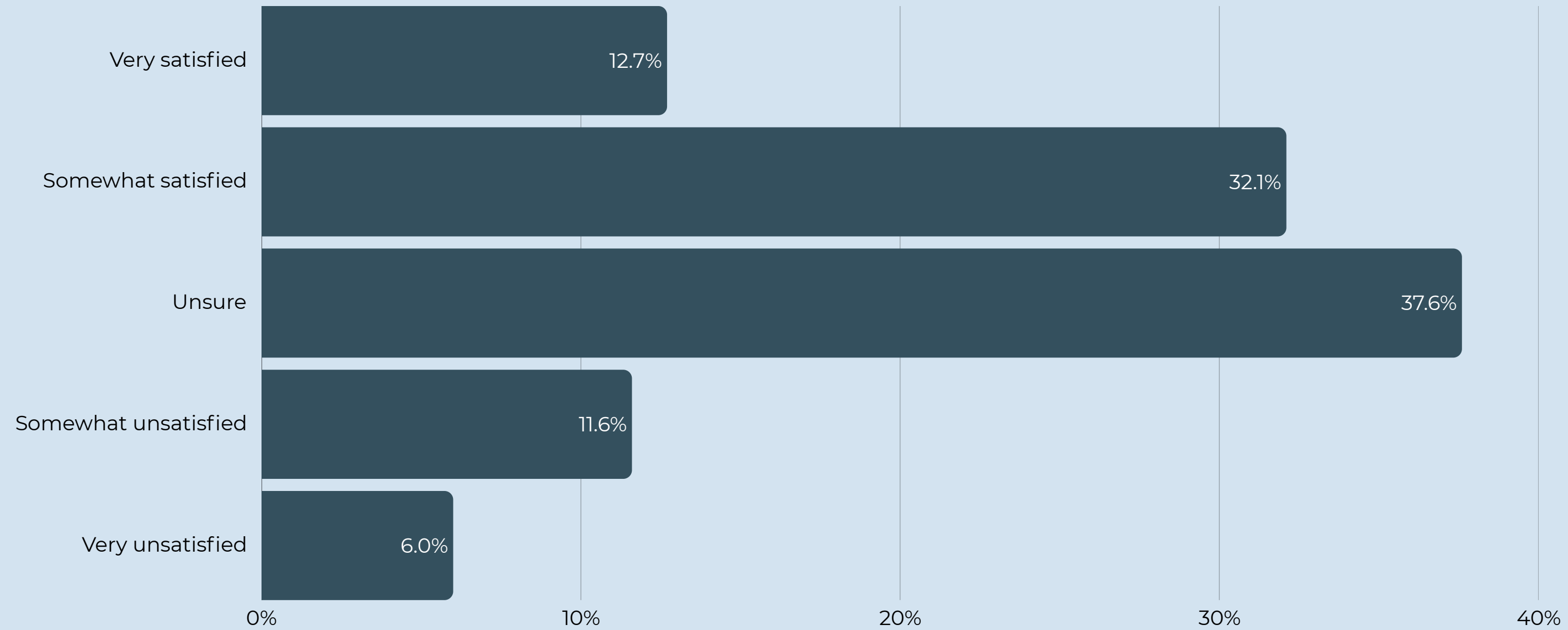

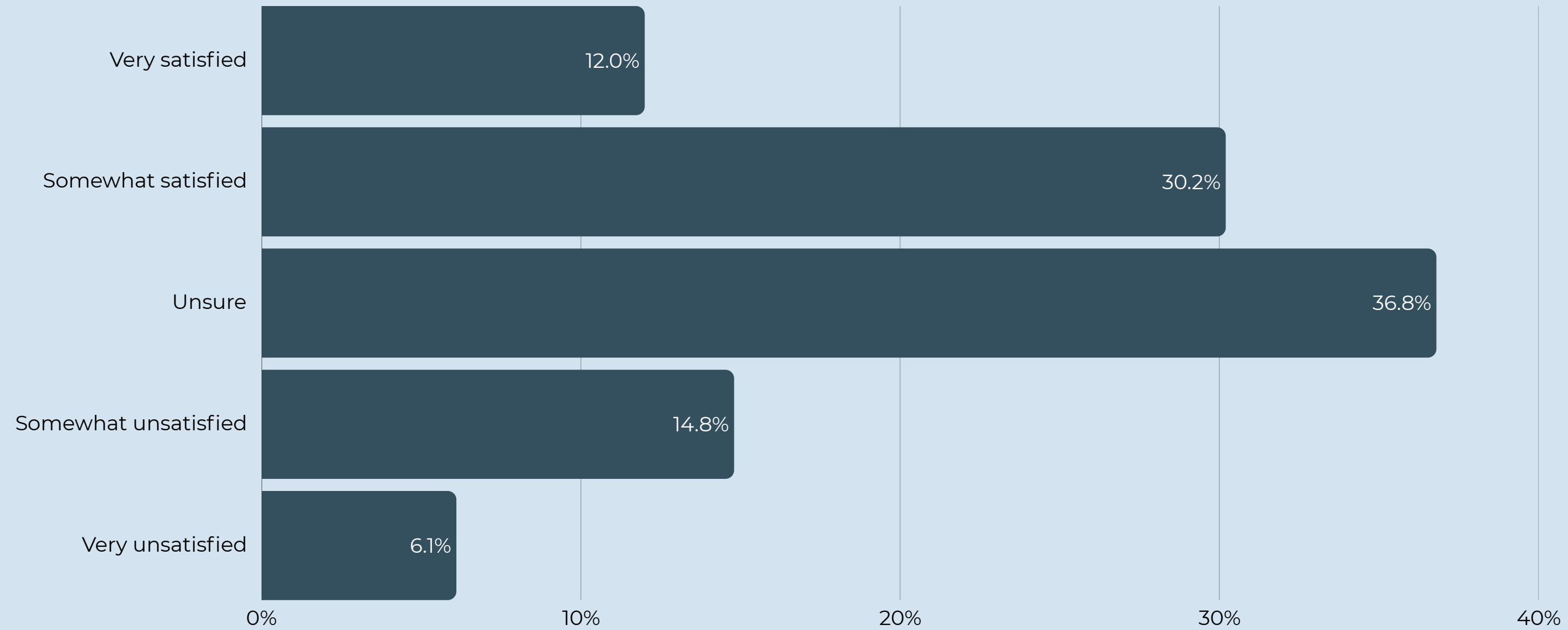

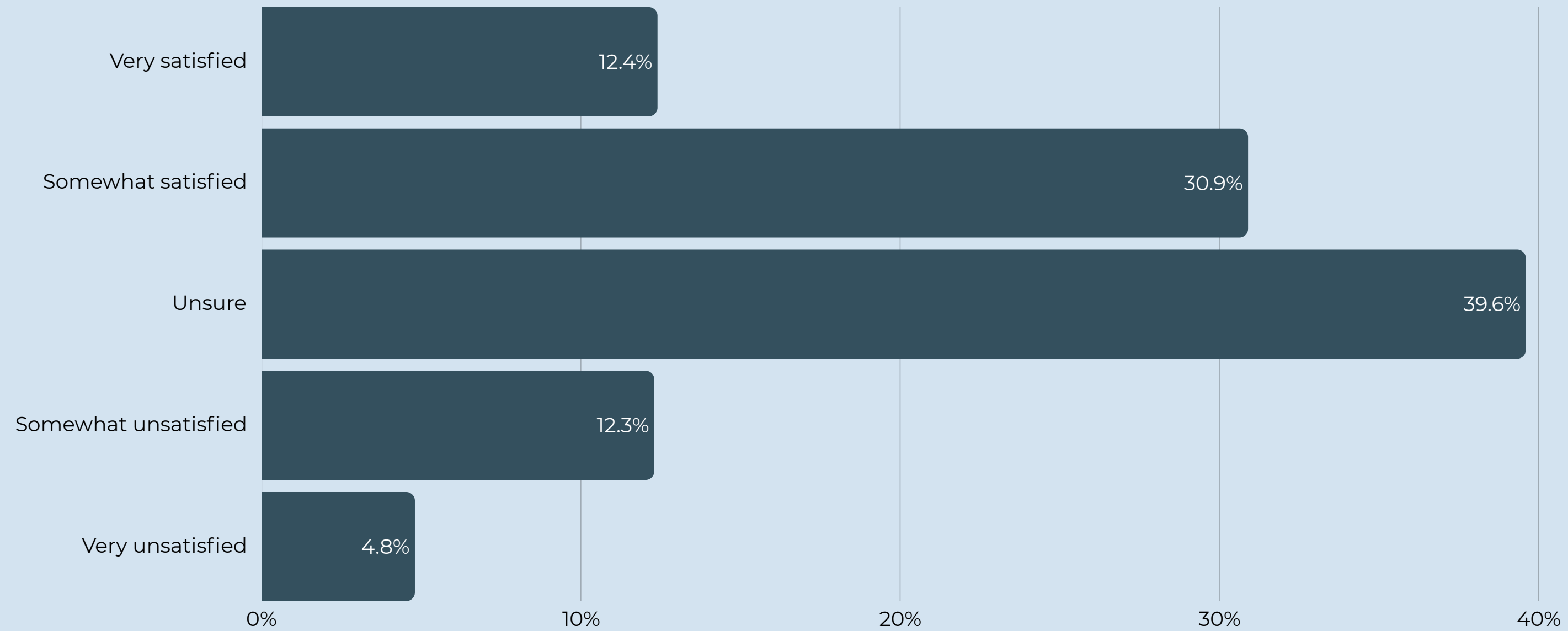

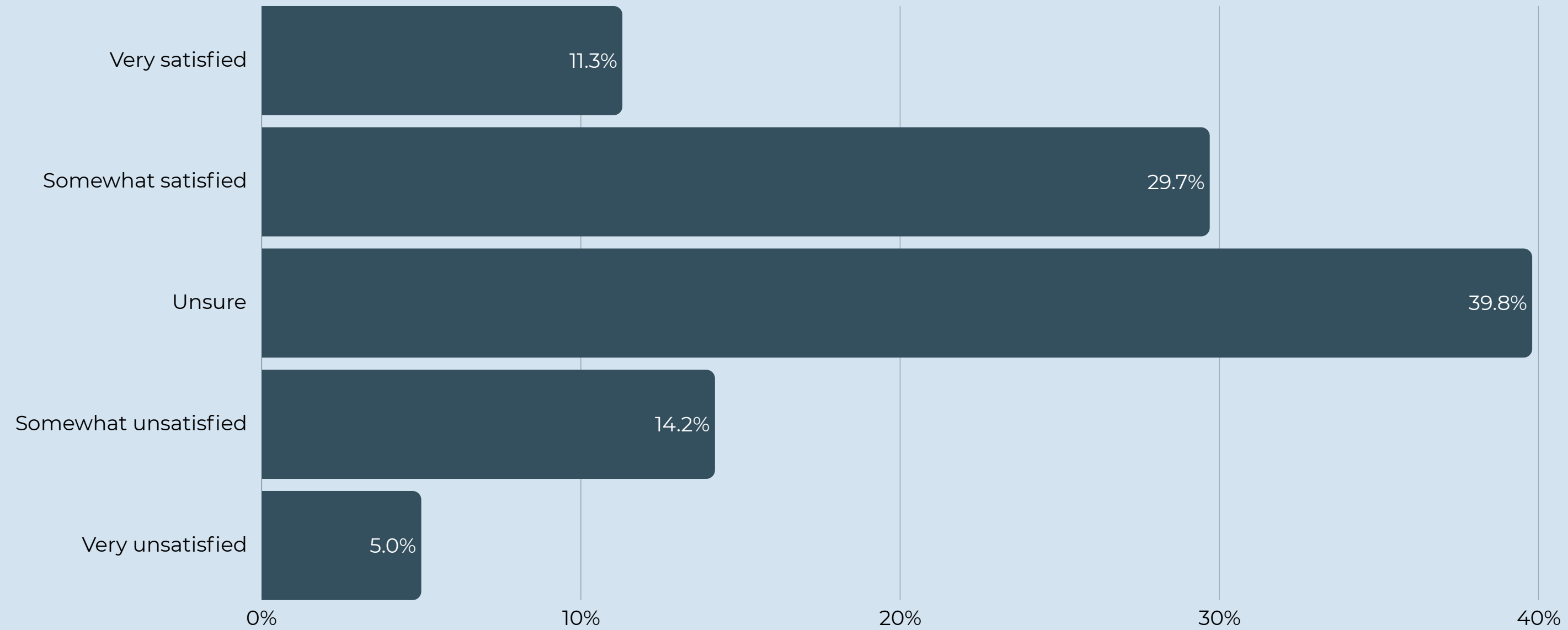

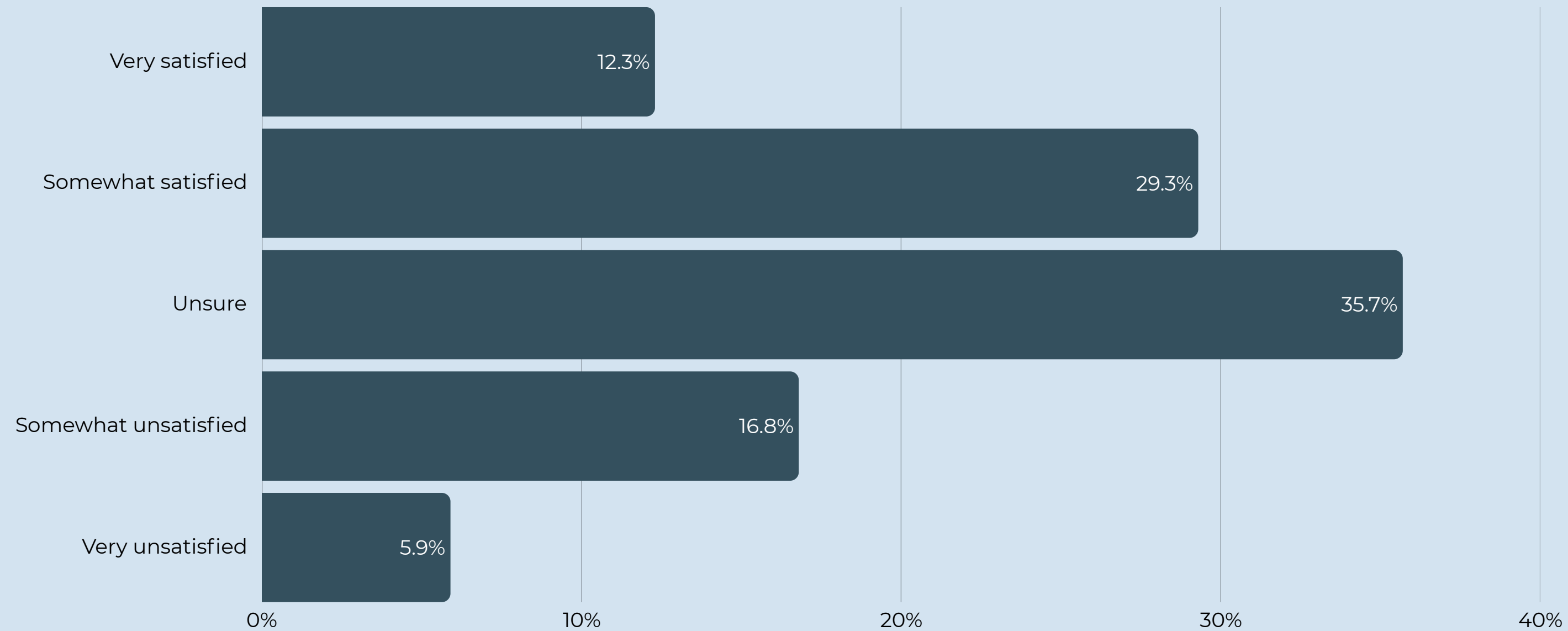

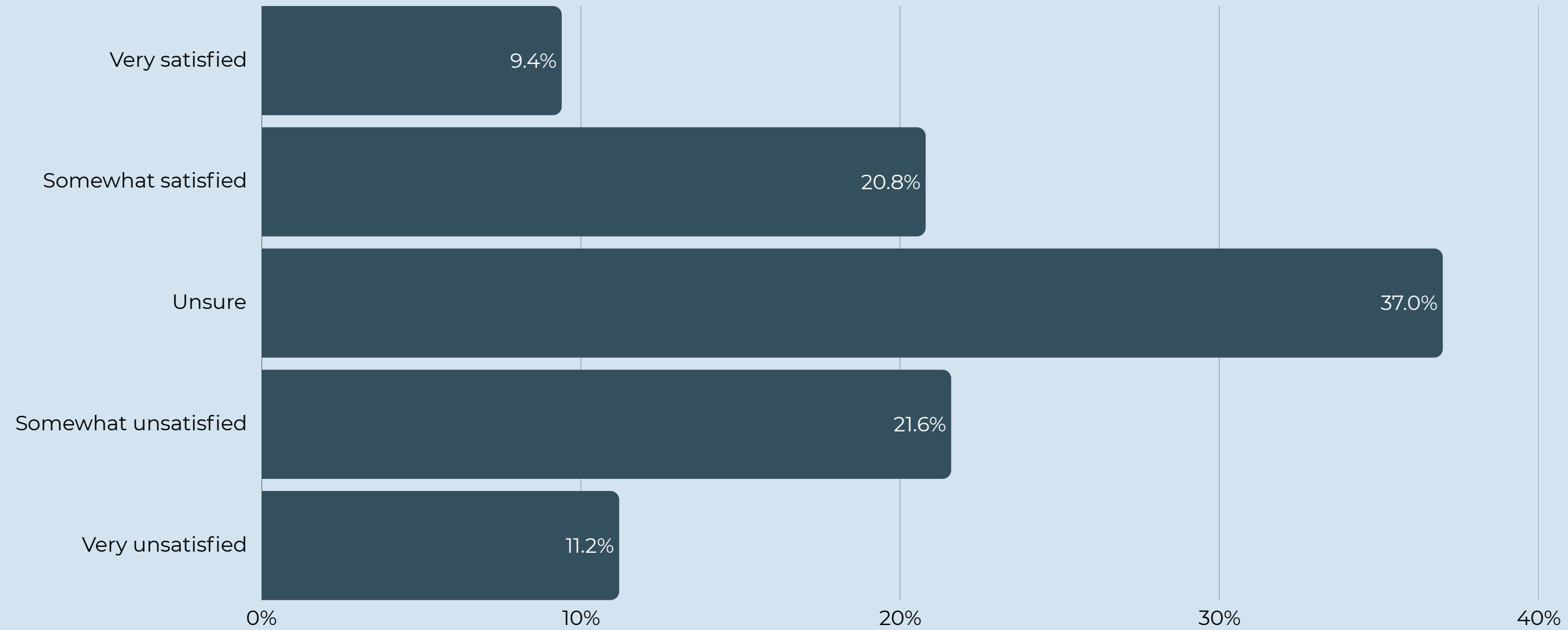

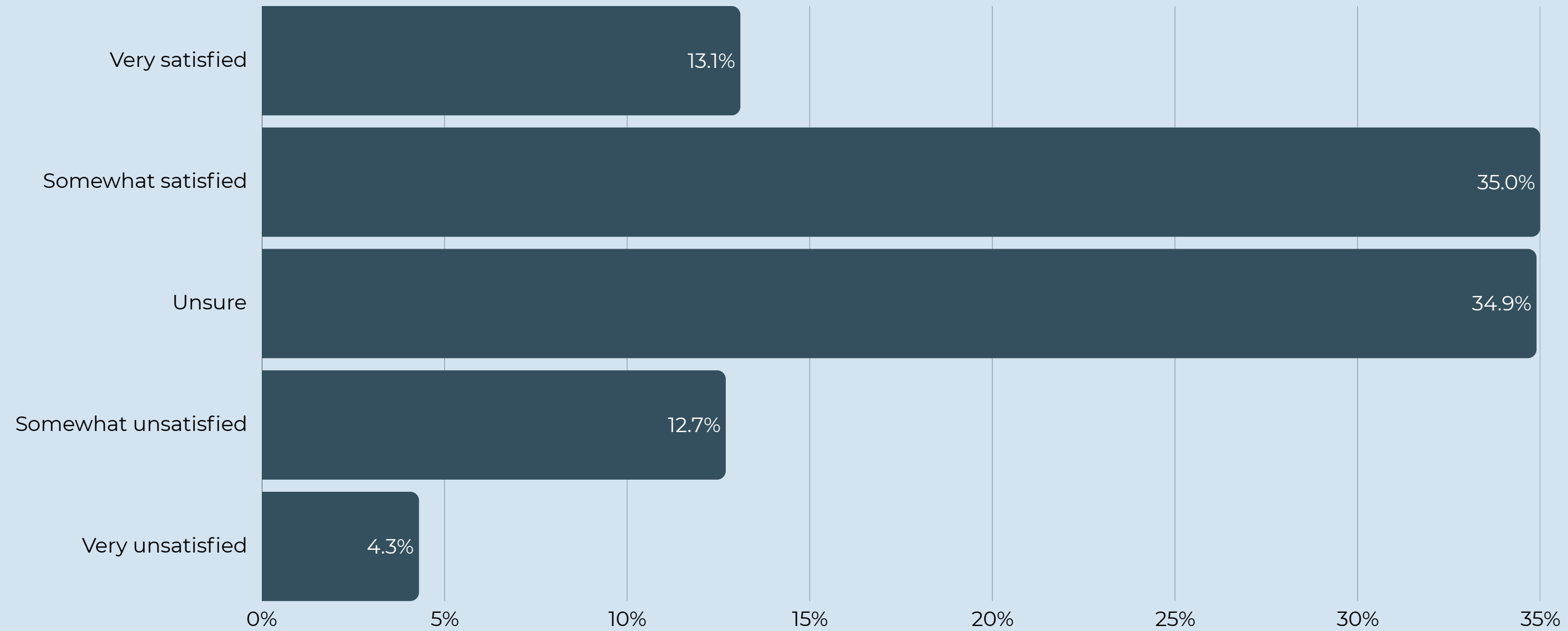

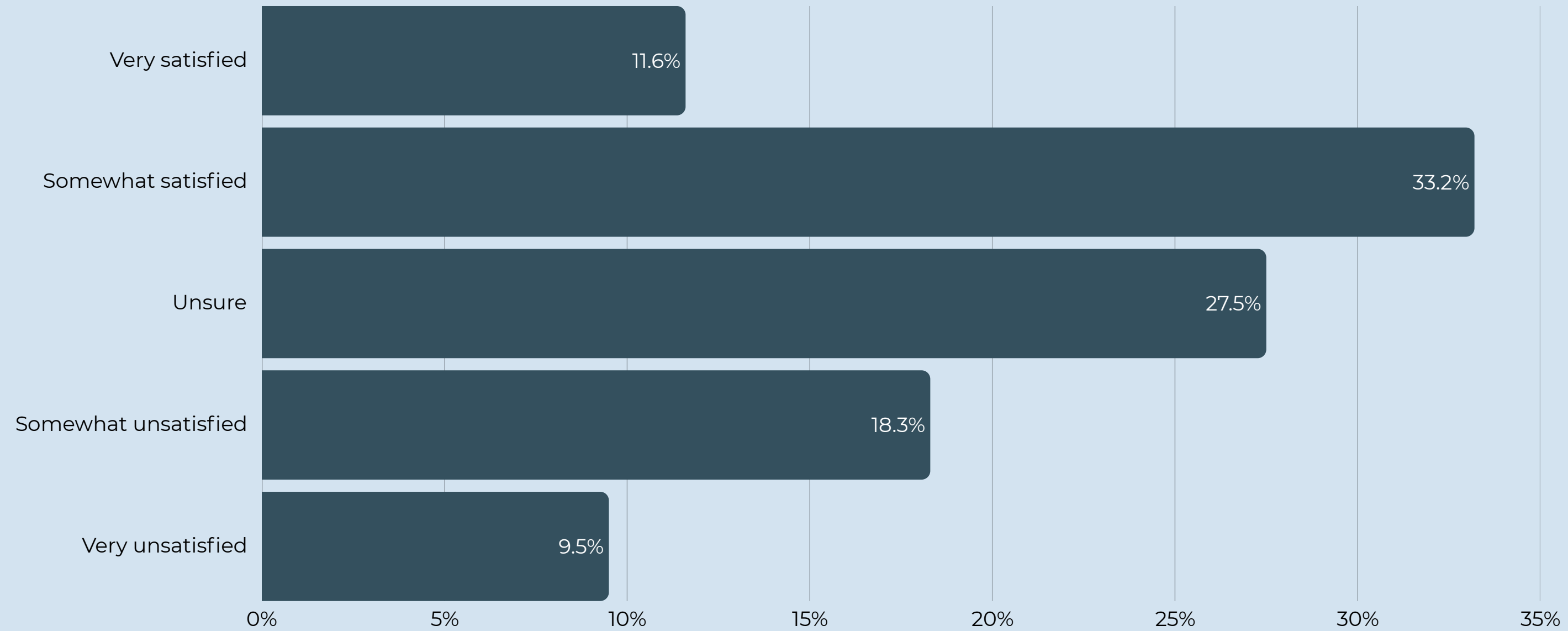

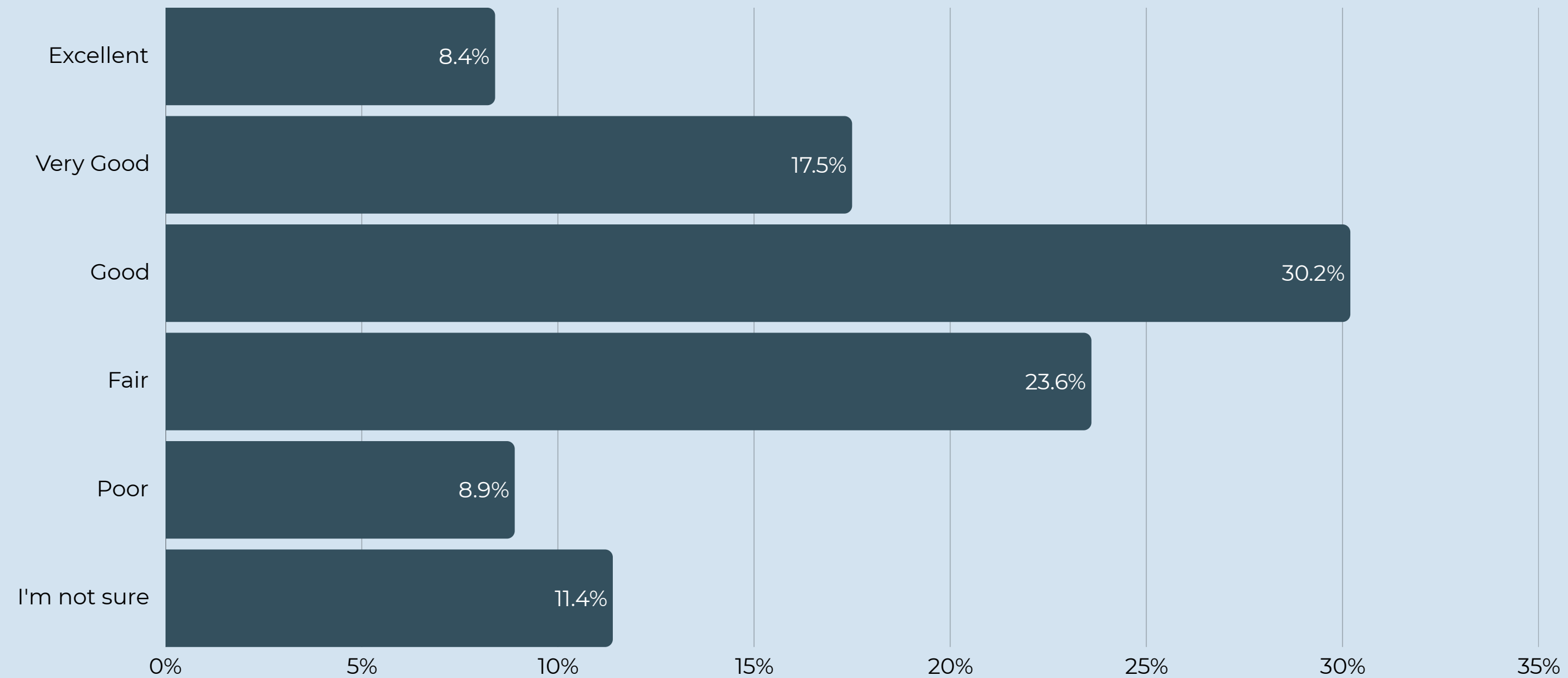

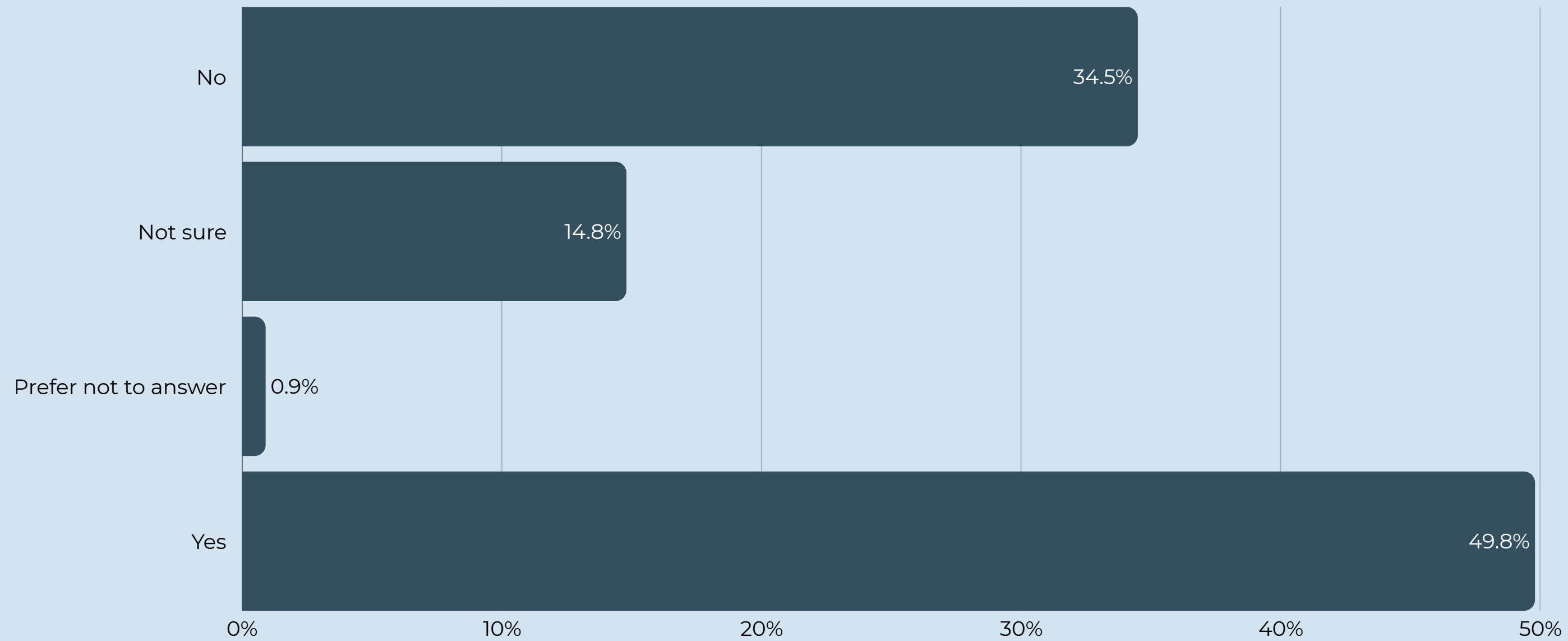

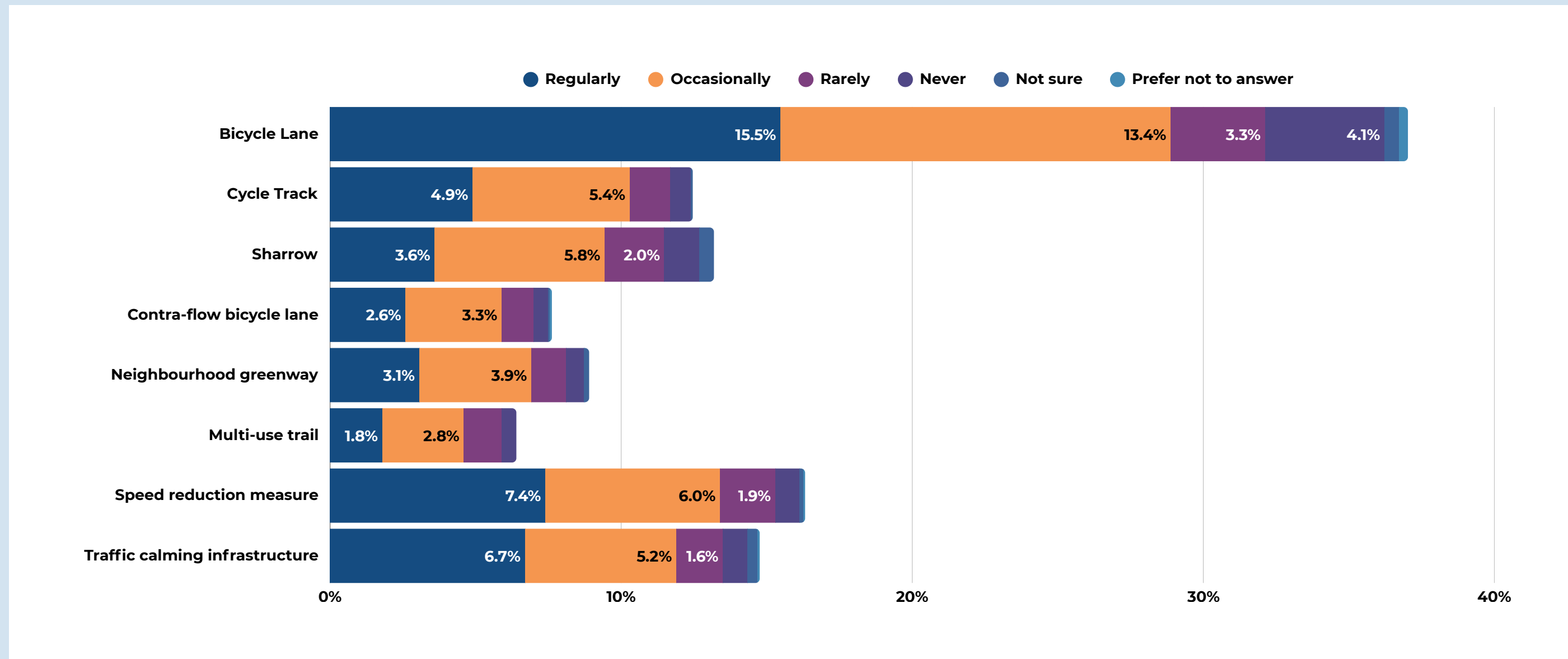

NOTICING RECENT NEW OR MODIFIED STREET INFRASTRUCTURE



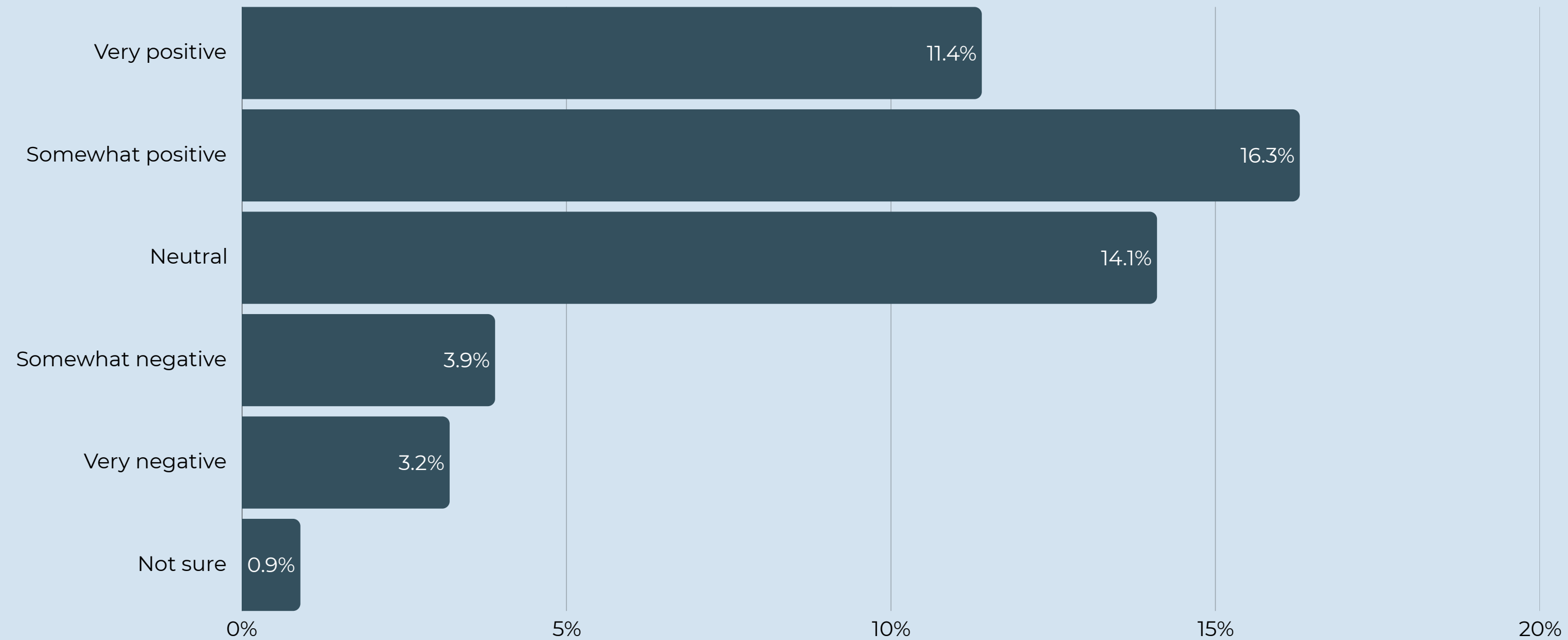

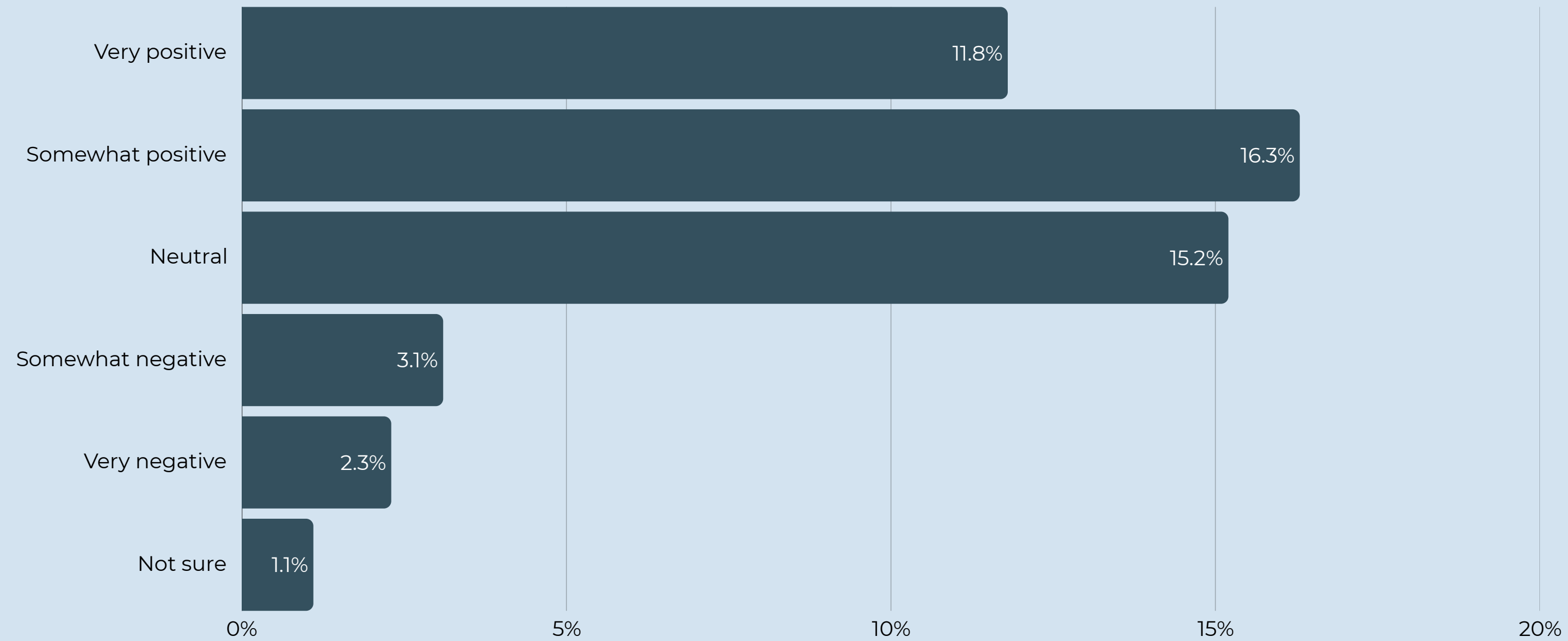

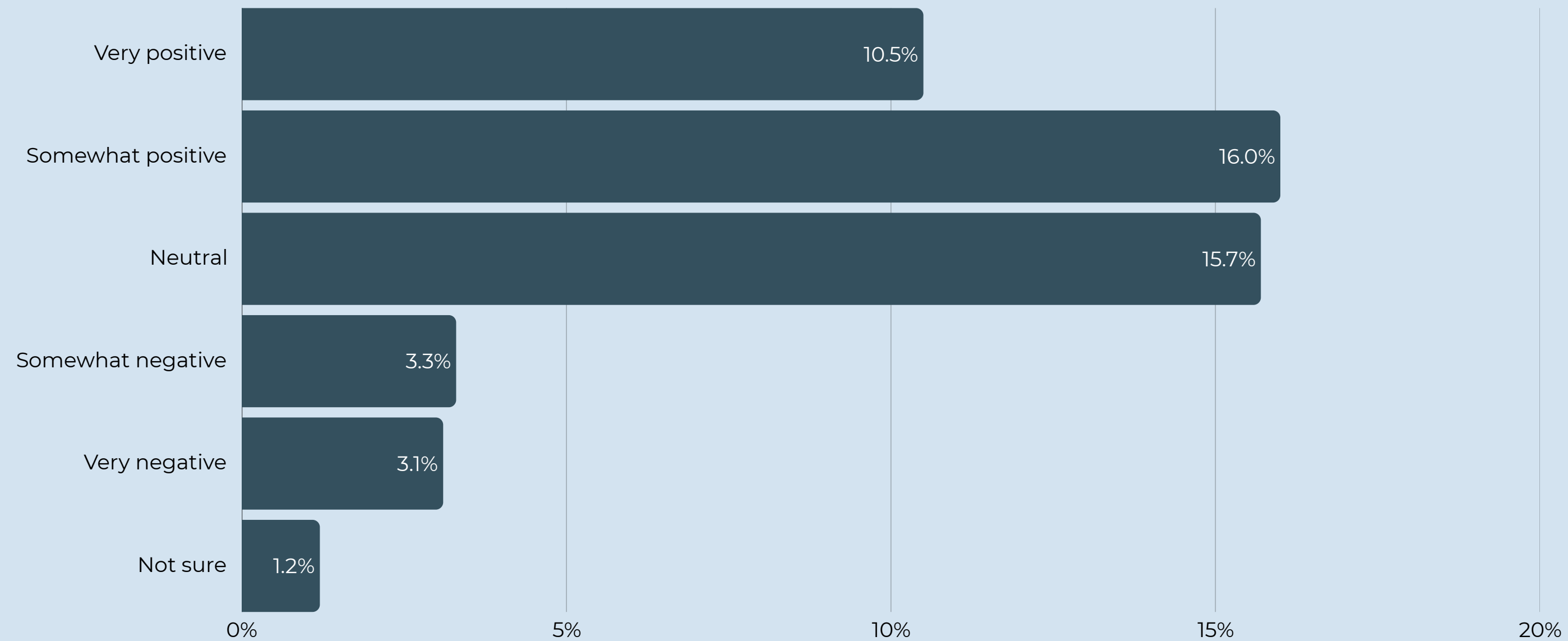

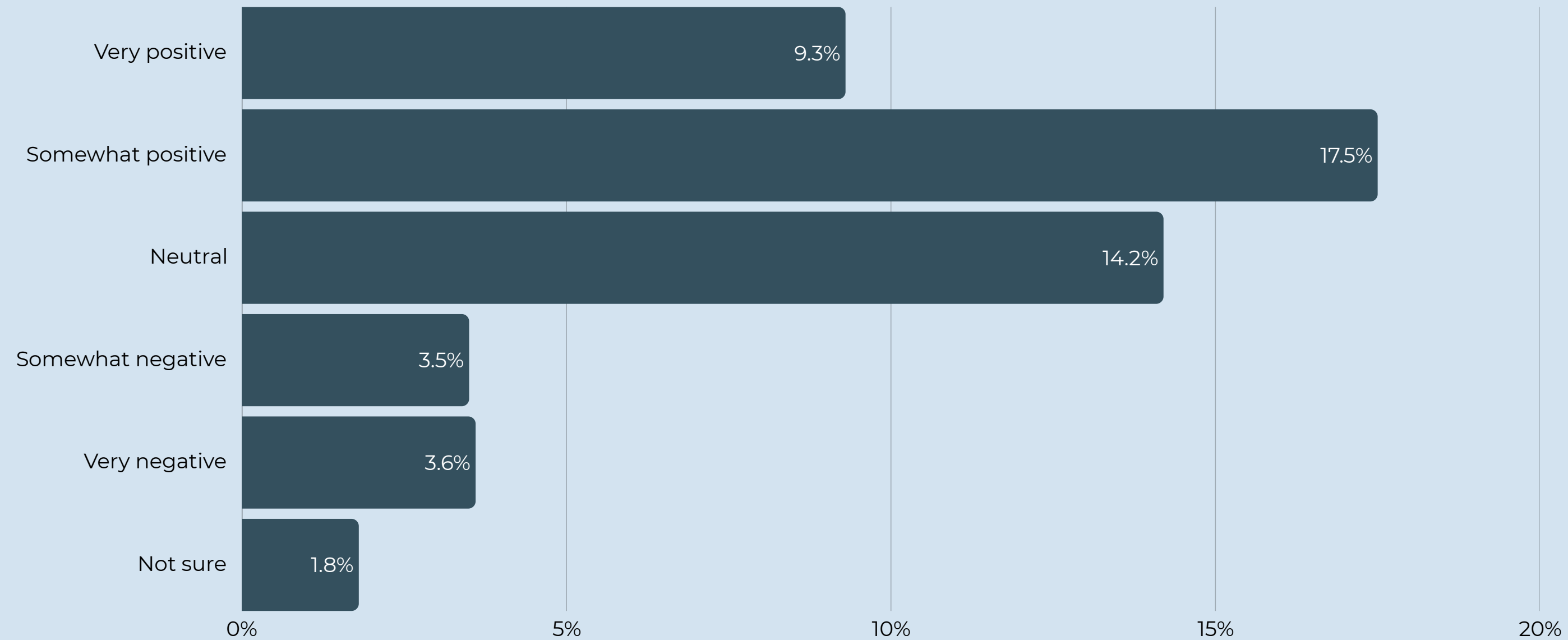

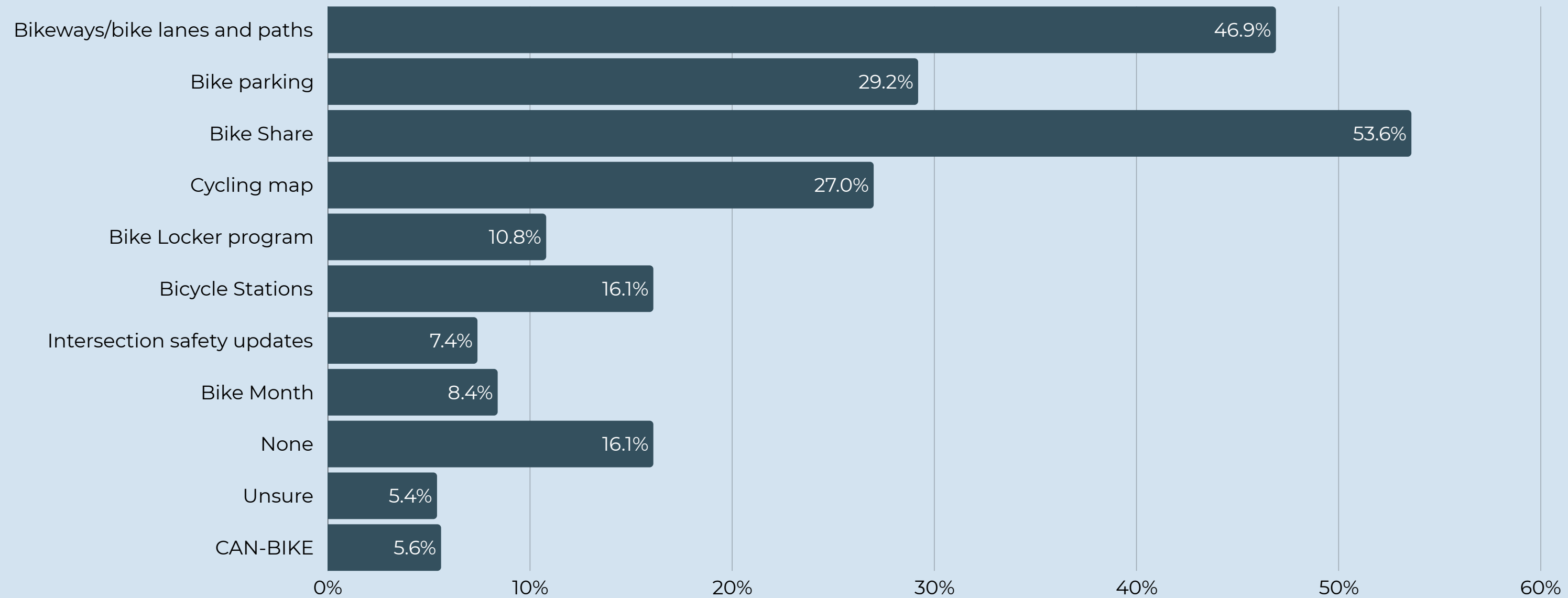

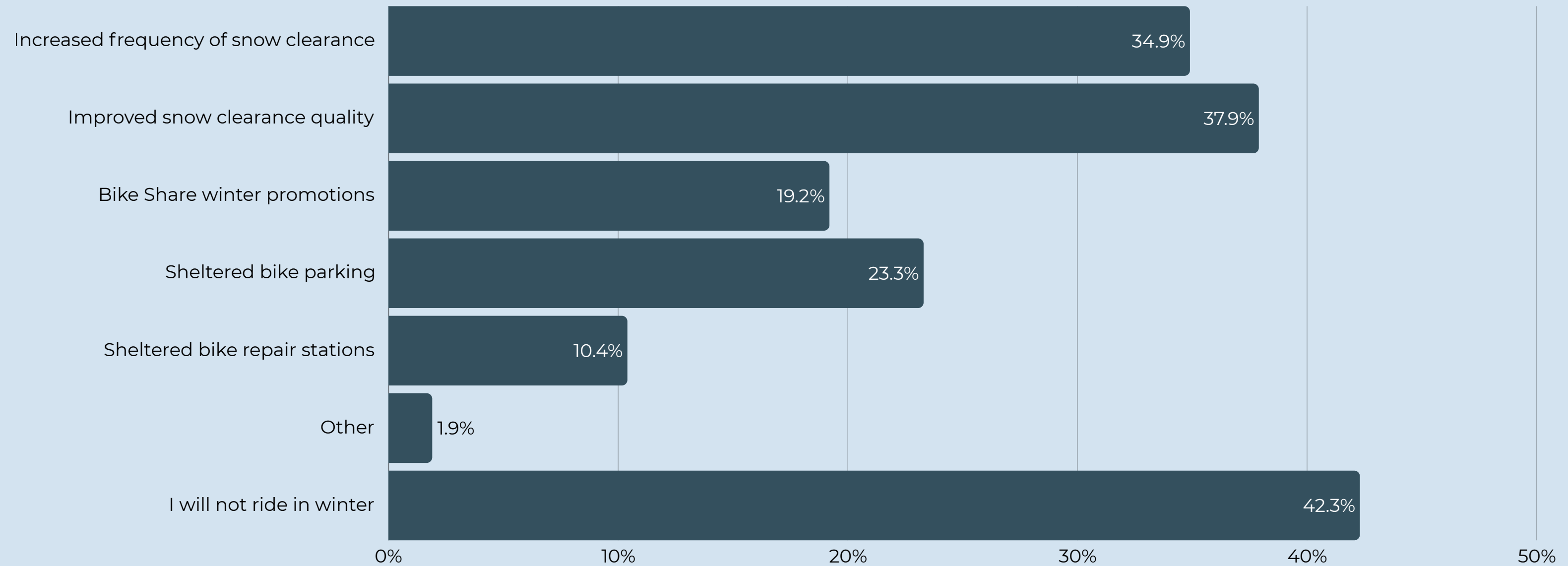
