 - i. the corporation that I represent carries on business in Ontario.
 - ii. the trade union that I represent holds bargaining rights in Ontario.
 - b. The corporation or trade union that I represent, is not ineligible or disqualified under the *Act* or any other legislation to be a registered third party advertiser.
 - c. Third party advertisements made by the corporation or trade union that I represent shall not be under the direction of a candidate whose nomination has been filed under section 33 of the *Act*.
