Overnight Sanitary Sewer Work on Scott Street from The Esplanade to Front Street East

Contract: 24ECS-LU-03TT

Start: Wednesday, May 20, 2026 (7:00 p.m.)

End: Thursday, May 21, 2026 (7:00 a.m.)

Timeline is subject to change.

The City of Toronto is providing an update regarding the ongoing Phase 2 sanitary sewer installation on Scott Street. Major components of the sanitary sewer upgrade and restoration activities have now been substantially completed.


To finalize the remaining restoration work, overnight construction activities have been scheduled to complete final line painting and roadway markings. This work is scheduled to begin on **Wednesday, May 20, 2026, at approximately 7:00 p.m. and is expected to conclude by 7:00 a.m. the following morning.** Crews will work overnight to safely complete these final activities while minimizing disruptions to daytime traffic and local stakeholders.

Please be advised that the project schedule remains subject to change based on weather conditions. The contractor will make every effort to minimize noise and disruptions to nearby residents and businesses.



We sincerely appreciate your continued patience and cooperation throughout these essential infrastructure improvements.

WHAT TO EXPECT DURING CONSTRUCTION

- Heavy equipment will be operated during the weekend construction period, and you may experience dust, noise and other inconveniences. We will be implementing dust-control measures and noise-reduction efforts to keep disruptions to a minimum.
- Crews require temporary lighting for nighttime restoration work.
- Please note that all construction vehicles are equipped with mandatory backup warning/signalling beepers. These devices are required for the safety of construction crews and cannot be disabled.
- The City will not be responsible for damage to any privately-owned items on City property, so please ensure that you remove/arrange for the removal of such items.

	<p>Road and Sidewalk Access: To complete the work in a safe manner, there will be some road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to driveway access. This overnight work will allow the contractor to cross both Scott Street lanes and the underground parking garage in one operation, minimizing impacts to local stakeholders.</p>

	<p>Traffic Management: Traffic on Scott Street has been reduced to one north-bound lane from The Esplanade to Front Street East to accommodate for this project. There is no on-street parking permitted on Scott Street during the construction period. Road users should expect delays and increased traffic on nearby streets. Motorists are reminded that bicycles and cars will be sharing the same traffic lane. When driving, please be mindful of other road users.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Field Ambassador listed below.</p>
