

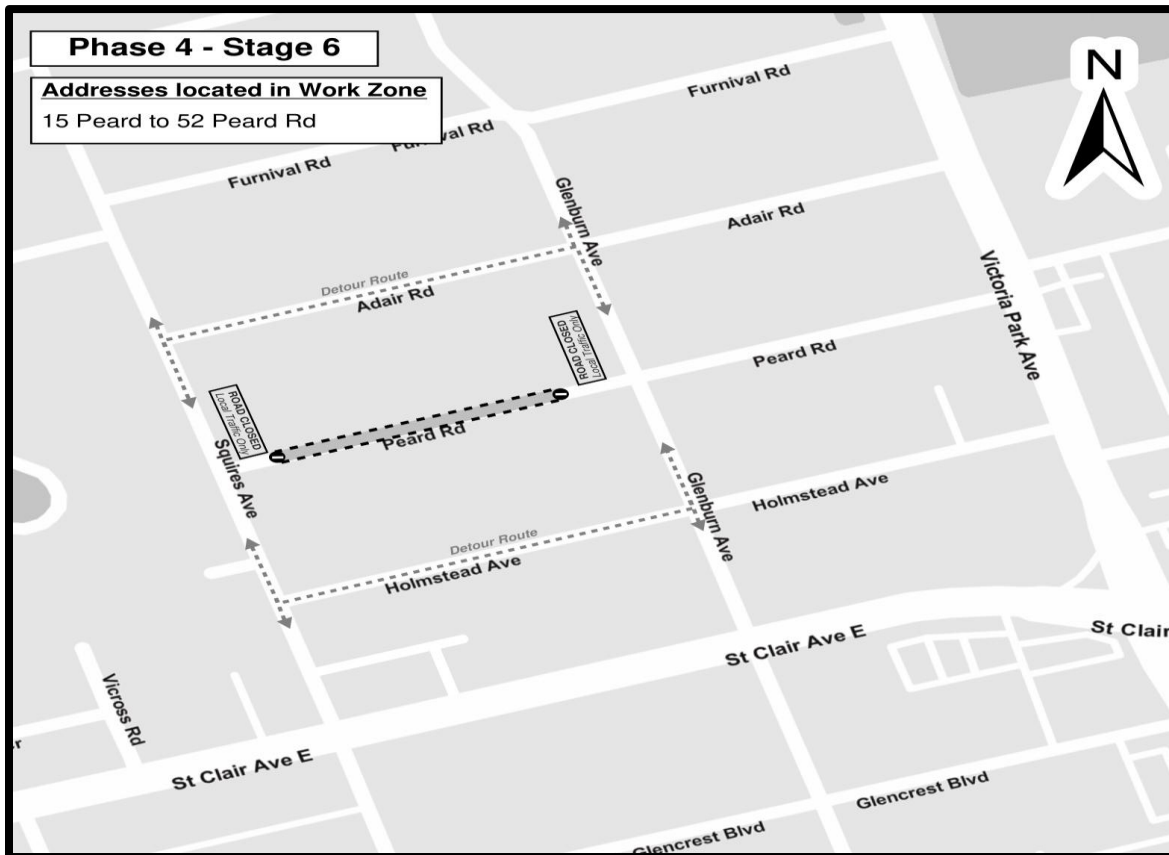

## Storm Sewer Upgrade on Peard Road

**Contract: 23ECS-LU-03FP**  
(Phase 4 Stage 6)  
**Start Date: June 8, 2026**  
**Expected End Date: July 31, 2026**  
\*Content/dates subject to change

The City of Toronto is upgrading the storm sewer system along Peard Road to reduce surface and basement flooding. Due to the depth and nature of the construction work, a portion of Peard Road will be closed. This temporary road closure will be in effect from 7:00 a.m., Monday, June 8, 2026, until 7:00 p.m., Friday, July 31, 2026.

## WORK DETAILS

The contractor will:

- Upgrade the storm sewer system to reduce surface and basement flooding.
- Excavate a portion of Peard Road.
- Addresses located within the work zone include: **15 Peard Road to 52 Peard Road.**
- The work zone area will be closed to all through traffic from 7 a.m. to 7 p.m., Monday through Friday. Local road access and driveway access will be available to residents within the work zone after 7 p.m. during the construction work week.
- During construction, driveways may be impacted for varying periods of time. If a driveway closure is required, the contractor will distribute Driveway Impact Notices only to the affected addresses when necessary.
- When driveway access is affected, please park in a legal spot on a local side street i.e., Adair Avenue, Furnival Road, or Holmstead Avenue and display the Driveway Impact Notice on your windshield.

	<p><b>Traffic Management:</b></p> <ul style="list-style-type: none"> <li>• Westbound traffic to travel north on Glenburn Avenue then take Adair Road to Squires Avenue. Travel south on Squires Avenue. Northbound traffic wishing to travel eastbound on Peard Road to continue north on Squires Avenue, then take Adair Road to Glenburn. Continue south on Glenburn Avenue.</li> <li>• Southbound traffic wishing to travel eastbound on Peard Road to continue south on Squires Avenue, then take Holmstead to Glenburn Avenue. Continue north on Glenburn Ave.</li> </ul>
	<p><b>Pedestrians:</b> Sidewalks will be fully accessible on both sides of the street.</p>
	<p><b>Work Hours:</b> Work will take place from 7 a.m. to 7 p.m., Monday to Friday.</p>
	<p><b>Accessible Accommodation:</b> The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>



**Parking Violation Notices: Please ensure you always park in a legal parking spot.** If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:

1. Pay the parking violation (follow instructions on the back of the notice) **or**
2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.


If you do not have a copy of the Construction Notice, please contact 311 to request a copy.

**Please note:** Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e., in front of a fire hydrant or in No Parking zones).

To reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.
