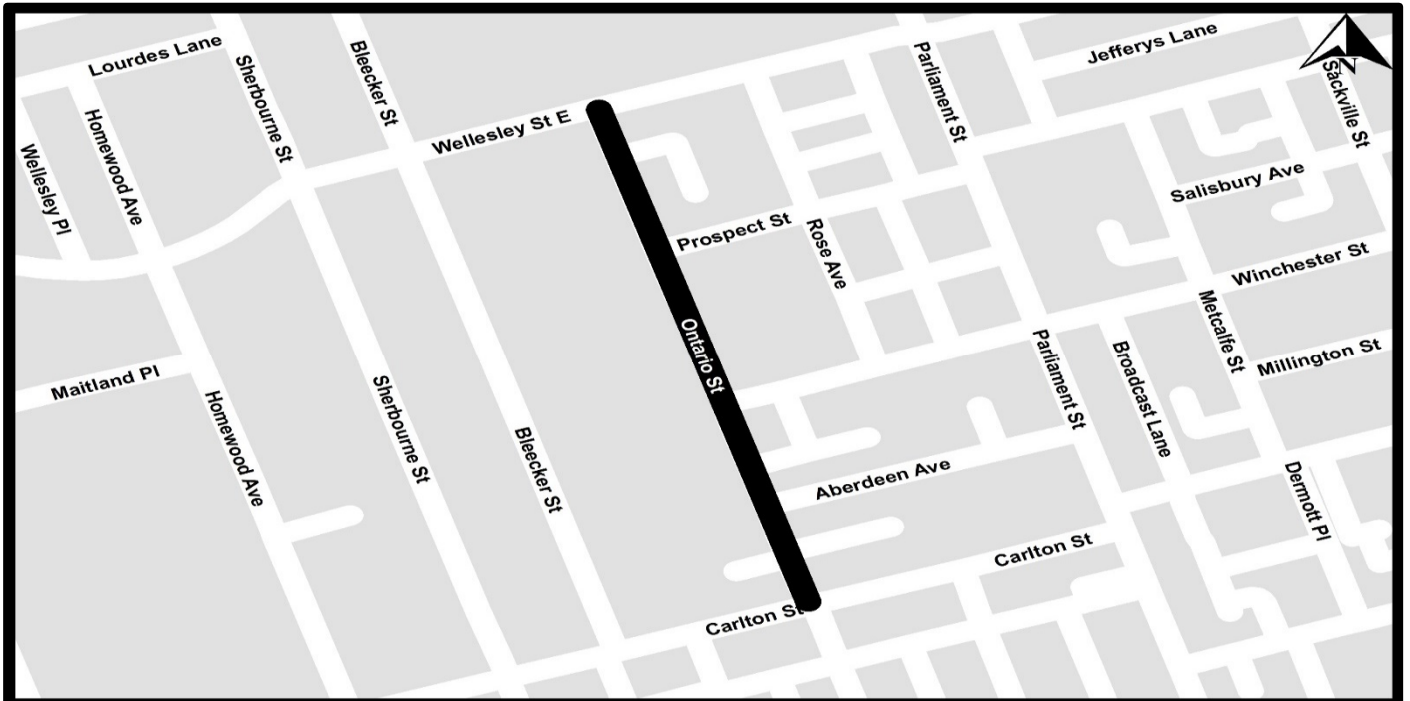

From **Tuesday, June 23, to Tuesday, July 7, 2026**, block-by-block closures will be in place on **Ontario Street between Carlton Street and Wellesley Street**, to accommodate road reconstruction and concrete road base.

Please note that through traffic will be unavailable while this work is underway, we apologize for the inconvenience. Please arrange for alternate parking if you require use of your vehicle. Residents with City parking permits can park anywhere in Area 7A. Emergency vehicle access will always be maintained.

WORK DETAILS






The City's contractor will complete:

- Road reconstruction from the existing condition down to the concrete road base
- Asphalt paving (base and top paving)
- Final surface paving
- Line painting and markings

WHAT TO EXPECT DURING CONSTRUCTION

- The community will experience dust, noise, traffic delays, and other inconveniences
- The City will make efforts to reduce the impacts. We appreciate your patience.

	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.</p>

	<p>Road and Sidewalk Access: To complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Parking: This project will affect on-street parking on Ontario Street between Prospect Street and Wellesley Street, and on Prospect Street between Rose Avenue and Ontario Street in order to convert traffic flow to become bidirectional during work hours. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.</p> <p>Local residents with parking permits are encouraged to park on neighbouring streets within Permit Parking Area 7A (see attached map for reference).</p>
	<p>Parking Violation Notice: <u>Please ensure you park in a legal parking spot at all times.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:</p> <ol style="list-style-type: none"> 1. Pay the parking violation (follow instructions on the back of the notice) or 2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction. <p>If you do not have a copy of the Construction Notice, please contact 311 to request a copy.</p> <p>Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (e.g., in front of a fire hydrant or in No Parking zones).</p> <p>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>
	<p>Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
