ROAD CLOSURE Martin Grove Road Between Donalbert Road and The Keane Gate

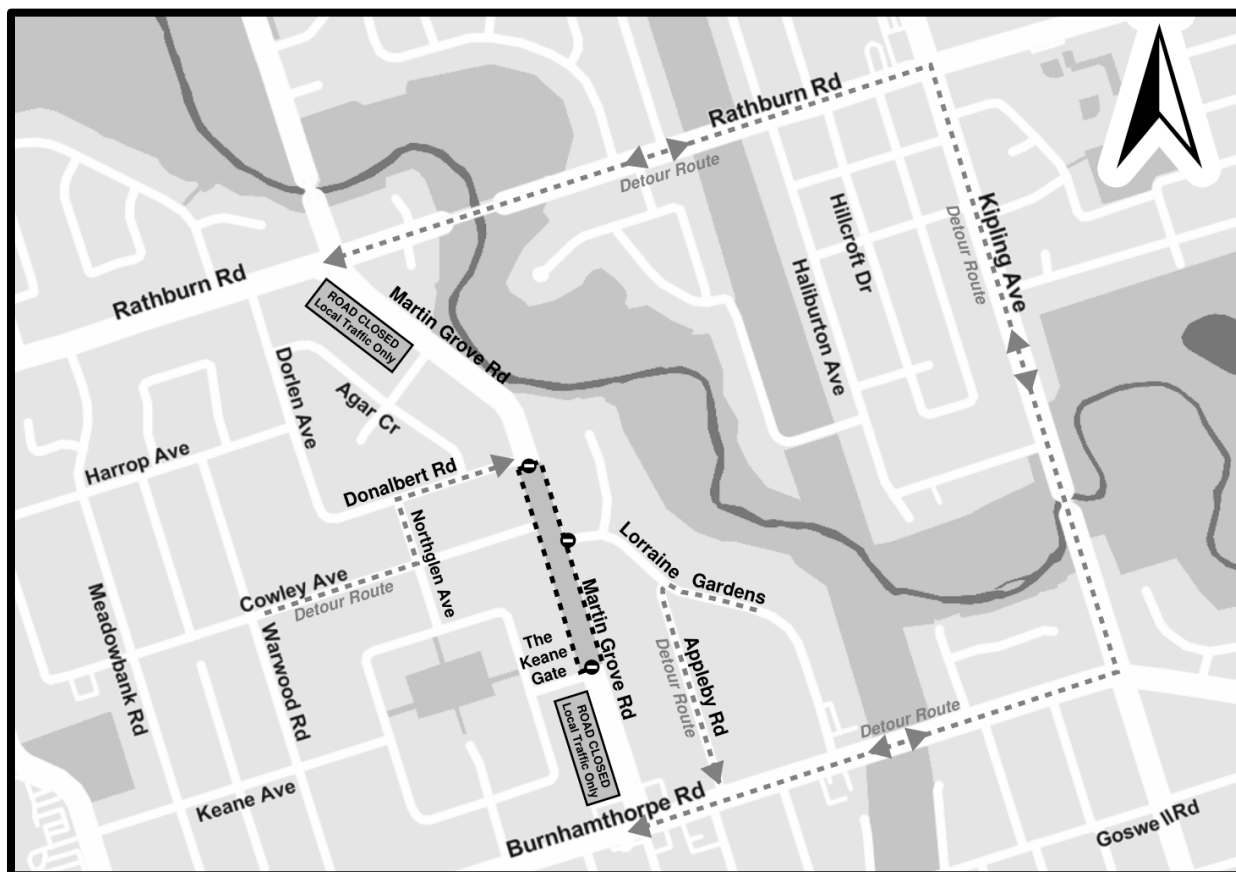

The City of Toronto is modifying and upgrading the storm sewer and related systems in your area to reduce surface and basement flooding. Due to the depth and nature of the construction work, **Martin Grove Road will be closed from Donalbert Road to The Keane Gate from 7 a.m. on Monday, August 24, 2026, to 7 p.m. on Friday, October 30, 2026, for construction purposes.**

WORK DETAILS

The contractor will:

- Excavate the roadway on Martin Grove Road between Donalbert Road and The Keane Gate.
- Remove the existing storm and sanitary sewers and install upgraded systems.
- Work will also include the storm sewer tie-in to the existing sewer network on Martin Grove Road.
- Restore the road and all areas affected by construction.



Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users, and residents.

Traffic Detour:

- The intersections of Martin Grove Road with Cowley Avenue and Lorraine Gardens will be fully closed. Eastbound traffic on Cowley Avenue will be detoured via Northglen Avenue to Donalbert Road, exiting onto Martin Grove Road. Westbound traffic on Lorraine Gardens will be detoured via Appleby Road, exiting onto Burnhamthorpe Road.
- Southbound traffic on Martin Grove Road will be detoured via Rathburn Road to Kipling Avenue, exiting onto Burnhamthorpe Road.
- Northbound traffic on Martin Grove Road will be detoured via Burnhamthorpe Road to Kipling Avenue, exiting onto Rathburn Road.
- Martin Grove Road, north of Donalbert Road and south of The Keane Gate, will remain accessible to local traffic only.
- Access for emergency vehicles will be maintained at all times.
- During the road closure, residents along Martin Grove Road will have access to their driveways except when construction is occurring in front of their property. Driveway Impact Notices will be distributed on an ongoing basis as necessary.
- When driveway access is not available, please park in a legal spot on a local side street and display the Driveway Impact Notice in your windshield.



Cyclists: During construction the cycle track/bike lane will be temporarily closed through the work zone. Cyclists dismount and follow the sidewalk.

	Pedestrians: The sidewalk on both sides will remain open.
	Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday, August 24, 2026, to Friday, October 30, 2026. Work hours may be extended, and weekend work may be required.
	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
	Parking Violation Notices: <u>Please ensure you always park in a legal parking spot.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment: 1. Pay the parking violation (follow instructions on the back of the notice) <u>or</u> 2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction. If you do not have a copy of the Construction Notice, please contact Field Ambassador to request a copy. Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e., in front of a fire hydrant or in No Parking zones). To reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.
