Road Reconstruction on Morningside Avenue from Highway 401 to Pan Am Drive

Contract: 26ECS-RD-04MR
Start Date: August 2026 End Date: December 2026
**Timeline is subject to change.*

The City of Toronto is planning to rehabilitate the road on Morningside Avenue from 200 metres south of the highway 401 eastbound off-ramp to 66 metres south of Pan Am Drive. Our inspection of the road shows that it needs rehabilitation, and the curb and sidewalk need to be replaced to bring them to a state of good repair.

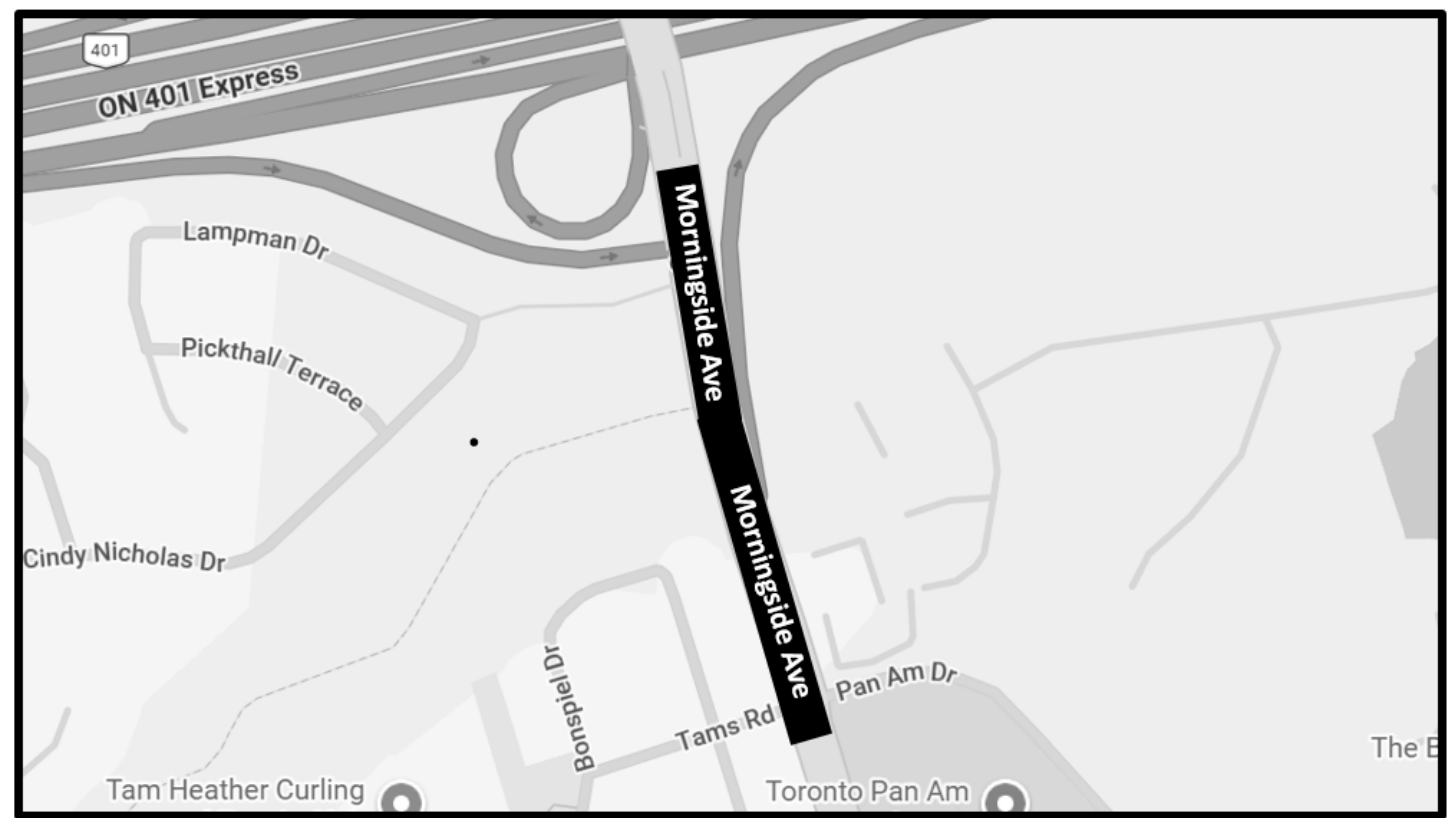
As part of this project, the City will also improve pedestrian and cycling infrastructure. Planned upgrades include a new sidewalk on the east side of Morningside Avenue, a new multi-use trail and raised cycle track on the west side, new cycling traffic signals and crossings, an integrated bike and bus platform, raised medians, streetscape improvements, and intersection enhancements at Tams Road/Pan Am Drive.

In alignment with the Council-approved Vision Zero Road Safety Plan, the following safety improvements will be implemented:

- Adjustments to the existing vehicle travel lane widths, to meet City standards.
- Curb radii reductions throughout the project area, where feasible, to tighten up intersection corners and slow down turning motorists and improve pedestrian and cycling crossing safety.
- Installation of other pedestrian features meeting Ontario's accessibility standards, such as curb ramps and tactile warning strips.
- Upgrades to existing pavement markings.

This project is part of the Council-approved 2026 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

WORK DETAILS

The City’s contractor will:

- Remove the existing road surface.
- Adjust maintenance hole and stormwater catch basins to the new road elevation.
- Repair and replace damage curbs and gutters, where required.
- Construct a new sidewalk on the east side of Morningside Avenue.
- Construct a new multi-use trail and raised cycle track on the west side of Morningside Avenue.
- Install a new granular road base and asphalt base layer.
- Pave the new asphalt road surface.
- Restore driveways, boulevards, and other areas affected by construction.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

	Work Hours: Work will take place from 7 a.m.to 7 p.m., Monday to Friday, with work after hours and on weekends as required.
	Pre-Construction Inspection: CRCE Construction Ltd. under contract to the City of Toronto, will survey all properties within 30 metres of the construction area before construction starts. The inspection will look at the interior and exterior of all properties to verify existing conditions. Although participation is voluntary, the City encourages all homeowners to participate. Without the survey, it will be difficult to confirm any claims of damage caused by construction. Affected properties will receive a separate notice to set up an appointment. All inspection staff will wear photo I.D. and carry photo equipment for this work.
	On-Site Communication: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing. If you need to speak with staff about the construction site, please contact the Project Contact email listed below or ask for the Site Inspector.
	Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage. This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the Project Contact below.
	Telephone and Internet Services: This work may affect phone and internet cables for individual properties that aren't buried deep below the sidewalk. Residents who find their service has been disrupted should contact the Field Ambassador <u>and</u> notify their phone or internet service provider.
	Water Service Disruptions: From time-to-time, the water supply to your property will be shut-off to complete construction; the contractor will provide notice at least 24-hours in advance. Throughout the work, it is recommended that you temporarily disconnect any water treatment systems (i.e. softeners or filters), water-cooled air conditioners or similar plumbing fixtures. Automatic lawn sprinkler systems may also be affected, therefore, you may need to water manually. In the event you did not receive advance notice, the City may have needed to use an emergency water shut off to complete work.

	Substandard Water Service Replacement: Please take the time to read the attached fact sheet carefully as it contains important information on lead in drinking water and how to prepare for replacement. If you want to replace the private portion-of the water service pipe, the City of Toronto recommends that you obtain several quotes before selecting a contractor. Please note: The City is not able to get involved in any contract to have work done on private property. Property owners are responsible for ensuring contractors do not interfere with the work being done on City property. Learn more at www.toronto.ca/leadpipes.
	Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times. Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.
	Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Traffic on Morningside Avenue will be reduced to one lane in each direction.
	Parking: This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.
	Parking Violation Notices: <u>Please ensure you park in a legal parking spot at all times.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date in order to avoid additional fines or records being kept of non-payment: 1. Pay the parking violation (follow instructions on the back of the notice) or 2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction. If you do not have a copy of the Construction Notice, please contact 311 to request a copy. Please note: Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in No Parking zones). In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.
	Garbage and Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. Please ensure that you label your bins with your address.
	Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
